2012: Year of the Cooperative



Last year, the U.S. Senate—building off similar action by the United Nations General Assembly— designated 2012 as International Year of Cooperatives. As a result, cooperatives everywhere are celebrating our unique not-for-profit, member-owned and -controlled business model.

If you read the POWERLINE regularly, then you know Corn Belt Energy is an electric cooperative; you and the 33,000+ households and businesses who receive electric service from us are member-owners, not just customers.

Because you and your fellow members govern how Corn Belt operates, our top priority remains providing safe and reliable service and keeping your electric bills affordable. Local control also means we're in the business of improving the quality of life in the communities we serve, from offering classroom grants to advice on how you can make your home or business more energy efficient.

Started in the 1930's and 40's to bring electricity to rural areas, electric coops are just one type of cooperative operating in America. Dairy cooperatives produce nearly 90% of our nations' milk. Credit unions are cooperatives, too, with more than 8,000 across the country serving 91 million consumers. You can also find housing, hardware, and even funeral

co-ops throughout the U.S. Some agricultural marketing cooperatives have become household names, including Sunkist, Ocean Spray, and Blue Diamond Almonds.

Together, all of us are a key part of our local economy. We provide good jobs to folks who live right here—your neighbors and friends. We deliver goods and services that keep our communities humming. We're happy to lend a hand when we're able, and we enjoy being involved with local schools and community organizations.

COOPERATIVE ENTERPRISES BUILD A BETTER WORLD

At Corn Belt, we return any excess profits, called margins, to you in the form of capital credits. That money then gets reinvested locally—perhaps at a grocery store or other retail outlet, which in turn allows the owners to hire more people. To date, more than \$11 million has been returned to member-owners, including over \$4 million that was returned in 2010.

While not a new concept—
Benjamin Franklin started the first cooperative called the Philadelphia Contributionship for the Insurance of Houses from Loss by Fire in 1752, which still operates today—the cooperative form of business continues as an integral part of our lives each day.

Safety Demonstrations

education GRANTS program

Corn Belt Energy is now accepting applications for our 2012 Education Grants Program. Four schools that serve children of Corn Belt electric members will each be awarded \$1,000 to fund innovative programs that enrich students' education.

Teachers and administrators of public or private K-12 schools may apply; the facility does not need to receive electricity from Corn Belt Energy, but must serve children of our members. Multiple projects within the same school can be combined to a total of \$1,000. Applications and further details can be found online at www.cornbeltenergy.com under "Community."

An impartial panel of judges will review the grant applications and preference will be given to projects and programs that enhance learning and are not currently being funded through the school's budget.

The application deadline is March 31 and the grants will be awarded in late spring.





Youth to Washington Tour

High school sophomores and juniors with a passion for leadership and government are encouraged to apply for an all-expenses-paid trip to Washington D.C. in June!

Washington D.C. from June 15 - 22, with other statewide winners.

The Electric Cooperative Youth Tour has been bringing high school students to Washington D.C. for over 50 years. On the tour, students will learn about electric cooperatives, American history and U.S. government and walk away with a greater understanding of their role as an American citizen. They participate in National Youth Day, visit with their representative and senators, and explore the sights around the nation's capital.
