# Illinois electric cooperatives announce Hom& program

Illinois electric cooperatives, including Corn Belt Energy, have received \$1.5 million in federal American Recovery and Reinvestment Act funds through the Illinois State Energy plan. With this funding, cooperatives plan to administer a residential energy efficiency program called HomE.

The HomE program involves a refundable \$25 home energy evaluation provided by Corn Belt Energy personnel. Based upon this energy evaluation, residential

members are then eligible for a series of rebates for making energy efficiency improvements to their homes. If a member claims a rebate, the \$25 evaluation fee is refunded.

The maximum rebate per household is \$1,500. Rebate funds will be provided to qualifying members who participate in the program and complete the efficiency improvements. Only residential Corn Belt Energy members who have had the energy evaluation

are eligible for these rebates. For existing homes only. These rebates may be combined with other federal and state rebates and incentives.

# Updated Line Extension Policy

Corn Belt has adopted a new line extension/new service policy which went into effect on April 1. You can download the policy details on our website under New Service Guidelines. A summary of changes includes:

#### **Line Extensions**

Cost of any new Corn Belt facilities providing service are the member's responsibility. Corn Belt allows a \$4,400 credit for a residential "standard line extension" when service is not within a subdivision.

#### **Temporary Service Charge: \$150**

Temporary service meter base must be both set and paid before energizing.

#### **Temporary Service: \$800**

Charge is for installing up to a 25 KVA XFMR and service, and eventual removal.

#### Permanent Residential Overhead Service

Corn Belt will provide standard length overhead service, up to \$600, at no cost to the member. Additional charges apply for extra length or capacity.

Meter pole installation: \$460

#### Permanent Residential Underground Service

200 Amp:

NOT in conduit: 50' Free | \$12/ft beyond 50' IN conduit: 120' Free | \$5/ft beyond 120' \* ^

400 Amp: *(members with electric heat)* NOT in conduit:

50' Free | \$75 + \$14/ft beyond 50' IN conduit: 120' Free | \$7/ft beyond 120' \* ^

Underground service can be provided in an overhead area by member paying a \$600 Service Riser fee.

<sup>\*</sup> Member installed conduit must be installed from the meter base to within 5'-10' of designated source and must be inspected by Corn Belt Energy before being back filled.

<sup>^</sup> Difficult terrain areas, narrow lots, zero-lot-lines, and underground in our Northern Region will require member-installed conduit.

## **SUMMER SAFETY TIPS**

#### AVOID POWER LINES

Overhead wires enter houses and buildings at places called service drops. Service drops are not insulated, so never attempt to touch these wires.

Storms or accidents can sometimes cause power lines to fall to the ground. Assume any wire lying on the ground is carrying electricity and stay away from it. If you spot a downed wire, immediately call your local police and Corn Belt Energy; Keep others from getting near the downed wire until help arrives.

#### TREE SAFETY

Tree limbs that grow up near power lines can be unsafe. If you climb such a tree, you could get hurt from electrical shock. Never trim trees near power lines – if you see a tree growing too close to power lines, contact Corn Belt to report it.

#### **HOT TUBS AND POOLS**

Water and electricity never mix! Keep electronics like radios away from pools and hot tubs, and watch

for overhead power lines when cleaning pools, sailing or fishing. Never install pools underneath or near power lines. Never touch an electrical appliance if you are wet; always dry off completely.

#### **OUTDOOR ELECTRONICS**

Be careful when using electrical appliances outdoors. Whether it's a bug zapper, an electric charcoal lighter, or a radio or CD player, use outlets that have weatherproof covers and ground fault circuit interrupters (GFCI) to prevent serious shock injuries. Use portable GFCIs for outdoor outlets that don't have them.

#### KITES AND BALLOONS

Since overhead power lines are not insulated, a kite or balloon string can conduct electricity to the ground. If a kite gets stuck

in a tree that is near power lines, do not climb up to get it. Fly kites and model airplanes in large open areas like a park or a field.
