#### Always call JULIE at 8-1-1 to have underground utilities located before you dig.

To avoid personal injury and damage to underground lines, state law requires you to contact Joint Utility Locating Information for Excavators (JULIE) before any digging project, regardless of the project size or depth. The call is free, and so are the services.

According to state law, the person doing the digging is required to call JULIE with the locate request information at least 48 hours (two working days, excluding weekends and holidays) in advance of the start of excavation. You must begin your project within 14 days from the time you call and if you want to start your project over the weekend, remember to contact JULIE by Wednesday at 4:00 PM.

In order to help the utility locator properly identify your project area, JULIE recommends that you mark the area where you will be digging with white paint and/or flags.

Each JULIE utility member is responsible to mark their own underground facilities with paint or flags within the two working day period required by law (*excluding Saturdays, Sundays and holidays*).

## **CHAPTER 6: A CHANGING MEMBERSHIP**



In the late 1970's, Corn Belt started to serve more city and suburban subdivisions in McLean County as a result of economic growth in the region. CEO Gerry Beer leaves the cooperative in 1979 to work for a national cooperative financial

In order to best serve a growing membership, the co-op made major investments in technology throughout the 70s and 80s.

The improvements in technology didn't come just to the line

operations; enhancements were being made in the office as well. Corn Belt made the transition from billing machines to the computer age in 1976 when it switched its billing operations to Central Area Data Processing. Billing soon switching to a monthly schedule with the assistance of hired meter readers, eliminating self-read metering. But technology wasn't the only thing causing change; the co-op members were changing, too.

As subdivisions around Bloomington-Normal begin to grow into rural areas, Corn Belt starts installing underground conductor. The demands and needs of farmers also grow during this time with grain drying and handling systems, prompting the co-op to invest in three-phase facilities in many areas. The local cooperative becomes a more sophisticated utility in order to manage growth and greater demand.
