# **Help Control Summer Energy Costs**

Do the Summer Shift: 11 a.m. to 7 p.m. Weekdays

You may wonder, "Why does an electric utility want me to reduce my consumption?"

The answer is that Clay Electric is different because we are a cooperative, owned by the members. Our goal is to provide reliable power at the best value for all our members with an eye on the future. Three major factors affect the price of electricity: the price of fuel needed to generate power, the cost to comply with environmental regulations and the demand for power. You have the power to help keep our rates affordable by simply shifting the timing of your power use over the summer.

Consider doing the summer shift by shifting any flexible energy use outside of the time window from 11 a.m. to 7 p.m. weekdays from June through August. These are the peak energy demand hours in our region in the summer. That means they are the hours that most tax our resources that generate our electricity, making it more expensive for them to provide for the higher energy demand.

Any energy use you can move outside of 11 a.m. to 7 p.m. on summer weekdays cuts our total use during peak pricing hours and helps to keep our rates affordable. You can do the summer shift by following these guidelines:

- Run appliances like clothes washers and dryers, dishwashers and other electric devices before 11 a.m. or after 7 p.m.
- Delay using hot water until after 7 p.m. so that your water heater


recharges after the peak times.

- Set the thermostat on your air conditioning equipment or heat pump up three degrees during the peak time. Use ceiling fans and close drapes to help the air conditioner even more.
- Turn off any unneeded lights and electronics (turn electronics off at the surge strip when possible).
- Delay television watching and computer battery charging until after 7 p.m.

We hope you will decide to make a few small changes in energy habits to contribute to savings for yourself and Clay Electric's entire community. Do the summer shift – Together We Save!

# Help college students stay safe

Electrical safety in the dorm



College living can undoubtedly be exciting. For most students attending schools outside of their home town or state, it's their first opportunity to be independent. While college provides new and exciting opportunities, it also introduces myriad safety hazards, especially to students living in dormitories, apartments, and other community locations.

The following tips will help college students and others stay safe this fall:

- Do not overload extension cords, power strips, or outlets. Overloading these can cause overheating and deterioration, resulting in a shock or fire hazard.
- Use adaptors in rooms with old-fashioned, two-prong outlets.
- Buy a power strip with an over-current protector. It will shut off power automatically if too much power

gets drawn.

- If an outlet is hot to the touch, unplug appliances immediately and notify the resident assistant. It could be a potential fire hazard.
- Do not connect multiple extension cords together.
- Extension cords are only for temporary use.
- Do not route extension cords under carpet or doors. Do not staple or puncture through extension cords.
- Look for the UL (Underwriters Laboratories) mark on any electrical product you use.
- Use lightbulbs with the correct wattage for lamps. The wattage specification should be indicated near the bulb socket.
- Always supervise the use of hot plates. They can easily start a fire if left unattended.
