2012 Rates are still a Mystery

As part of our commitment to keeping the membership well informed, I will update you on our potential/probable rate increase for 2012.

Chairman Dickinson started the rate increase dialogue at our March 17, 2011 Annual Meeting. As you know, SIPC (Southern Illinois Power Cooperative) is our wholesale power supplier. Mr. Dickinson discussed three factors concerning SIPC that will drive our need for an increase in electric rates. First, is the commercialization of the newly constructed Prairie States Generating Station located in Lively Grove, Ill. SIPC owns approximately 8 percent of Prairie States, and we are confident Prairie States will provide SIPC reasonably priced and reliable energy for many years to come, proving to be a wise and prudent investment. But, in turn, SIPC will need to raise its rates to Clinton County Electric (and other cooperative members of SIPC) in order to cover costs at Prairie States.

The second factor affecting electric rates actually involves working in favor of lowering rates. SIPC implemented a fuel plan a few

years ago and we are experiencing substantial savings from that plan and SIPC plans to continue to enhance that plan as time goes on with the expectation of future savings.

Environmental Compliance is the third factor – our "900 lb Gorilla." Currently, environmental compliance accounts for about 20 percent of our power bill from SIPC. With the impending EPA regulations and potential Carbon Emission legislation, potential Coal Ash legislation and Clean Air Transport Rules, that number will undoubtedly go up.

SIPC recently contracted with an outside firm to produce a Cost of Service (COS)/ Revenue Requirement Study. This study looks at a period of time and tries to establish the billing determinates that will ensure long-term financial integrity of the cooperative. Early results of that study indicate that SIPC will need to raise rates to Clinton County Electric by around 15 to 20 percent or possibly slightly more. Please note, this is only an estimate and is likely to change over the next few months. Remember, power costs make

Been on vacation? Then why isn't your bill lower?

You were gone two weeks on vacation. And when you got your electric bill you found that it wasn't any lower, or not much anyway, than the month before. Why?

There are many reasons for this and here are just a few:

- 1. Major appliances If you did not adjust your water heater before you left, it would have continued to run to keep your water hot, even with no one home. The same holds true for your refrigerators or freezers. They have to continue to run to keep things cold even when you aren't there. Also, did you turn your air conditioner off?
- 2. Split billing periods the time that you were gone may have been split between two billing periods. So, even if there would be some reduction in electrical usage, it may be split between two billing periods, making the reduction less noticeable.
- 3. Extra electrical use before & after the trip this usage might include

things like extra laundry on your return home or turning down the air conditioner to cool the house back down if you had turned down your thermostat during your time away.

We want you to enjoy your vacation, but remember, the electricity is working for you even while you are away.

up about two-thirds of our total costs.

Here at Clinton County Electric, we are in the process of evaluating all of our non-power cost expenditures to make sure we keep them as low as possible while maintaining reliable service to you, the member-owner.

As members themselves, your Board of Trustees understands today's troubling economy and the effects it is having upon the membership. The board has the responsibility of delicately balancing the financial requirements of the cooperative and the needs of the membership. In keeping with our commitment to communication, we will continually update you

when information is known.

I would expect the rate increase analysis to be completed in mid to late September. This will be the main topic of conversation at our Area Meetings on October 19th and 20th. (Please see important dates section for times and locations of these scheduled meetings on page 16d.)

Three Clinton County Youth attend "Youth to Washington"

At the National Rural Electric Cooperative Association Annual Meeting in Chicago in 1957, Senator Lyndon Baines Johnson addressed the crowd stating, "If one thing goes out of this meeting, it will be sending youngsters to the national capital where they can actually see what the flag stands for and represents." Soon thereafter, Illinois sent a busload of young people to Washington. By 1964, approximately 400 students from 12 states made the trip to DC. The word of the program continued to spread, and today over 1,500 students and their chaperones participate in the Youth Tour every year.

The program is stronger than ever and Clinton County Electric Cooperative was proudly represented by three outstanding youth on this year's "Youth to Washington" Tour held from June 10 – 17. Adam Eggerman, Nicole Hanke, and Sawyer Magnus, all children of CCECI members, loaded a motor coach in Mt. Vernon early Friday morning, June 10, and started what was an eye-opening experience by seeing numerous D.C. area attractions and monuments, learning more about electric cooperatives and creating countless friendships which will last for many years to come.

More than 1,500 youth from all over the United States gathered at the Hyatt Regency Hotel one morning for the Youth Day assembly to hear phenomenal speakers. Former Nebraska State Senator David Landis provided a vibrant historical portrayal of US Senator George W Norris. Senator Norris saw the need for the enactment of the Rural Electrification Administration (REA), which gave rise to the rural electric cooperatives and public power. The students were also privileged to hear Keynote speaker Mike Schlappi, who delivered an inspiring message from his wheelchair. Mr. Schlappi was accidentally

shot at age 14 and doctors told him he would never walk again. Prior to his accident, he was dreaming of a career as a top American athlete. In his message he stated, "Just because you can't stand up, doesn't mean you can't stand out." His message was inspiring for the young and old.

The week in Washington DC was action-packed with 76 students and eight chaperones representing Cooperatives from the entire state of Illinois. They all traveled together to visit such sites as the Capitol Building, Gettysburg, Arlington National Cemetery, the Washington National Cathedral, several Smithsonian Museums, the US Holocaust Museum, the WW II Memorial, memorial to Presidents Lincoln, Jefferson, Washington, and Roosevelt, the Royal Embassy of Saudi Arabia, the Newseum and numerous other historical locations. A highlight of the trip was the opportunity to meet our United States Representatives and Senators. Adam, Nicole and Sawyer were able to personally meet with US Representative John Shimkus along with other


Unites States Representatives and Senators.

The Youth Program allows today's students to experience government first-hand by visiting Capitol Hill and seeing the historical sites in Washington DC. Adam, Nicole and Sawyer, along with all of the Illinois students who attended, did not want this awesome week to end.
