## PRESIDENT'S REPORT by Michael Hastings

## **Stronger together... Farmers Mutual** members approve merger

A little over a year ago, we announced plans to combine with Farmers Mutual Electric Company located in Geneseo. Spreading costs over more meters is one way to manage risk and control expenses. Combined operations can produce efficiencies, while a larger membership justifies the use of new technologies and strengthens our voice on important issues.

In November, members of Farmers Mutual voted overwhelmingly to merge with Jo-Carroll Energy. Eighty-seven percent of the Farmers Mutual members who voted were in favor of the measure. A two-thirds majority was required for passage. Out of the 348 ballots cast, 302 were "yes" votes. Our own bylaws do not require members to vote on a merger with another cooperative.

We are now working on completing the transaction, and will soon welcome the Farmers Mutual members as part of our cooperative family. We all are committed to making the transition as smooth as possible.

The Farmers Mutual office in Geneseo will remain open and all current Farmers Mutual employees will have the same or similar positions as they currently hold. Farmers Mutual, the oldest electric cooperative in the state of Illinois established in January of 1936, currently provides electric service to approximately 1,500 rural residential, agricultural and business members in Henry and Whiteside counties.

Farmers Mutual's board president Tom Zwica said this is a significant milestone in the history of both cooperatives. The result of this merger will offer a level of assurance that quality service will be maintained, additional services provided and stable rates maintained.

Members of both cooperatives will benefit from increased efficiencies, combining the talents and experience of employees from both cooperatives. Jo-Carroll Energy members will benefit from a stake in one of the newest, cleanest and most efficient power plants in the country through Prairie Power, Inc., the current generation and transmission cooperative serving Farmers Mutual Electric. This is important for long-term power supply planning of Jo-Carroll Energy.

Farmers Mutual Electric members will see a significant expansion in the number of services available to them that Jo-Carroll Energy members already enjoy. These include access to wireless broadband Internet service through Sand Prairie Wireless, online bill pay, automated meter reading, budget billing, energy efficiency programs and discounts at local and national businesses through the Co-op Connections® Card.

The new year brings new challenges and opportunities. We'll provide regular updates on the progress of the merger transaction, as we look forward to getting to know our new members. It is our aim to serve all our members reliably and with the same values on which your local cooperative was built. Together we will be stronger. That's the power of cooperation.

# **Director Profile - Marcy Stanger**

A sk Jo-Carroll Energy board director Marcy Stanger about change at the cooperative since she was elected and she responds, "There definitely has been change."

A new CEO and several new board members over the past 10 years bring a different direction and vision to the cooperative, according to Marcy. New services also were made possible by advances in technology to support an increase in members.

Now serving her third term on the board of directors, Marcy was first elected in April 2005 at the time the cooperative was in the middle of purchasing the electric and natural gas assets from Interstate Power and Light Company in Illinois (Alliant Energy).

"Most of the legal work was completed by the time I attended my first board meeting," Marcy said, "but it's never really over until all papers have been signed. Something could still have happened to stop the acquisition. As events happened, we also found ourselves looking for a new CEO."

"A lot of hard work by dedicated people resulted in the 26,000 account cooperative we have today," she added.

It was a huge change requiring new ideas to service not only the increased number of farming, residential and industrial/commercial members, but also the newly acquired natural gas lines. Jo-Carroll Energy since has added Sand Prairie Wireless, a broadband internet service. "It continues to grow and the board is very proud we took on this project," Marcy said.

Most recently, Jo-Carroll Energy is finalizing a merger with Farmers Mutual Electric in Geneseo. Farmers Mutual's 1,200 members benefit by being able to access Jo-Carroll Energy member services and Jo-Carroll Energy will have a stake in Prairie Power, Inc., the current generation and transmission cooperative serving Farmers Mutual. Prairie Power is one of newest, cleanest and most efficient power plants in the country, Marcy noted.

According to Marcy, a decision to



review and update the cooperative's mission statement a few years ago was paramount. It now reads: Jo-Carroll Energy exists to enhance the quality of life for our members. The board members are guided by this statement and an accompanying set of values, according to Stanger.

"Members are very concerned with rates, but they are equally concerned with reliability and service," Marcy commented. "They expect VALUE for what they pay. Employees are the core to delivering reliable service; the board listens to their suggestions and is very concerned about their safety. The board is concerned with fiscal issues, reviewing financial statements monthly relative to setting the annual budget."

"It's a balance," she said. "In the role of a director you have to understand how our members work and play--what are the needs for their families. Then a director must respond by taking a leadership role to enhance their quality of life. The director needs to be forward in letting members know what we are doing and why we are doing it to support the goal."

To Marcy, that ushers in the last of the values of "Community and Economic Growth, Environmental

# **Neighbor to Neighbor Care Fund can help**

If you need assistance paying your energy bill this winter, help may be available through Jo-Carroll Energy's Neighbor to Neighbor Care Funds.

This program works in tandem with the Low Income Home Energy

Assistance Program (LIHEAP).

If funds are available, you may receive a grant from the Neighbor to Neighbor Care funds. To find out if you qualify, contact your respective agency to start the application process: Jo Daviess County— Northwestern Illinois Community Action Agency (NICAA), 815-232-3141 or 800-883-1111.

Carroll and Whiteside counties— Tri-County Opportunities Council, 815-625-1172 or 800-323-5434.

## Low income energy assistance available

Two agencies have funding available through the Low Income Home Energy Assistance Program (LIHEAP) to assist lowincome residents with their winter heating costs.

LIHEAP is a state and federally funded energy assistance program for low-income families in which heating bill payments are made on behalf of households.

Northwestern Illinois

Community Action Agency (NICAA) has funding available for the residents of Jo Daviess County while the Tri-County Opportunities Council can assist residents of Carroll and Whiteside counties.

Clients are served on a firstcome, first-served basis until funding is exhausted.

A single-person household can qualify with a monthly income of up to \$1,396; a two-person household up to \$1,891; a three-person household up to \$2,386; and a fourperson household up to \$2,881. Income requirements increase by \$495 for each additional person.

Benefits are paid directly to utilities on behalf of eligible households. The exception is households whose heating costs are included in their rent.

# Why does my energy bill go up in the winter?

During the winter months we often receive calls from members concerned about their bills because they are higher than usual.

Several factors can lead to higher energy bills during the winter. Furnaces and heaters are running; we are all inside more; TVs, computers and the lights are on longer. Following are some of the things that can contribute to more energy use:

- Shorter days and longer nights mean lights stay on longer.
- Heating systems and space heaters are in use. Most heating

systems use electricity for some function and many run almost continuously.

- Extra hot water may be used on cold days.
- Electronics such as TVs, DVD players, game consoles and computers are often used more in the winter.
- Clothes dryers are used more often.
- Guests in the home for the recent holiday festivities.
- School-age children and college students are home for winter breaks.

## **Resolving to save money this year?** *Start with energy efficiency*

Was saving money one of your New Year's Resolutions? The average family spends \$2,024 a year on energy—with almost half going to heating and cooling costs. Stay warm and save energy with these helpful winter tips:

• Pick smarter light bulbs.

Lighting is one of the easiest ways to increase your home's efficiency. Switch to compact fluorescent light bulbs or light emitting diode light bulbs. Both types use significantly less energy than traditional light bulbs. CFLs and LEDs last longer, too, so you won't have to replace bulbs as often.

- Install a programmable thermostat. Is your home alone most of the day? Programmable thermostats can knock up to 10 percent off heating bills with the ability to automatically turn temperatures down 10 to 15 degrees for 8 hours a day.
- **Insulate water heaters and pipes.** Wrap water pipes connected to the water heater with foam, and insulate the water heater, too. Give your water heater a break

by setting its temperature to 120 degrees. To save about \$75 annually, consider lowering the water heater temperature from 130 degrees to 120.

- Bundle up your home. The more heat that escapes from cracks, the more cold air enters, causing your system to work harder and use more energy. Use an incense stick to spot air leaks. When it's windy outside, hold a lit incense stick near your windows, doors, and electrical outlets. If the smoke blows sideways, you've got a leak that should be plugged with weather-stripping, caulk, or expandable foam.
- Use a low-flow showerhead. About 14 percent of your energy bill funds water heating. Lowflow showerheads can minimize water use by up to 50 percent.
- Let Energy Star help you cut costs. Energy Star products use at least 20 percent less energy than other products. If you are not replacing electronics, you can save money by unplugging electronics that are not in use.

• Two degrees can make a big difference on your electric bill. Setting your thermostat 2 degrees Fahrenheit higher in summer and lower in the winter results in major energy savings.

# **Co-op energy efficiency rebate success generates repeat**

HomE Lite energy efficiency incentives are available for limited time

In 2011 the electric cooperatives of Illinois received funds for the HomE Program to help cooperative members become more energy efficient.

Collectively, Illinois electric cooperatives received \$2.5 million from the American Recovery and Reinvestment Act program through the Illinois Department of Commerce and Economic Opportunity's State Energy Plan. Those funds were distributed to co-op member-owners for energy efficiency projects. This investment paid real dividends and helped prime the pump for nearly 10 times that in energy efficiency investments. Better yet, the energy efficiency improvements will multiply the savings for many, many years.

The HomE energy efficiency rebate program was so successful in creating new jobs for heating and air conditioning contractors, plumbers and insulation installers plus saving energy for co-op memberowners that it is being repeated for a second but very limited time.

If you didn't get a chance to participate in the first round of HomE rebates now you have a second chance. HomeE Lite rebates are available until funding runs out, or until June of this year.

### HomE Lite incentives Include:

- Energy Audit by BPI certified auditor - \$300
- Geothermal system \$1,500
- Air-Source Heat Pump (16 SEER or higher) - \$1,000
- Insulation and Weatherization
   50 percent of total project

- cost, up to \$1,000
- Heat Pump Water Heater
  \$250
- Commercial installations -\$500 per ton of capacity, up to a maximum of \$10,000 for geothermal and air source heat pumps.

Thru the help of the first round of HomE funding, 423 Jo-Carroll Energy members requested assessments with 416 assessments resulting in incentives. Jo-Carroll Energy members installed 17 geothermal heat pumps, 13 air-source heat pumps, 275 furnaces, 87 central air conditioners and 94 members made insulation and weatherization improvements. Jo-Carroll Energy issued \$164,946 in incentives and members spent more than \$1,688,774 on energy efficiency projects.

Energy advisor John Scott says, "We know a lot of members were unable to participate in the first HomE program for a variety of reasons. Any member who doesn't already qualify for low-income weatherization programs is eligible."

And, he emphasized that by taking part in the HomE Lite program, a Jo-Carroll Energy member could get a home energy audit—a \$300 value—for free.

"When taking advantage of the audit, you can learn a significant amount of information about your home's energy consumption," he continued. "You are provided with a list of priorities that can help lower energy costs and the audit could be free. When you participate in this



program and complete a recommendation that comes from the audit, such as insulation and air sealing, upgrade HVAC efficiency, replace your water heater with a heat pump water heater or install geo-thermal or air-source heat pumps, you can get the \$300 rebate for the energy audit"

Don't forget there are federal income tax credits for some of these projects.

## **Preparing for power outages from winter storms**

Winter can be a beautiful time of the year with white snow and sparkling ice, but that same winter weather can also wreak havoc on communities. It can cause treacherous roads, schools to close, and sometimes power outages. Making plans now can make riding out a power outage safer and more comfortable.

A good way to help keep your family safe and comfortable during a winter storm is to put an emergency kit together.

- Water stock up on bottled water for consumption
- Food have at least enough for 3 to 7 days that includes nonperishable packaged or canned foods, juices, foods for infants or the elderly, and snack foods
- Utensils include a non-electric can opener, cooking tools, paper plates, and plastic utensils
- Blankets, pillows, and warm clothing items
- First aid kit, medicine, and prescription drugs
- Toiletries, hygiene items, moist towelettes
- Flashlight and batteries be sure to include extra batteries

Cash and credit cards

- Important documents
- Tools keep a set in your kit; can include duct tape, screw drivers, pliers, wrench, work gloves, safety goggles, etc.
- Toys, books, and games
- Pet-care items
- Supplies for any alternate heating methods your home may have, such as a fireplace or wood-burning stove

# Jo-Carroll Energy introduces new Member Service Portal

Jo-Carroll Energy is pleased to introduce its new Member Service Portal designed to give members more access and control with their accounts. Launched in December, the Jo-Carroll Energy Member Services Portal has many advantages for members, according to Jennifer Skein, vice president of member services.

You can access the portal by clicking on the "My Bill" button on the cooperative's website at www.jocarroll.com or the "Pay My Bill" link on the Account Management tab.

The new portal offers convenience to members who want to modify their account information, sign up for alerts and reminders or set up eBill—as well as paying their bill online.

## Just a few of the features include:

- Account reminders Never forget to pay your bill again by signing up for the reminder service. An alert will be sent to you via email or text massage to tell you a payment is due. You can schedule your payment reminder to notify you days ahead of your due date. And, if you happen to miss the due date, a past due reminder can be sent.
- Account notifications –If you're concerned about someone changing your Jo-Carroll Energy account information without your knowledge or want to know your bill has been paid, you can set up alerts. With the alert service, we can notify you via email or text message when your payment has been



received and processed or when a change (address, phone number, contact name, etc.) has been made to your account.

 Budget or levelized billing – If you're looking for a way to avoid fluctuations in your bill caused by winter and summer or other use changes, consider levelized or budget bill. You can now sign up for budget or levelized billing on the portal.

• **eBill**—Want to eliminate paper bills? Now you can sign up for eBill service right from the member services portal.
