PRESIDENT'S REPORT

Rate discussion

I've had a few questions lately about electric rates and thought I'd spend a few minutes discussing the issue. We've just received word that Commonwealth Edison has raised its rates 17% and will be going in for another rate increase early this year (2014).

Jo-Carroll Energy's situation is certainly different than Commonwealth Edison's. While we don't have to go to the Illinois Commerce Commission for a rate increase, our member-elected directors who do set the rates are loathe to increase them!

Due to existing power contracts, Jo-Carroll Energy can't immediately drop one of its power suppliers and choose another supplier for some short-term savings. This also provides rate stability – short-term savings can turn into long-term rate increases!

Having said that, we don't expect any big increases in rates for 2014. The power cost adjustment (PCA) will continue on our bills as we have had some upward price pressure from Interstate Power and Light, our major electric power supplier. This has been offset to a small degree by a modest rate decrease at Dairyland Power Cooperative, another one of Jo-Carroll Energy's electric power suppliers.

No one likes increases in electric rates. That is a major reason why we emphasize conservation and energy efficiency efforts so much – so you can spend less for energy and stretch your energy dollar further.

We recently replaced two appliances at our house, a washer and a dryer. We had used these appliances for many years. The energy savings with the new washer and dryer was dramatic and immediate. The energy savings will pay for the appliances over a fairly short time.

Another member I visited with this week reported that he had replaced all of his indoor lighting with LED lights and also saw immediate energy savings.

As members of a cooperative, we all have a job to do when it comes to efficiency. With the helpful tools and resources from your cooperative, using energy wisely is easier than you think – especially when we work together. After all, using energy responsibly and saving money go hand in hand. The more we work together, the more we save. That's the power of co-op membership.

Still time to file nomination petitions

Jo-Carroll Energy members interested in running for one of three seats up for election on the cooperative's board of directors have until Feb. 4 to file petitions for nomination.

Board directors whose terms are up for election include: Marcia Stanger, District 3, of Apple River; Thomas Lundy, District 6, of Savanna; and Larry Carroll, District 9, of Thomson.

Any Jo-Carroll Energy member residing in the district of a director whose term is expiring, including the incumbent director, may file for nomination. Petition forms can be obtained from Jo-Carroll Energy's offices in Elizabeth or Savanna or online at www.jocarroll.com. Candidates must obtain at least 25 signatures of cooperative members from the same district in which they live.

Completed petitions must be submitted to the cooperative by Feb. 4. In order to qualify to have their names placed on the ballot, all nominees must participate in an orientation process provided by the cooperative's attorney to assure that all nominees fully understand the expectations and responsibilities of directors including time demands, education expectations and fiduciary responsibilities.

All eligible candidates will be announced in the 2014 Annual Meeting book (expected to mail in March) and the April 2014 Hi-Lines.

One member, one vote

If more than one candidate files for election in a district, ballots will be mailed to each member resid-

ing in that district from which the director is to be elected.

Members may vote for one director for the district in which they reside or in which the member is entitled to vote. If a member prefers to vote in person instead of using the mail ballot, he or she may cast their vote at the cooperative office.

All balloting concludes on April 4, the day prior to the annual meeting. The ballots are counted by the Credentials and Election Committee. Results of the election are reported at the 75th Annual Meeting on April 5 at the Chadwick/Milledgeville school in Chadwick.

If only one candidate files in a district, election for that district is by acclamation at the annual meeting and ballots are not mailed.

Forum for cooperative board chairs held at the AIEC

Cooperative leaders from various Illinois electric, telephone and agricultural cooperatives attended the Cooperative Board Chairmen's Roundtable sponsored by the Mid America Cooperative Council, Inc., Indianapolis, and the Association of Illinois Electric Cooperatives, in Springfield on Dec. 12 and 13.

The roundtable included sessions and guidance from Dr. Greg McKee, chairman of the Quentin Burdick Center for Cooperatives at North Dakota State University in Fargo, N.D., Dr. Megan Gerhardt, associate professor of management in the Farmer School of Business at Miami University, Oxford, Ohio, Duane Noland, president/CEO of the Association of Illinois Electric Cooperatives, and Dan Kelley, owner of Kelley Farms, and chairman of GROWMARK, Inc.



The speakers provided tools to help board chairs guide their boards and cooperatives' management to make decisions that best serve their members' needs, while navigating through a variety of business risks and governance challenges.

2014 energy efficiency incentives are here!

Being energy efficient puts dollars in your pocket by lowering your energy bill and it also qualifies you for additional dollars through our incentive program.

Our 2014 Energy Efficiency incentives offer savings for both our electric and natural gas members. Eligible electric members can qualify for rebates on: electric clothes washers, dehumidifiers, refrigerators, room air conditioners, freezer recycling, refrigerator recycling, window air conditioner recycling and LED light fixtures. Rebates are also available to our electric members for geothermal heat pumps, air source heat pumps and minisplit and central air conditioning and ductless minisplit. Natural gas members can apply for rebates on furnaces or boilers as well as HVAC, natural gas water heaters, stoves and dryers. Additional natural gas incentives are available for fuel switching.

To qualify for one of our incentives in 2014:

- Purchase and install a qualified energy efficient product in 2014.
- Submit required documentation as soon as possible as funds are limited. Incentives are in place through Dec. 31, 2014 or until funds are depleted.
- Submit all documentation no later than six months after purchase or installation and no later than Jan. 2, 2015. (Those who receive our Pilot Light natural gas newsletter should note the updated deadlines.)

Ugly Fridge contest winners will save with newer model

Doss Shultis and girlfriend Christina Myers of Woodbine entered their Ugly Fridge in Jo-Carroll Energy's first ever Ugly Fridge Contest the day before the deadline.

While paying their bill at the Elizabeth office, the couple noticed the old fridge on the cooperative's lawn. Myers picked up a flyer, and realized they only had a few days left to enter the contest. They returned home, got creative and submitted their entry just in time.

Shultis has been a member for five years, but the refrigerator in the home was much older. Judging by the numerous racing stickers and grease stains, this refrigerator had seen better days.

"[Christina] hated my refrigerator," Shultis explained, "so we entered the contest."

"It was Doss's idea that I be in the photo," Christina added. She had faith that this fridge was the ugliest, "I kept telling him we were going to win."

The battle was close until the last few days of member voting when Shultis' refrigerator took a soaring lead, and, in the end, won with 279 votes and 59 percent of the total votes cast. In second place were Richard and Nora Taets of Geneseo, whose entry received 107 votes.

Shultis used a message on Facebook to spread the word of the contest and request votes. They also used a more traditional method: "We called everyone."

As winners of Jo-Carroll Energy's Ugly Fridge Contest, Shultis and Myers were able to purchase a new, stainless steel 18.3 cubic foot top freezer/refrigerator, Energy Star® Frigidaire. It has a simple design, and fits in their space. Most importantly, it is more efficient.

Before they recycled their old refrigerator (a 2004 18.87 cubic foot

top freezer Kenmore), the couple tested its energy consumption using a Kill-A-Watt meter. Based on the readings, they will see an estimated 26.8 percent reduction in energy consumption.

The top six entries in Jo-Carroll Energy's Ugly Fridge Contest received a certificate for a free home energy audit, a value of \$300, from The Energy Detective, a service of Jo-Carroll Energy.

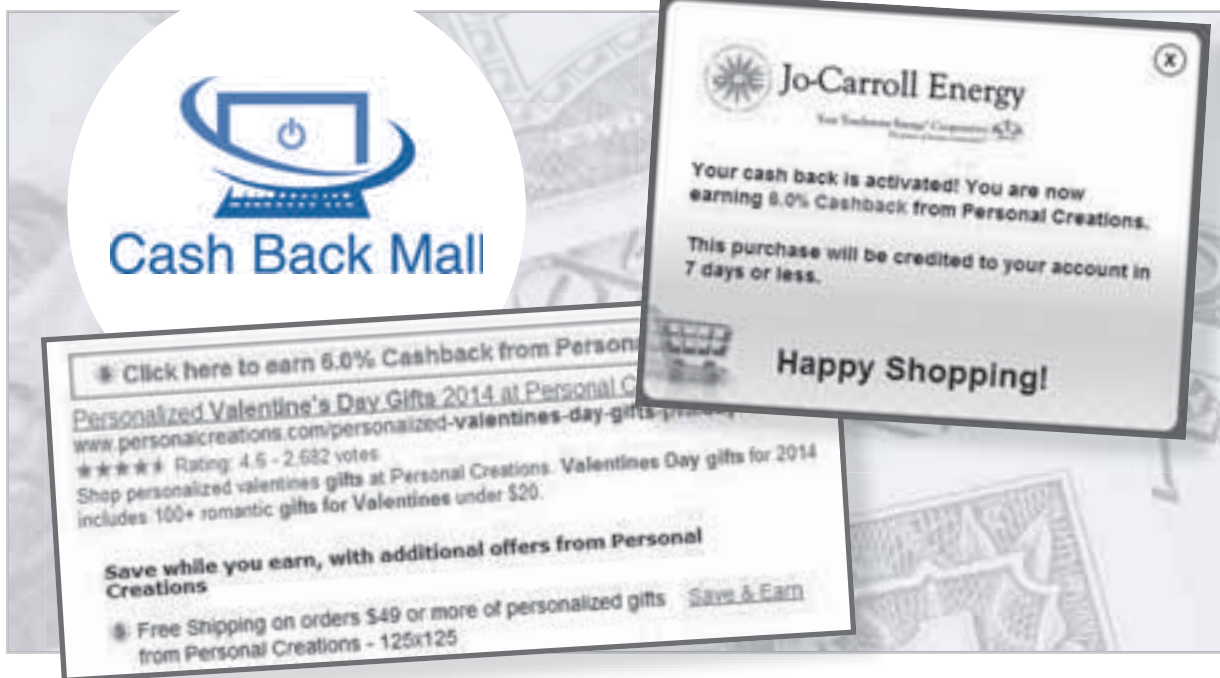

New Bulb on the Block: Meet LED Lucy

There's a new lighting mascot in town. CFL Charlie, a cartoon mascot for Touchstone Energy Cooperatives®, the brand "ID" of the nation's not-for-profit, consumer-owned electric cooperatives, helps families become "Super Savers" by switching to energy efficient lightbulbs. In 2013 he was joined by LED Lucy, a dazzling, spunky mascot lighting the way for even brighter bulb savings.

Lighting standards started shifting away from traditional lightbulbs in 2012. CFL Charlie and LED Lucy want to make sure Jo-Carroll Energy members know about all lighting options.

"I'm older than I look," LED Lucy confides. The mascot's light-emitting diodes beam. "The first LED was created in 1927. Since then we've added stylish colors, and costs dropped. I love bargains, and LED prices get lower every year!"

The mascots share a few pointers on their energy efficiency namesakes.

Compact Fluorescent Lamps (CFLs)

CFL Charlie—and other bulbs like him—are the most common and economical efficient lightbulbs on the market. The swirly style is linked to the concept of efficient lighting, but some consumers haven't warmed to the design.

"Not everyone likes to see my swirls," explains Charlie. "That's fine by me—everyone has a different sense of style. Several of my friends are designed to look just like a traditional lightbulb."

CFLs offer 75 percent energy savings over traditional incandescent bulbs and pay for themselves in 9 months, according to the U.S. Department of Energy.

Light emitting diodes (LEDs)

Light emitting diodes (LEDs) have been used for years in cell phones and other electronics. Most diodes are small—about half the size of a pencil eraser. By banding several small diodes together, a bright and dependable light emerges. As their popularity grows, some companies are making light with a single, bright LED chip. New ways to build LEDs will help drive down costs.

"It's going to be fun to watch LED Lucy gain fans," laughs Charlie. "She uses a little less energy

than me, and lasts 25 times longer than traditional incandescent bulbs."

Since lighting adds up to 10 percent of a home's electric bill, every bulb counts. To help children learn more about lighting, visit www.kid-energyzone.com.
