Board of Directors voting process

Democratic Member Control – It is the second of seven principles that guide cooperatives. If you haven't already, you should be receiving the 2010 Jo-Carroll Energy Annual Meeting book and, if you live in a district with a director election, ballots for the Jo-Carroll Energy board of director's election. Districts with elections this year include Districts 1, 2 and 4.

The annual meeting book contains important information about your cooperative, as well as profiles of the candidates for election in the 2010 director elections. Ballots are mailed separately.

Cooperative members have equal voting rights — one member, one vote. By returning your ballot you are participating in the democratic process; each vote counts, so please remember to return your ballot. Only members in those districts with a director up for election will receive ballots and may vote for the director from their district. Strict anonymity is enforced when tallying the ballots. By signing the return envelope, your ballot is in no way associated with your account.

When completing your ballot remember the following: The ballot must be filled out by the person under whom the membership is listed.

The return envelope must be signed or the ballot is invalid. All ballots must be received by 4 p.m on Friday, April 16.

"They can count on you and that is why they keep coming back," said Jackson.



Resume of Minutes

Regular Board Meeting • January 27, 2010

The Jo-Carroll Energy Board of Directors met on Wednesday, January 27, 2010 at Chestnut Mountain Resort. The following is a summary of the meeting activities.

- Joe Mattingley, Chairman, called the meeting to order at 9:00 a.m. All board members were present. Others present were attorney John Cox, recording secretary Dorothy Young, and President and CEO Michael Hastings. Staff members Kyle Buros, Pat Keleher, Tracy Heidenreich, Richard Larimore, Russ Simpson and Dorothy Waters were also present during all or part of the meeting.
- The agenda was approved as modified. The consent agenda items were approved, including the December 2009 board meeting minutes and minutes summary, safety report, written reports from staff, correspondence and board expense summaries.

Member Presentation

Mike Murphy, Manager of Chestnut Mountain Resort, welcomed the Jo-Carroll Energy Board of Directors to the resort and provided an overview of Chestnut Mountain's operations, including recent improvements and updates. He invited members of the Board of Directors to take a tour of the facility following the meeting.

Chairman's Report

Chairman Mattingley discussed the recent strategic planning sessions held by the co-op and believed they went extremely well. He noted that several new values statements were to be presented. Mattingley thanked the members of the board and staff for their help in making the process a success.

Dairyland Report

Chris Stadel reported on activities of Dairyland Power Cooperative. Dairyland scheduled two full load control days in December 2009. Dairyland received a very positive court ruling

regarding its ongoing dispute with the federal government over its failure to pay Dairyland for nuclear decommissioning and storage costs associated with Dairyland's nuclear assets. The court awarded Dairyland \$37.6 million in damages for costs incurred by Dairyland to date. The federal government is expected to appeal. Stadel reported on Dairyland's 2009 margins and how they were allocated to the members. Stadel noted that the Sierra Club had not yet filed its threatened lawsuit against Dairyland regarding power plant emissions. Stadel also discussed several transmission projects Dairyland had in its 2010 work plan.

AIEC Report

Dave Senn provided a report regarding activities of the Association of Illinois Electric Cooperatives (AIEC). Senn noted that the media campaign regarding global warming being discussed at the AIEC was not implemented. A new law regarding lobbyist reporting was discussed. Senn reported on Federated Rural Electric Insurance Exchange's plans to move its annual meeting to the Fall rather than holding it in conjunction with the NRECA's annual meeting. A survey was developed by the AIEC regarding services provided by the Association. Senn also discussed new developments with media access and information, including Facebook and Twitter. These tools are now being utilized by cooperatives to communicate with members and the public at large.

Strategic Activity

Smith presented the monthly policy for consideration, Policy 131 – Distributed Generation. Policy 131 was approved as presented.

CEO Report

 Financial Operating Report – The CEO reported that the Cooperative had an unaudited margin of \$861,852 for the month of December 2009. This compares with a budgeted margin for the month of December 2009 of \$497,836. The Cooperative finished 2009 with an unaudited margin of \$1,920,672 compared to a budgeted margin of \$2,278,455. Other aspects of the financial report were highlighted. The monthly financial operating report was approved.

- **Power Supply Report** The CEO reported on Dairyland's rate increase for 2010, which will be just under a 5% increase. Hastings also discussed the Interstate Power and Light's (IPL's) wholesale rate true-up, the IPL demand charge increase and other IPL rate issues that were underway.
- Biomass Plant Update The CEO provided the board with a report on the Sand Prairie biomass plant, including a number of recent staff and consultant activities that have occurred regarding the project. A new property option was discussed that would expand the amount of property available for the plant's development. Work continues with the water discharge permit. Discussions with potential project partners continue.
- NRCO Report The CEO reported on activities involving the National Renewables Cooperative Organization (NRCO). He discussed renewable generation projects being pursued by the NRCO, work with the Rural Utility Service regarding NRCO renewable power contracts, and work to develop a biomass power purchase agreement.
- Strategic Planning Implementation – Hastings reported on the staff's work on implementing the new strategic planning strategies as developed at the recent sessions. A new organizational chart was presented that had been developed to better assist the Cooperative in pursuing its strategic objectives. The CEO reported on other actions taken to date.
- Economic Development Program and TCEDA Update – Simpson provided a report on the co-op's

economic development efforts including progress associated with the Tri-County Economic Development Alliance (TCEDA). A new Executive Director has been hired. Randy Prasse has been selected for the position. Mr. Prasse has held a number of leadership positions involving economic development. Work continues in earnest regarding the proposed purchase of the Thomson prison by the federal government. TCEDA is mobilizing to assist with this effort.

- Substation Infrastructure/Broadband Update – Buros provided a report on progress with the substation infrastructure/broadband program. More members have signed up for the co-op's wireless internet service, Sand Prairie Wireless. Several new towers have been erected. A redundant bandwidth path from Clinton, Iowa is being planned. A new wallet sized marketing card has been developed regarding the service. The cards were distributed to board members.
- Facilities Charge Update Hastings reported on an analysis of the co-op's facilities charges.
- External Affairs Update Cox provided a report on the climate change issue being considered by Congress.

Board Issues

- Dairyland District Meeting Board members that planned to attend Dairyland Power Cooperative's 2010 District Meeting in Decorah, Iowa discussed that event.
- Approval of Work Orders and Special Equipment – The Board of Directors approved the 2009 work orders and special equipment listing.
- Approval of 2010 Strategic Plan

 The Strategic Plan developed for
 2010 was presented, including several
 new value statements. The Board of
 Directors approved the 2010 Strategic Plan, including the changes to
 the Cooperative's values statements.
- **Consideration of Property Option** Hastings discussed a recommendation to pursue a second property option involving the biomass plant site. After discussion, the Board of Directors voted to approve the second property option proposal as presented.

- Approval of Nominees for the Credentials and Election Committee

 The Board of Directors reviewed the listing of nominees for the Credentials and Election Committee.
 Proposed Committee nominees were Jeffrey Klein, Michelle Randecker and Don Slaats from District One; Alan Bird, Bob Strahlman and Rob Volkommer from District Two; and Dale Harms, Harvey Kloss and Gary Lietz from District Four. The Board of Directors approved the Committee nominees.
- NRECA Course 2640.1 Financial Decision Making – Those directors planning to attend the NRECA Course 2640.1 involving Financial Decision Making, scheduled for March 4, 2010 in Springfield, Illinois discussed that event.
- CFC Voting Delegate and Alternate Chris Stadel was selected as the Cooperative's Voting Delegate to the 2010 CFC Annual Meeting, to be held in conjunction with the NRECA 2010 Annual Meeting in Atlanta, Georgia. Russell Holesinger was selected as the Cooperative's Alternate Delegate to the CFC Annual Meeting.
- Federated Voting Delegate Pat Smith was selected as the Cooperative's Voting Delegate to the Federated Rural Electric Insurance Exchange's 2010 Annual Meeting to be held in conjunction with the NRECA's 2010 Annual Meeting in Atlanta, Georgia.
- NRTC Voting Delegate and Alternate – Dave Senn was selected as the Cooperative's Voting Delegate to the NRTC 2010 Annual Meeting, to be held in conjunction with the NRECA 2010 Annual Meeting in Atlanta, Georgia. Marcia Stanger was selected as the Cooperative's Alternate Delegate to the NRTC Annual Meeting.
- **Conflict of Interest Declaration** The Board of Directors completed conflict of interest forms for 2010 pursuant to Policy 103.
- Committee Meeting Scheduling

 A meeting of the Cooperative's Policy Committee was scheduled for February 10, 2010 at 5:00 p.m. A

meeting of the Cooperative's Executive Committee was scheduled for February 23, 2010 at 5:00 p.m.

- AIEC Survey The Board of Directors discussed the AIEC survey regarding services provided by the Association.
- Jo-Carroll Energy 2010 Annual Meeting Theme and Report Cover

 The Board of Directors reviewed several possible themes and report covers for the Cooperative's 2010 Annual Meeting. "Membership Matters" was selected as the 2010 theme. Pictures for the Annual Meeting report cover were chosen.
- Dairyland Power Plant Tour Those planning to attend the tour of Dairyland Power Cooperative and one of its power plants on February 11, 2010 discussed that event.

Executive Session

The board of directors went into executive session to discussion pending litigation, potential property acquisitions and labor/employment issues.

After coming out of Executive Session, the Board of Directors approved a budget variance for 2010 and ratified a decision to retain Sullivan and Ward, an Iowa law firm, to assist the Cooperative with a complaint filed against the Cooperative by the Iowa Utility Board involving a natural gas pipeline.

Reports

- Those attending NRECA Course 2620.1 Board Roles and Relationships, held at the AIEC on January 7, 2010, reported on that course.
- The Board of Directors discussed the Cooperative's Strategic Planning sessions held on January 11-12, 2010.
- Those attending the Galena Rotary Club's 2010 Rotary Roundtable Event on January 13, 2010 discussed that event. Cox was one of the featured speakers at the 2010 Roundtable.
- Smith reported on her attendance at the 2010 Jo Daviess County Leadership Forum.

Earth Day turns 40 on April 22! Celebrate by saving energy — the quickest, cheapest, cleanest way to extend our world's energy supplies and help the environment by improving efficiency.

Follow these simple tips for greater energy efficiency and lower costs:

- Replace regular incandescent bulbs with energy-efficient compact fluorescent lights (CFLs) that use only a quarter of the energy to produce the same amount of light. CFLs help reduce electric bills and the bulbs last four times longer.
- A well-placed tree can reduce cooling costs and provide a relaxing and refreshing spot to enjoy the outdoors. Re-

member when planting a tree to be aware of overhead power lines and avoid taking unnecessary risks (see sidebar).

- Clean or change filters monthly during the cooling or heating seasons. An efficiently running cooling system will save dollars.
- Cooling costs can be lowered by about 3 percent for each one-degree increase in the thermostat setting.
- Weather-stripping and caulking are inexpensive measures to seal air leaks and boost overall efficiency.
- When replacing appliances large or small, look for Energy Star qualified products.
- Turn off lights, televisions and other electric appliances when



leaving a room.

- Operate your clothes washer and dryer and try cooking and baking during cooler morning and evening hours.
- Take cell phones and other items off chargers once they have finished charging. These items continue to use energy until they are unplugged.

Know where to plant that young tree

any people plant trees during the spring, especially around National Arbor Day, occurring April 30 this year. Planting young trees has many environmental and beautification benefits, but Jo-Carroll Energy wants to remind everyone to be aware of electrical hazards while planting this year.

Seek help from professionals when choosing and placing trees and bushes, and remember the following:

 Consider mature height of trees. Never plant a tree near a power line that could grow within 25 feet of it. Tall growing trees should be planted a mini-

mum of 20 feet away from power lines, and 50 feet away to avoid future pruning. A mature height of less than 15 feet is recommended for trees planted near power lines.

Do not plant near underground utility services. Tree roots can grow to interfere with underground pipes, cables and wires. Future repairs to these facilities could damage the health and beauty of nearby plants and trees, or even require removal.

- Keep areas around electric meters, transformers or other electrical equipment free of any vegetation that could limit utility service access.
- Before digging, call the underground utility locator service to mark the location of underground utilities so that accidental contact, damage and injuries can be avoided.
