The board met on Wednesday, February 24, 2016, at the Jo-Carroll Energy Headquarters. The following is a summary of the meeting activities. The Agenda and the Consent Agenda were approved.

Chairman's Report – Chairman Senn commented on the high cost of large-scale battery storage projects as being high, but that technological advances may bring costs down where it warrants consideration. Senn also noted that transmission costs are on the rise around the country, as well as the effects of the EPA's Waters of the U.S. rule may have on cooperatives and farmers.

Dairyland Report – Director Stadel reported that there was no meeting this month.

AIEC Report – Director Senn reported that AIEC's Norm Conrad is retiring and Bradley Rightnowar has been hired to replace him. Former Secretary of Transportation, Ray La Hood, will be the keynote speaker at the AIEC Annual meeting. The passage of the "Electrify Africa" Act was also discussed.

APGA Report – Director Carroll reported that the Sierra Club is bringing lawsuits related to fracking. The APGA is in the process of hiring a new general counsel.

PPI Report – Director Hallendorff reported on the Prairie State generating units' performance and availability.

Monthly Committee Review

Policy Report – Policy 100.1 - Governing Style was discussed and approved with no changes.

CEO's Report – The CEO reported on the following in addition to his written report:

a. Financial Operating Report – Hastings reported that the Cooperative had unaudited margins of approximately \$1,142,000 in January, compared to a budgeted amount of \$725,000. The Board accepted the January Financial Operating Report for filing with the auditor by general consent.

b. Power Supply Report – CEO Hastings reported the following: Alliant Energy has approached the cooperative with an offer to purchase 16 Mw of generation from a new natural gas facility. Dairyland will soon release marketing materials related to their planned solar energy projects. The PPI board has decided not to pursue any further merger or consolidation efforts.

c. CFO Report – Vice President and Chief Financial Officer Heidenreich reported on the cooperative's weighted cost of capital, noting that it has decreased due to proactive efforts by the board and staff, as well as favorable market conditions. Heidenreich also reported that the independent audit for 2015 was close to completion.

d. Sr. Vice President and Assistant General Manager Report – Director of Operations, Bob Pelelo, reported on the electric and natural gas work plans for 2016, as well as the status of the headquarters building addition. Manager of Key Accounts, Ken Sivertsen, provided updates on compliance efforts and key accounts. Director of Engineering, Jesse Shekleton, provided an update on the

Cooperative's net metering policy and the fiber pilot project in Galena.

e. Culture of Excellence and Communications – Merri Sevey, Vice President of Human Resources outlined the Cooperative's partnership with Southwest Tech regarding the school's electrical power distribution program.

f. Member Services – Jennifer Skien, Vice-President of Member Services, clarified a small discrepancy between the recently approved yearly Sand Prairie rates and the marketing materials. Skien also updated the board on outstanding account balances.

g. External Affairs Update – Chris Allendorff, Vice President of External Relations and General Counsel reported on the stay issued by the U.S. Supreme Court regarding the Clean Power Plan, as well as the effects that Justice Scalia's death may have on current and potential cases. Allendorff also reported on the NexGen breakfast being held by TCEDA at Highland Community College and that TCEDA's annual meeting will be held on March 17 at the Irish Cottage.

Board Issues

a. Discounted Estate Retirements Approval – CFO Heidenreich presented the current discounted estate capital credit retirements for the board's consideration. The discounted estate retirements were approved as presented.

b. Approval Allocation of 2015 Margins – Allocation of the 2015 Margins were approved.

c. CRC Voting Delegate/Alternate – The CRC Delegate and Alternate were chosen.

d. NRECA Legislative Conference – The NRECA Legislative Conference will be held May 1-4 and the attendees were confirmed.

e. CFC Forum – The CFC Forum will be held June 5-8 and the attendees were selected.

f. TCEDA Annual Meeting – The TCEDA Annual Meeting will be held March 17th and the attendees for the meeting were selected.

g. Dairyland Power Cooperative Annual Meeting – The Dairyland 75th Annual Meeting will be held on June 8 and the attendees for the meeting were selected.

h. Special Equipment and Work Order Reports – The 2015 Special Equipment and Work Order Reports were approved.

Reports – Reports were heard on: Leadership Forum, Dairyland District Meeting, and the NRECA Annual Meeting.

Upcoming Meetings – March 8-9 NRECA Course 2640.1- Financial Decision Planning.

Other Business

Credentials and Election committee- Names were submitted.

Executive Session

Executive Session was held to discuss pending and possible litigation, other legal matters, and employment matters.

Consideration of Matters discussed in Executive Session – None.

Adjournment – The meeting was adjourned at 11:55 AM.

Ballots are only mailed to members in a district where more than one candidate has been nominated. Results of the director election in District 4 will be announced at the annual meeting. Bylaw amendment

One bylaw amendment will be considered. The proposed change is to "Article IV Directors" regarding the nomination and election process for positions on the board of directors. The amendment adds a

provision that "Nominations of an individual to run for the election to a Director position scheduled for election at any Annual, Regular, or Special Meeting of the Members will not be accepted from the floor at such meeting, nor will write-in votes naming persons not properly nominated in accordance with the foregoing Section 5 be counted." Director Candidates

DISTRICT #1

Incumbent: Martin Werner, 361 Sherwood Ave., East Dubuque, IL 61025



Martin Werner has been a member of the Jo-Carroll Energy Board of Directors since 2007.

He lives in East Dubuque with his wife, Sherrie. They have been married for 44 years. They have two daughters and four grandchildren.

Werner has lived in this area for more than 60 years. His grandfather, John Werner, was the Marshall of

East Dubuque. Martin formerly worked for John Deere in Dubuque Iowa for 30 years. He also owned and operated a part-time auto repair business (Marty's Auto Repair) for 25 years.

Martin attended St. Mary's grade school and graduated from East Dubuque High School. He served two years in the United States Army in the Armored Division at Fort Hood, Texas. He also worked in a missile unit in Germany.

Martin was elected to the Jo Daviess County Board in 2014 and

he has served on the East Dubuque Zoning Board and is a retired member of the East Dubuque Volunteer Fire Department.

"I would like to represent District 1 with the knowledge that I have gained from all the years that I have lived in this area. The fact that I am now retired gives me plenty of time to invest myself in serving the members of the cooperative. I feel that my experience in many different fields should serve well as a director for Jo-Carroll Energy."

DISTRICT #2

Incumbent: Joseph Mattingley, 292 West Schapville Rd., Scales Mound, IL 61075



Joseph Mattingley is from rural Scales Mound, Illinois, and resides in Guilford Township. He has been a member of the co-op since the late 1990s. Currently he is the chief executive officer of The Galena Territory Association, Inc.

He was a graduate from Scales Mound High School. Post-

graduation, Mattingley enlisted in the Navy as a Medical Corpsman. Upon completion of his stint in the Navy, he finished his college degree from Highland Community College and then Columbia College of Freeport.

Since his appointment to the board in May of 2006, he has brought ideas to Jo-Carroll Energy from his member constituents that have helped advance board and administrative policies.

The initiatives that have evolved

from Mattingley's input range from energy conservation, power supply and national energy policy to recycling programs. He promotes the idea of cooperative communications and has assisted multiple times with member communicate. If re-elected, he will continue to promote these and other efforts within his district, as well as throughout the Jo-Carroll Energy service area.

Mattingley is a former board chairman.

DISTRICT #4

Incumbent: Chris Stadel, 6609 S. Blanding Rd., Hanover, IL 61041



Chris Stadel is seeking re-election to the District 4 Directorship. He has been a member of the Jo-Carroll Energy board of directors since 2004.

Chris is also on the board of directors for the AIEC and has been since 2008. He is the director for the Dairyland Power Board. Stadel has been a Jo-Carroll

Energy member since August of 1991. Through director educational courses, Stadel has earned his CCD (Cooperative Credential Director Certificate) and his Board Leadership Certificate.

He is running for the Jo-Carroll Energy Board because he wants to help ensure the lowest rates possible for members. He also would like to make sure that the members have a voice representing them.

Stadel states, "due to the rising cost of energy, I want to do all that

I can in helping members to find ways to reduce energy costs as well as providing reliable service at the lowest possible rate."

DISTRICT #4

Bret Jones of Hanover is seeking election to the District 4 directorship. He has been a member of Jo-Carroll Energy for five years.

Jones said he has a strong experience to be a solid contributor to the Jo-Carroll Energy Board of Directors. Now retired, Jones' experience includes work as an electrician with Dixon Commercial Electric; engineering, large industrial and wholesale account manager with Wisconsin Power & Light; and power trading/marketing with Delhi Energy, Tenaska. His experience also includes power and gas

trading at Cargill Power & Gas Markets, with his final position as president and business unit leader.

A graduate of Dixon High School, he has a B.S. degree in electrical engineering from the University of Illinois.

Jones has conducted wholesale power contract negotiations with city councils and electric commissions of several Wisconsin communities. Jones stated his experience is well suited to the board and he is very interested in the nuances of the busi-

ness, adding he "would like to better understand and provide input to the management of the business and provide input that benefits the members.

"I believe I can do a lot to assist in fulfilling the Jo-Carroll Energy mission statement, and build a culture that builds trust with members and drives success for Jo-Carroll Energy," Jones said. "Across a range of electrician, electrical engineer, wholesale U.S. power, transmission system understanding and business management, I bring good skills to the Jo-Carroll Energy board and members of District 4."

Jones has two sons and two daughters. His interests include solar power, dogs, working on his property, reading, kindness and education.

National Electrical Safety Month addresses common home electrical hazards

May is National Electrical Safety Month and Jo-Carroll Energy is teaming up with the Electrical Safety Foundation International (ESFI) to spearhead the annual effort to raise awareness of potential home electrical hazards and the importance of electrical safety.

"Extension cord misuse and overburdened electrical systems are two of the main causes of home electrical fires," said ESFI President Brett Brenner. "It is important to be aware of these common and preventable hazards, as well as other safety measures you can take to ensure that your home is electrically safe."

The National Fire Protection Association (NFPA) estimates 47,700 home structure fires reported to U.S. fire departments each year involve some type of electrical failure or malfunction as a factor contributing to ignition. These fires result in 418 civilian deaths, 1,570 civilian injuries and \$1.4 billion in property dam-

age. Awareness and education are critical to reduce the incidence of electrical fires, and ESFI sponsors National Electrical Safety Month each May to educate the public.

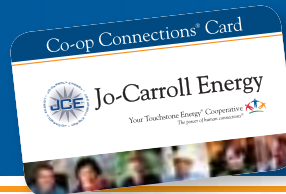
