Jo-Carroll Energy supports youth

We talk a lot about the services we provide members—home energy audits, convenient billing options and events like our annual meeting and member appreciation days. However, many of our value-added benefits are directed at a younger audience.

At Jo-Carroll Energy we take great pride in highlighting the value of cooperative membership to our youth—after all, they're our members-in-training. We provide a wide variety of programs that benefit youth, from elementary school safety demonstrations to scholarships for graduating high school seniors.

For younger kids, we have a variety of programs ranging from the CFL Charlie Super Energy Savers classroom program to wildflower seed packets celebrating Earth Day courtesy of our Sand Prairie Wireless broadband internet service. Just this year, co-op employees have visited more than 825 students in classrooms and at events across our service territory to present safety and efficiency programs.

Older children benefit from our participation in career fairs and other special events. And, for children of all ages, we provide safety demonstrations.

During the annual Rural Electric Youth Tour, more than 1,500 high school students, generally rising seniors, from across the country descend on Washington, D.C. to learn about government, history and the role of electric cooperatives. Jo-Carroll Energy selects two high school students to travel to our nation's capital for this annual Youth to Washington program. Students complete

applications and go through an interview as part of the selection process.

The youth tour provides a unique opportunity for high school students to gain insight into our government and cooperatives. I want to congratulate Thomas Watson of Mount Carroll and Kelley Koester of

Elizabeth who were chosen to represent Jo-Carroll Energy this year.

Finally, we're proud of our annual scholarships for high school seniors. The co-op awarded its first two scholarships in 2003. Each year

since 2008, Jo-Carroll Energy has awarded five scholarships to graduating seniors from throughout our service territory—two from both Carroll and Jo Daviess counties and one from Whiteside County. Following the recent merger, we will review the scholarship program to include our new members from Henry County for 2014.

I'm pleased to announce that five scholarships were awarded again this year to a group of seniors who have outstanding academic records, impressive community involvement and ambitious goals for the future. They are: Zachary Gronewald of Galena, Matthew Carroll of Elizabeth, Morgan Ashby of Thomson, Matt Keppen of Chadwick and Olivia Whitney of Albany. Congratulations to our communities' future leaders.

Resume of Minutes

Regular Board Meeting • March 27, 2013

The board met at the Cooperative headquarters in Elizabeth on Wednesday, March 27, 2013. The following is a summary of the meeting activities. The Agenda as modified and the Consent Agenda were approved.

Member Presentation: A presentation was made by Rich Mattas, Interim Executor Director of the Jo Daviess Conservation Foundation. He reviewed structural changes being planned for the organization and listed major activities, completed and pending. He described properties owned by the Foundation and explained the Rivers to Ridges Program.

Chairman's Report - The Chairman commented on his tenure as Chairman of the Board of Jo-Carroll Energy. He said he will not be seeking re-election as Chairman after the Annual Meeting. He reviewed the goals the Board had adopted and expressed his appreciation for the effort put forth in achieving many of them. He said he felt Jo-Carroll Energy was one of the leading cooperatives in the State of Illinois and that he was amazed at how fast his six years as Chairman passed. Mattingley also commented on the leadership provided to the Cooperative by CEO Michael Hastings and his senior staff. Director Stanger expressed her opinion that the entire Board has appreciated his efforts as Chairman.

Dairyland Report - Director Stadel reported that the Dairyland financials show a positive variance from the budget. He said he attended the Rules and Regulations meeting with the CEO on March 26th and felt the meeting went well.

AIEC Report - Director Senn stated that Jo-Carroll Energy continues to be a leader in the State of Illinois. He said he saw the resolution process as one continuing to move forward. He reported that he had brought back a certificate from the Association of Illinois Electric Cooperatives (AIEC) for the success of Jo-Carroll Energy in assuring a safe work environment for its employees.

APGA Report - Director Carroll reported that the conference was excellent and that he had learned a lot.

Monthly Committee Review

a. Approved Board Policy 116 entitled Member and Non-Member Requests for Cooperative Information as presented.

CEO's Report - The CEO reported on the following in addition to his written report:

a. **Financial Operating Report -** Hastings reported that the Cooperative had an unaudited margin of \$651,149 for February. He reviewed the various financial reporting documents and answered questions from Board members. The Board accepted the Financial Operating Report for filing by general consent.

b. **Power Supply Report -** The CEO reported that he is awaiting approval of language Jo-Carroll Energy has recommended to Interstate Power & Light (IPL) for a settlement of the pending litigation.

c. **Farmers Mutual Report** The CEO stated that the merger with Farmers Mutual Electric Company (FMEC) will close on Monday, the 1st of April. He reminded the Board that Tom Zwica, Doug Darby and Ron Hallendorff will be the new members of the Board of Directors having been appointed by the FMEC Board.

d. **CFO Report -** CFO Heidenreich introduced Dean Rohne, auditor with the firm of CliftonLarsonAllen. He advised the Board that his opinion was "unmodified" which previously was "unqualified." He advised that the cooperative is in "good shape." CFO Heidenreich updated the Board on her work related to facilitating the Farmers merger including identification of assets that will become the property of Jo-Carroll Energy upon closing.

e. **COO Report -** COO Buros said he believed everything was ready for the closing on April 1st with Farmers. He discussed projected system upgrades that will be imple-

mented to increase the reliability of service to the members. He then provided the Board with a 3-D drawing of the system upgrades he was describing.

f. **Culture of Excellence and Communications -** Vice-President of Human Resources Sevey discussed the progress being made coordinating with FMEC employees for their smooth transition to Jo-Carroll Energy. She emphasized the comfort level she had experienced working with both Jo-Carroll Energy employees and FMEC employees related to their ability to work together to make the merger happen.

g. **Member Services -** Vice-President of Member Services Skien stated that additional funds have been made available through the AIEC working with the State of Illinois Department of Commerce and Economic Opportunity (DCEO) for the HomeE Lite Program. She reported that Jo-Carroll Energy is the number one cooperative in the State of Illinois for rebates to members, already totaling in excess of \$64,000. Skien reminded the directors that the natural gas rate increase will take effect on April 12th. She closed her comments stating that the unbundling of electric bills for Jo-Carroll Energy continues to move forward.

h. **External Affairs Update -** Cox reported the Federal Government has not approved a budget but has approved another continuing resolution that the Board that the Thomson Prison remains closed. He closed his report with a discussion on current activities of the Tri-County Economic Development Alliance (TCEDA).

Board Issues

a. **Galena Jo Daviess County Historical Society -** The Board of Directors approved a pledge to the Historical Society.

b. **401K Plan Modification/Resolution -** Approved modifying the 401K.

c. **Board Performance Evaluation -** All Board members completed their Board Performance Evaluation forms.

d. **Audit Report -** Approved the Audit Report.

e. **CRC Voting Delegate & Alternate -** Approved CEO Hastings as Delegate and COO Buros as Alternate Delegate to the Cooperative Response Center (CRC) Annual Meeting.

f. **IRS Form 990 Questionnaire -** Directors were requested to fill out the questionnaire as soon as possible.

g. **Gas System Proposal -** CEO Hastings described an investment opportunity in a gas system that may be for sale. Board authorized proceeding with the due diligence process regarding this opportunity.

h. **JDCF (Jo Daviess Conservation Foundation) Proposal -** Approved a contribution to JDCF for 2013.

i. **RS Prepayment -** Approved the prepayment over a period of five years with interest at 2.15%.

j. **PPI Board Director Selection -** Approved Tom Zwica Director, Director and Doug Darby Alternate Director, Director for Jo-Carroll Energy directors on the Board at Prairie Power, Inc. (PPI) and Michael Hastings as Manager, Director.

l. **PPI Assumption Agreement -** Approved the Assumption Agreement with PPI for power supply.

m. **National Wind Proposal -** Approved proceeding with due diligence on the wind proposal.

n. **Use of EnPower name -** Approved investigation with Dairyland Power regarding the purchase of the name "EnPower" and any related trademarks.

o. **Capital Credit Allocation -** Based on capital credit allocations recommended by the CFO, the Board approved those recommendations.

Reports/Meetings - The Board heard reports on several matters and reviewed scheduled meetings.

Adjournment - The meeting adjourned at 1:43 pm.

Director Profile - David Senn

The cooperative business model is the “perfect thing for this corner of the world,” says Jo-Carroll Energy’s new board of directors chairman David Senn.

Senn was elected chairman at the board’s reorganizational meeting following the 74th Annual Meeting of Members held April 13.

Co-ops are a good way of doing business in rural America where communities are more closely knit, neighbors know each other by name and when “someone new moves in down the street or road you go introduce yourself,” Senn said.

“Cooperatives—and the difference we bring to the table versus an IOU—are an excellent business model. Their shareholders don’t have anything involved or benefit beyond their investment. There are things they are willing to give up for a return on an investment. In the co-op business model, we are all owners. We don’t want to cut corners. We want the system to last; we don’t want to stretch every penny out of it to line our pockets. We want reliability.”

While Jo-Carroll Energy still serves a more rural area, Senn noted these are “not the same people who were happy and joyful that electricity showed up on the farm. People are living longer; we have improved lifestyles. We have come to assume electricity is going to be there. But it’s kind of like driving privileges, if you abuse them, they can go away.”

That’s where the collective voice of co-op owners is important. Rural America lost a huge voice when it lost many small farmers, Senn observed. “But we (co-op members) do have numbers. Nationally, we’re 42 million strong and have more territory as far as lines than the rest of the systems across the country. If we get together we can provide that grassroots feedback to the people in government and let them know our feelings that we don’t want to go away, that we don’t want to be forced out.”



An involved membership is important to the co-op, Senn said. “It’s easier to do things for people if they have an understanding of what you’re trying to do and what you’re trying to accomplish. I hope members are involved enough to give us input, because

always in our minds as directors that what we’re doing is for the benefit of the membership. . . . They need to know what happens. It’s their system. They own it.”

Senn also stressed the importance of planning for the future, and not just what happens next year. Like as in individual financial planning—a process he was involved in for more than 20 years—the board has the challenge of looking forward and planning for contingencies, both the positives and the negatives.

“We’re always looking out beyond what’s in the immediate future and hoping we do the best for our members going forward,” Senn said. “We’re going through some of the toughest times right now with aggregation and the market cost of electricity being as cheap as it is.”

Cautioning against being like the investor who looks for the short-term gain, Senn commented that “in less than the blink of an eye what you’re saving for can be gone. The same thing can happen here. Some members look for a short-term fix; we on the board look out beyond what’s on the immediate horizon and hope we are doing the best for our members going forward.”

Senn pointed to system improvements in recent years, pointing out that Jo-Carroll Energy has done a lot with the system that was gained through the acquisition in 2007. “We’ve taken a system and brought it into the 21st century. It was not just a dollar commitment but a time commitment and effort on the part of the co-op and board.

“Sometimes members don’t see the benefits of clearing trees, improving poles and replacing things that need to be replaced,” he said. “But our out-

ages are fewer and lesser in duration because of the things we did. Our goal was to accomplish that.”

Senn stressed the need to continue moving forward. The recent merger with Farmers Mutual Electric is an excellent example. “We bring these members technology and services they couldn’t have afforded, and at the same time we get to expand the services we have. . . . We’ll continue to “look for opportunities that allow us to grow, whatever they may be as long as they fit into what we currently do and benefit our members.”

A member of Jo-Carroll Energy since 1982, David Senn was first appointed to the Jo-Carroll Energy board of directors in the fall of 2007.

Senn is the Jo-Carroll Energy board’s representative to the Association of Illinois Electric Cooperatives. He has served on the statewide scholarship committee, board self-evaluation committee and as chair of the resolutions committee.

As a director, he has completed the courses necessary to become a certified cooperative director and the Board Leadership Program.

A graduate of Northern Illinois University in 1967, he received a B.S. degree in accounting. After graduation he became a naval flight officer, achieving the rank of lieutenant. He later entered into a career in the brokerage industry that included a five-year stint in New York City. Senn worked as a financial planner until retiring in 2011.

A member of the Lions Cub International, Senn has served as a district governor on the executive board for Illinois and has held all positions of office with the local Mount Carroll Lions Club. He is actively involved in many conservation groups such as the National Wild Turkey Federation, Pheasants Forever and the Rocky Mountain Elk Foundation.

Jo-Carroll Energy members re-elect incumbent board members

An estimated 450 members, employees and friends of Jo-Carroll Energy gathered for an appreciation breakfast and the cooperative's annual meeting held April 13 in Elizabeth.

A number of new members were on hand for the annual meeting, the first following the co-op's recent merger with Farmers Mutual Electric Company.

During the meeting, members approved bylaw amendments that created a new tenth district covering the Geneseo area, directors to represent the district and clarification of qualification requirements for service as a director. Directors representing

the newly created District 10 are Tom Zwica, Doug Darby and Ron Hallendorff.

Three incumbent Jo-Carroll Energy directors were re-elected to the cooperative's board of directors. Results of the director elec-

tion in District 2 were announced. Members re-elected Joseph Mattingley of Scales Mound in a two-way race in which Mark Turczynski had challenged the incumbent. Mattingley also has served as board chairman since 2007.



Incumbents Martin Werner of East Dubuque and Chris Stadel of Hanover were re-elected to represent Districts 1 and 4, respectively, by a vote of acclamation at the meeting. No other candidates had filed petitions for nomination. A bylaw change approved in 2011 provides that ballots are mailed to members only in districts where more than one candidate has been nominated. All directors serve three-year terms.

In keeping with the meeting theme "This Is Your Co-op", Mattingley opened his remarks by asking those present to think about why they were at the meeting.

"It's because we believe in the benefits of a community working together," he said. "By their very nature, co-ops empower members to improve their lives. We want you to be involved as we build a better future together."

"By working with your co-op, you can make a big impact on the communities we serve. We encourage all members to learn as much as they can about their co-op, and join us as we lend our time, resources and assistance as we continue the cooperative tradition of making a difference in our communities," he added.

Michael Hastings, Jo-Carroll Energy president and CEO, echoed the chairman's comments that members are the cornerstone of the cooperative.

"Over the years, it has been you, the members, who have ensured our success," he said. "From the early days, we've had dedicated local folks step up and contribute to help bring service to their rural neighbors. . . . We are a community of people, helping one another. And that is the cooperative difference."

Mattingley and Hastings both welcomed the new members from the merger, and recognized employees for their efforts during the past year. Hastings also presented updates on projects undertaken by the cooperative's electric, natural gas and broadband departments, an online member portal and savings through the Co-op Connections® Card.

District 7 director David Senn of Mt. Carroll was elected as chairman at the board's reorganizational session following the annual meeting. Mattingley announced during the meeting he was stepping aside from the chairmanship. Senn served as the board's treasurer previously. Werner was elected as treasurer. Board officers re-elected were Stadel as vice chairman and Marcia Stanger of Apple River, District 3, as secretary.

You can help ease summer demand

Summer 2013 will be much like Summer 2012 in that there will be plenty of sunny warm days. Our gardens, lawns and flower beds will grow, children will celebrate being out of school for the summer and we will want to keep our homes comfortable with air conditioning.

Each year the total amount of electricity we use as a cooperative family has been increasing (as it is across the nation). With the electricity demand and the market's power prices in our region highest on weekdays between the hours of 11 a.m. and 7 p.m., we all have an opportunity to curb our use during those hours.

We need your help to delay summer peak period energy use as much as possible on those hot summer days to help us hold the line on our rates. We will need to use less electricity during the summer peak demand on weekdays from 11 a.m. to 7 p.m. to

accomplish this. We are asking for your help in shifting electricity use outside of this window as much as is reasonable and possible for your household.

It's about community

Together we can shift the time of our use of any non-essential electricity to avoid these peak hours, which can limit additional charges assessed back to the co-op. Please plan to move optional power use outside of the summer peak demand window, using it before 11 a.m., after 7 p.m. or on weekends.

Our goal is to lower our entire co-op's demand for power during these more costly summer peak demand hours to prevent higher energy charges from being passed along to you, our members. It is our goal to provide reliable access to all the power your family needs and to help

you use it most wisely to help manage our costs today and in the future.

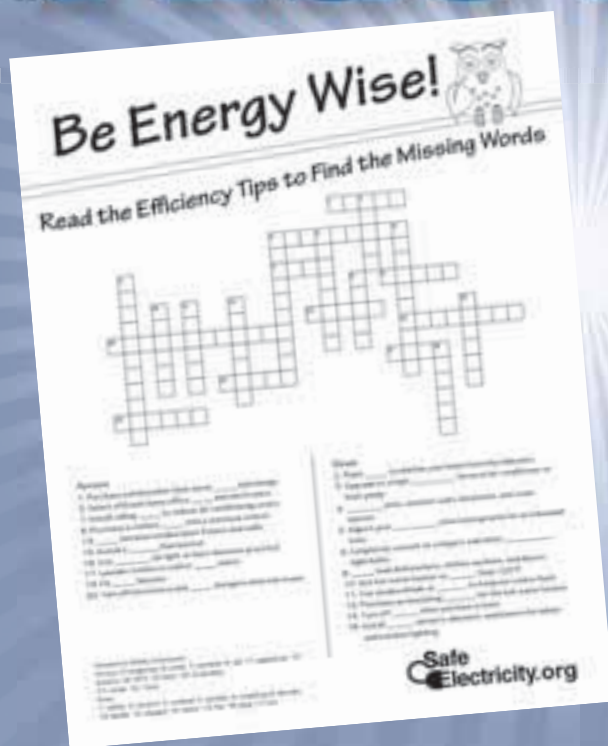
What can you do?

Shifting your family's electricity use to before 11 a.m. and after 7 p.m. on weekdays is the key.

Do you have any electricity needs that can be done earlier in the day or later in the evening? Can you wait until after 7 p.m. to recharge portable electronics and cell phones? Can you delay laundry until after 7 p.m., or move some of it the weekends? Perhaps closing your drapes and windows during the day so your air conditioner runs less is a possibility for you?

You may decide it is time to try either raising the temperature a couple of degrees on your air conditioning or switching to cycled air conditioning—we can help you figure out what makes sense for your household. Together We Save.
