PRESIDENT'S REPORT

At the annual meeting we announced our intention of increasing the monthly facility charge for residential service in the acquired service area to \$12, an increase of \$3 from the current \$9 facility charge. Members receiving residential service will start to see this increase on their September bills.

Currently, the legacy members' facility charge is \$18. Throughout the acquisition, we discussed the plan to bring the facility charges for the legacy and acquired areas together over a period of five to seven years. It has been just over three years since the acquisition, and this increase is a part of that plan.

The facility charge is what helps us pay for the costs associated with getting power to you. Even when members use little or no power, we still have expenses to keep it ready and reliable for when you do flip a switch. It covers a variety of expenses such as the costs of poles, transformers, metering devices and other line equipment. Other costs of doing business such as accounting, billing and associated activities are also covered through the facility charge. These costs – all those things we need to have electric service available for you when you need it – are incurred whether you use one kilowatt hour or a thousand.

We do everything we can to control costs and increase efficiencies. In my report in May, I discussed my concern about the continued increases and volatility of electric energy costs. We will see increased power costs from our power suppliers in 2010. The latest estimates from Dairyland Power Cooperative indicate those power costs will increase just over 5 percent. Interstate Power and Light's power costs are still being finalized but are expected to rise even more. Increased power costs are passed through to Jo-Carroll Energy and in turn to our members in the power cost adjustment.

With climate change legislation still under discussion, it is an uncertain time for the electric industry. At the time of this writing, it was unclear when or if the U.S. Senate would take up debate of a new piece of legislation introduced by Senators John Kerry from Massachusetts and Joe Liebermann from Connecticut. Unveiled in May, the draft of the American Power Act proposes legislation including a call for emissions from power plants to be regulated by a cap and trade program.

Last year the U.S. House of Representatives passed its version of climate change legislation that also included a cap and trade system. Adding to concerns, the U.S. Environmental Protection Agency (EPA) declared last December that six key greenhouse gases, including carbon dioxide, are "endangering public health and welfare." This opens the door for the EPA to issue new rules that could impose strict limits on carbon emissions,

Resume of Minutes

Regular Board Meeting • April 27, 2010

The Jo-Carroll Energy, Inc. Board of Directors met at the Cooperative head-quarters in Elizabeth, Illinois on Tuesday, April 27, 2010. The following is a summary of the meeting activities:

Chairman Joe Mattingley called the meeting to order at 9:20 AM. The agenda was approved unanimously as modified. The Consent Agenda, including the March 31, 2010 board meeting minutes and minutes summary, safety report, written reports from staff, AIEC Report, correspondence and board expense summary was approved unanimously.

Chairman's Report

Chairman Mattingley discussed several key issues being considered by the Jo-Carroll Energy Board of Directors. He commented on the "Great" Annual Meeting and thanked the board and staff for their most successful efforts. These issues included references to challenges for the coming year including energy legislation. The Chairman described his desire that the board become more involved in the resolution process both at the AIEC and the NRECA. Chairman Mattingley expressed his appreciation for the continued support of the board in re-electing him as Chair.

Dairyland Report

Chris Stadel reported on activities of Dairyland Power Cooperative. He commented on the March meeting of the Dairyland Power Board of Directors. He provided a report on the continued operation of GEN-SYS Energy by Dairyland. Director Stadel prefers that GEN-SYS be brought inside Dairyland for cost savings as well as more consistent operations. He also reviewed information regarding

the upcoming Dairyland Power Annual Meeting.

AIEC Report

Dave Senn reported that the Association of Illinois Electric Cooperatives (AIEC) has completed their Budget Draft. Director Senn then reported on the CFC/CoBank case settlement for \$22,000,000.00. This case did not involve the Cooperative.

Strategic Activity

Pat Smith presented the monthly policy for consideration, Policy 134 – Workplace Violence. The policy was approved unanimously with minor corrections.

CEO's Report

The CEO reported on the following:

- Financial Operating Report The CEO reported that the Cooperative had an unaudited margin of \$74,736 for the month of March 2010. This compares with a budgeted margin for the month of March 2010 of \$213,554. A motion was made, seconded and carried unanimously to approve the monthly financial operating report.
- Power Supply Report The CEO reported on issues involving the Cooperative's electric and natural gas suppliers. Staff continues to attempt to resolve an Interstate Power and Light (IPL) billing error issue. The CEO also commented on the Dairyland Power rate study in process.
- Biomass Plant Update The CEO provided the board with a report on the Sand Prairie biomass plant, including a number of recent staff and consultant activities that have occurred regarding the project. Work continues at the Illinois

EPA with the project's air permit application. Work also continues on the water discharge permit process. The CEO reported on completion of negotiations and signing of documents with the landowners on a second property option. Discussions continue with several potential development partners.

- County Property Update Hastings reported that the County continues to work on getting its new Hanover property ready for use. Appraisals have been ordered for the county property previously purchased by Jo-Carroll Energy, both individually and combined.
- Digester Discussion Bonnie Cox is working on arranging a meeting regarding possible use of a County digester for energy production. Care will be taken to avoid conflicts involved in Bos dairy project. The meeting could be held in June or July.
- Spring Collections Update-Amanda Russ Amanda Russ, Member Services Manager, provided an update on her background at Jo-Carroll Energy and that of her team. She discussed collection rules and changes in the law. She reported on upgrades to the phone system, including the recording of calls. Ms. Russ also reported on the spring disconnection cycle.
- Economic Development Program Update Simpson provided a report on the Cooperative's economic development efforts. He reported on the recent activities of TCEDA in fundraising and program implementation. Simpson commented on efforts to develop the property in Mt. Carroll known as the Campbell Center at the former Shimer College. Jo-Carroll Energy will continue to emphasize

Co-ops are helping homeowner members to get efficient



Want to learn how you can make your home more energy efficient and save money? Jo-Carroll Energy can help.

Through the HomE program, co-op members who own their homes can receive a residential energy assessment, which makes them eligible for a series of rebates for efficiency upgrades they can make to their home.

Jo-Carroll Energy is able to offer this program through stimulus funds received by our statewide association. The Association of Illinois Electric Cooperatives is distributing \$1.5 million in American Recovery and Reinvestment Act (ARRA), or stimulus funds, to cooperative members through this program. The funds are allocated evenly to members of 25 electric distribution cooperatives in the state.

Who is eligible?

To participate in the HomE program, you must be a member of

Jo-Carroll Energy. The home must be served with electricity or natural gas by Jo-Carroll Energy and must be the member's primary residence.

How does the program work?

Start by contacting the co-op to arrange for a home energy assessment by one of our energy experts. A cooperative representative will meet with you at your home to do an energy assessment. An adult member of the household must be present.

We'll provide you with a written follow-up report that makes a series of recommendations on how you might improve your home's energy efficiency, performance and comfort – saving money and valuable energy.

There is a \$25 charge for this service.

What do I need to do?

Then the next step is up to you. Based upon the recommendations made by the cooperative, you could

be eligible for a one-time rebate of up to \$1,500 per residence for improvements you make.

Once you have your recommendations, you decide what is best for you. You will then submit a proposal form and estimate to us. We will return a signed copy to you, indicating that funds have been set aside for you. You will then have 60 days to complete your project.

Once you have made your purchase or completed your project, you will send us a completion form with copies of the paid receipts. We will then issue a check to you.

Rebates will be available until funds are exhausted.

Standards

All heating-cooling system upgrades must meet federal Energy Star standards in order to be eligible. The standards are:

Geothermal, closed loop	14.1 EER, 3.3 COP
Geothermal, open loop	16.2 EER, 3.6 COP
Air-source heat pump	16 SEER
Central air conditioning, split	16 SEER
Central air conditioning, package	14 SEER
Natural gas or LP furnace	95 percent efficiency
Heat pump water heater	2.0 energy factor

Rebate schedule:

Rebates are available for Energy Star-qualifying heating-cooling system upgrades, and for installation of heat pump water heaters. Rebates are also available for installation of insulation and weather stripping/sealing.

Geothermal heat pump	\$1,500
Air-source heat pump	\$1,000
Central air conditioning	\$350*
Natural gas or LP furnace	\$350*
Heat pump water heater	\$250
Insulation	30 percent of project costs, maximum of \$500.

The maximum total grant is \$1,500 per cooperative member/residence. Grants will be approved for a central air or gas furnace upgrade, but not both.

Small changes add up to big savings

The Virtual Home
Tour provides a good starting point. As you move
through each of the six
rooms, clicking on areas highlighted in yellow
prompts you to take various
interactive energy-saving
measures and shows how
these changes translate into
savings on your electric bill.

A visit to the attic, for example, recommends adding insulation. Slide the arrow up the scale to add extra inches of insulation and watch the exciting end result. Adding nine inches saves up to \$143 a year. Add 15 inches, and that figure jumps to \$241.

Now head downstairs to the living room. Most folks enjoy watching television and playing Wii or Xbox games, but you don't need these gadgets on 24 hours a day. By unplugging entertainment center devices when they're not in use, you could save up to \$174 every year. Seems simple enough — and every small step adds up to big savings. In fact, just lowering your thermostat one degree in winter could save \$82.

The website uses calculations targeted for our co-op's kWh electric rate and geographic lo-



cation. In short, it gives you an accurate reflection of what your potential savings could be if you implement suggested steps.

including those from power plants.

The Clean Air Act is the wrong tool for the job. The National Rural Electric Cooperative Association (NRECA) believes it is the responsibility of Congress and not an administrative agency to develop policy. At least eight bills have been introduced to prevent or delay the use of the act to regulate carbon.

Over the past year, many of you joined the grassroots campaign "Our Energy, Our Future" to send a message to Congress about our energy future and the need to keep electric bills affordable. I encourage you

to continue the conversation and visit www.ourenergy.coop to ask Congress to step in and prevent the EPA from using the Clean Air Act to regulate greenhouse gas emissions from power plants. Together we can send a message and keep the lights on at an affordable price.

Help your air conditioner save you money

Air conditioners — and dehumidifiers — consume a lot of electricity, and are the largest summer utility expense for many families.

Without regular service to your air conditioner, its efficiency can fall by as much as half, especially when it works overtime in the summer heat. However, proper maintenance and repair on your air conditioner will save you money and can extend its life for roughly 15 years.


Also, recent design improvements have reduced the consumption of this hungry appliance. During the hottest weather, you may need the full capacity of your air conditioner to keep your home comfortable. During this full-time operation, standard air conditioners run at their maximum efficiency. But during moderate weather, old-fashioned air conditioners will cycle on and off to keep from over-cooling your home. This stop-and-go operation is inherently inefficient, since a lot of energy is wasted during the start-up and shut-down part of each cycle.

Air-conditioning units with a two-stage compressor and a multi-speed outdoor condenser fan operate at lower capacity during moderate weather. This results in longer cycles and improved efficiency. It also allows your system to remove more humidity from the air. When the weather is truly hot, they step up to full-speed operation to assure your comfort.

Here are a few other tips to help you keep your cool this summer and keep your energy bills lower.

- Use ceiling fans to cool your AC costs. They offer extra cooling & better circulation so you can raise the thermostat.
- Go green and save energy when cooking summer meals by cooking outdoors whenever possible to reduce the load on your air conditioner. Toaster ovens, convection ovens and slow cookers can get the job done with less energy than conventional stovetops or ovens, especially when preparing smaller meals.
- Heat absorbed through windows and roofs makes your air conditioner work harder and gobble up more electricity. But incorporating shading concepts into your landscape design can help reduce this solar heat gain—and your cooling costs. Shading from trees can reduce surrounding air temperatures as much as 9° F.
- If you use air conditioning, a ceiling fan will allow you to raise the thermostat setting about 4°Fahrenheit with no reduction in comfort. In temperate climates, or during moderately hot weather, ceiling fans may allow you to avoid using your air conditioner altogether. Install a fan in each room that needs to be cooled during hot weather.

You can't avoid the heat of summer, but by taking a few energy efficiency steps you can reduce the cost of cooling your home.

economic development and will be working closely with TCEDA and the communities in the area to assist them.

- Substation Infrastructure/Broadband Update Buros provided a report on progress with the substation infrastructure/broadband program. More members have signed up for the Cooperative's wireless Internet service, Sand Prairie Wireless. SCADA equipment is in the process of being installed at co-op substations. Equipment is being readied for AMI with actual installation to begin soon. The wireless Internet backbone is in place and the final loop to serve Chadwick and nearby will soon be installed.
- Water Update The CEO reported EJ Water Cooperative from Effingham, Illinois will be coming to the area to review several of the water systems in the area. EJ Water can provide assistance with grant applications, lobbying and other activities being studied by Jo-Carroll Energy in adding this service activity.
- External Affairs Update Cox provided a report on pending climate change legislation now that the health care bill has passed. He discussed possible changes to the "cap and trade" provisions as well as the possibility that immigration may replace climate change as the focus of debate in the near term. The upcoming 2010 NRECA Legislative Conference in Washington, D.C. was discussed with reference to a planned private meeting with Senator Durbin by the CEO and Board Chair being able to focus the Senator on issues of concern to Jo-Carroll Energy.

• Voting Delegate/Alternate for United Utility Supply – A motion was made, seconded and carried unanimously to appoint Kyle Buros as delegate and the CEO as alternate to attend the United Utility Supply meeting.

 Delegates to Dairyland Annual Meeting – A motion was made, seconded and carried unanimously to name Holesinger, Stadel, Stanger, Werner and

Holesinger, Stadel, Stanger, Werner and Lundy as delegates to the Dairyland Power Annual Meeting in LaCrosse, Wisconsin.

- Employee Breakfast The date for the Employee Appreciation Breakfast will be May 13, 2010 at the Jo-Carroll Energy headquarters in the multi-purpose room.
- Industrial Member Contract Negotiations Update Hastings provided an update on the pending negotiations with large industrial customers Danisco, Rentech and Metform, rate issues and other contract terms.
- Consideration of Rates Administrative Policy # 901 (Rentech Delivery Service Schedule) Administrative Policy # 902 (Danisco Delivery Service Schedule) Administrative Policy # 903 (Metform Delivery Service Schedule) were presented to the board. A motion was made, seconded carried unanimously to approve the rates as presented.
- Consideration of 2009 Tax Return
