In 2011 the electric cooperatives of Illinois received \$2.5 million from the American Recovery and Reinvestment Act program through the Illinois Department of Commerce and Economic Opportunity's State Energy Plan. Those funds were, in turn, distributed as rebates to co-op memberowners for energy efficiency projects. This investment paid real dividends and helped prime the pump for nearly 10 times that in energy efficiency investments. Better yet, the energy efficiency improvements will multiply the savings for many, many years.

The HomE energy efficiency rebate program was so successful in creating new jobs for heating and air conditioning contractors, plumbers and insulation installers plus saving energy for co-op member-owners that it is being repeated for a second but very limited time.

If you didn't get a chance to participate in the first round of HomE rebates now you have a second chance. HomE Lite rebates are available for a very limited time until funding runs out. They began January 1, 2013.

HomE Lite Incentive Rebates Include:

Insulation and Weatherization	50 percent of total project cost, <i>up to \$1,000</i>
Heat Pump Water Heater*	\$250

Energy Audit by BPI certified auditor (and perform one significant improvement noted in the audit)	up to \$300

Present were Manager Lynn Frasco, Attorney Charles Smith, and Directors Gary Martin, Jerry Brooks, Michael Carls, Jay Frye, Warren Goetsch, Donald McMillan, Michael Patrick, Roy Seaney and Steven Worner.

Frasco advised there are a total of 88 new irrigation systems for the year and he anticipated at least 4 or 5 more; 29 are diesel conversions; co-op will need to install 13 miles of line to serve new systems.

Prairie Power completed security assessment with recommendations for data room.

Co-op scored well on Safety Accreditation Inspection.

Co-op will use a web design service from NRECA.

Frasco reported through the CoBank Sharing Success Program the co-op was contributing \$2,000 to the Mason County Food Pantry.

Co-op will donate \$500 to NRECA International Program.

Frasco discussed proposed new tree trimming bid specifications for 2013 program. Attorney Smith in process of reviewing bid specification form. Goetsch discussed HomE Lite program.

Goetsch asked Board members to review a white paper entitled Managing Uncertainties in Electricity Costs in Illinois.

Carls and Frasco discussed impact of Prairie Power 2013 base demand re-calculation and its effect on co-op.

Frasco discussed re-establishing power cost adjustment for 2013 energy billing rates; will present different scenarios next month.

Frasco discussed Nominating

Committee, formed to fill the vacancy created by upcoming retirement of Carls. Three members serving on the committee were given list of members in district. Committee will meet and suggest names for consideration. Frasco advised he would like them, with proposed nominees, to attend next month's meeting.

November 27, 2012

Manager Frasco presented the Financial Report for Oct. Year to date margins were 1,407,167 compared to 735,838 a year earlier. Equity as of the end of Oct. was 35% and the number of members served was 10,555 compared to 10,544 a year ago. Net Utility Plant at the end of Oct. was \$38,549,020 compared to \$36,153,190 last year. The cooperative continues to meet the requirements of the RUS, FFB and NRUCFC.
