- 1. Keep farm equipment at least 10 feet from power lines.
- 2. Use a spotter when moving large equipment near power lines. And be aware of higher antennas on large modern tractors
- 3. Use care when raising augers or truck beds. Lower portable augers or elevators to their lowest level before moving. Variables like wind, uneven ground, shifting
- weight or other conditions can combine to create an unexpected result.
- 4. Never attempt to raise or move a power line to clear a path.
- 5. Don't use metal poles when breaking up bridged grain inside and around bins. Be careful not to raise equipment such as ladders, poles or rods into power lines.

What do you do if you contact power lines?

Stay inside if your farm equipment comes into contact with a power line.

If the power line is energized and you step outside, your body becomes the path and electrocution is the result. Warn others who may be nearby to stay away and wait until the electric utility arrives to make sure power to the line is cut off.

If there is the unlikely threat of fire or other risk, the proper action is to jump – not step – with both feet hitting the ground at the same time. Do not allow any part of your body to touch the equipment and the ground at the same time.


Continue to hop or shuffle to safety, keeping both feet together as you leave



the area. Once you are away from the equipment, never attempt to get back on or even touch the equipment.

Many electrocutions occur when the operator dismounts and realizing nothing has happened, tries to get back on the equipment.

HomE program rebates for homeowners

She came to the annual meeting in June and enjoyed her pork chop dinner, received a \$10 bill credit and attended the energy efficiency seminar. She went home with an energy efficiency starter kit, information on the HomE program, and knowledge of how energy efficiency improvements can save her big each month on her electric bills.

She called our office soon after the meeting to inquire about the HomE rebate program. Hazel told Tim Schafer at our office that her furnace was original to her home, built in the 1960s, and she thought it was about time to replace it.

In fact, with a tax credit up to 30 percent and an additional \$350

HomE rebate through us, it might just be the perfect time.

Tim set up a time to meet with Hazel at her home. He collected some information from her about her home and started the HomE paperwork process. The program requires the homeowner to pay \$25

to have the initial assessment completed. "Well, I got a \$10 bill credit for attending the annual meeting so it's like it cost me \$15 then," says Hazel.

Now that the assessment is completed it's up to Hazel. She'll get a few bids on a new furnace, decide what contractor to use and what system to put in. The furnace must be 95 percent efficient to receive the rebate. That's also the standards needed to get the 30 percent tax credit.

Once her system is put in, Hazel will simply send us the receipt and we'll issue her a check for the \$350. It's that easy.

"I try to keep my house up," says Hazel. "I always have. It came here in pieces and we helped to build it," she says speaking of herself and her late husband. Hazel has a lot of pride in her home and maintains it well. A new furnace should last her many years.

Board Meeting Report

Menard Electric Cooperative From the Board Room May 25, 2010

The monthly Board Meeting of the Board of Directors of Menard Electric Cooperative was called to order by President Gary L. Martin at 6:00 p.m. at the headquarters of the cooperative, 14300 State Highway 97, Petersburg, County of Menard and State of Illinois.

On roll call the following Directors were present: Jerry W. Brooks, Michael L. Carls, D. Jay Frye, Gary L. Martin, Donald E. McMillan, Michael E. Patrick and Roy H. Seaney. Directors Warren D. Goetsch and Steven L. Worner were absent. Also present was Manager Lynn A. Frasco and Attorney Charles K. Smith.

President Martin reviewed the Consensus Agenda. It was moved and seconded that the Consensus Agenda be approved with the changes to the May 4, 2010, minutes. Motion carried.

Manager Frasco presented the Manager's Report for the month of April 2010. He reviewed the Balance Sheet, Budget, Outage Summary and Safety Report.

Under the Operations Report, Manager Frasco reported on the work done by the crews for the month. He advised that he was expecting the final payment from FEMA with regard to the ice storm damage. He received a call from Prairie Power on May 24, 2010, for voluntary transmission curtailment. He advised that Menard interrupted hot water heaters for a period of time.

He advised that he had further discussions with regard to the repair of Gumtown Road issue. He stated that he had heard nothing further as of the date of the meeting in response thereto. He discussed the status of the Virginia wells line construction and reviewed the diagram indicating the progress of work, showing that portion of construction that had been completed, the portion that was still in process and that portion for which the design work had recently been completed. He advised that Virginia wanted the line energized sometime in November.

Manager Frasco reviewed the Ameren CIPS Residential Rate Changes and advised that Ameren had increased its fixed charges. He also reviewed the Low Income Energy Assistance Program that showed payments by month and per county for September 2009 through 2010. The total payments to Menard members for that time period was \$116,880.00 in comparison with the total payment for the previous year in the sum of \$97,406.00.

He submitted to the Board a proposal from CoBank as to refinancing two existing loans Menard had with RUS. He discussed the terms and provisions of the proposal which would provide for an interest rate of 4.49% as opposed to the 5% interest rate with RUS. He discussed the interest savings and the fact that the cooperative would also receive a patronage refund from Co-Bank. After discussion by the Board, it was moved and seconded that the cooperative proceed with refinancing the notes with CoBank on the terms as proposed by CoBank. Motion carried.

Manager Frasco also discussed with the Board making further draws on another RUS loan. He discussed the advantages of doing so and applying the loan proceeds to the cushion of credit. After discussion by the Board, it was the consensus to give Manager Frasco discretion as to making further draws on the RUS loan. It was moved and seconded the Manager's Report be approved as presented. Motion carried.

Manager Frasco presented the Financial Report for the month of April. Year to date margins were \$501,769 compared to \$438,474 a year earlier. Equity as of the end of April was 34.84% and the number of members served was 10,496 compared to 10,469 a year ago. Net Utility Plant at the end of April was \$35,390,605 compared to \$35,148,311 last year. The cooperative continues to meet the requirements of the RUS, FFB and NRUCFC.

Manager Frasco advised that Director Goetsch was absent due to medical reasons. Manager Frasco advised that there was no AIEC Meeting. President Martin advised that it was necessary to certify the Director and Alternate Director for the AIEC Board and also the Representative for the AIEC Annual Meeting. It was moved and seconded that Director Goetsch be made the Director with Director Brooks as the Alternate. Motion carried. It was moved and seconded the Director Goetsch be certified as the Representative with Director Brooks as the Alternate Representative for the 2010 AIEC Annual Meeting. Motion carried.

Director Carls reported on Prairie Power, Inc. and reviewed the April Energy Charge as well as the President's Report. He reviewed the discussions by the Prairie Power Board with regard to the back billing of power supply costs for 2008 and 2010. He advised that no decision had been made by the Prairie Power Board and the matter had been tabled to next month's Board Meeting. Manager Frasco reviewed Deferred Revenue for 2009 through 2012 in comparison with other cooperatives of Prairie Power.

Director Brooks reported on plans for the Annual Meeting scheduled for June 5, 2010. He advised that there was an Annual Meeting Committee Meeting scheduled for Wednesday, June 2 at 9:00 a.m.

Manager Frasco reviewed the General Retirement of the Menard Electric Capital Credits. He advised that the total number of members who had received capital credits was 5,820 and total retirement for all members was \$408,793.29.

Manager Frasco reviewed the Capital Credit Estate Refunds Report.
