Join us for our 77th Annual Meeting of Members

This year, we have two individuals vying for the District 1 position — current board member, Larry Haas of rural Millstadt and Richard Hollis of rural Columbia.



Larry A. Haas lives north of Millstadt and is seeking his 14th three year term as a director of Monroe County Electric Co-Operative. He

has been the only MCEC director to chaperone the Illinois Youth to Washington bus trip.

Besides being a member of MCEC, he was active in community organizations and organized a community survey for the Millstadt Jaycees resulting in building the Millstadt swimming pool. Haas also intervened in state wide telephone rate cases before the Illinois Commerce Commission and was granted rights to cross examine company witnesses and offer alternate solutions to rate and service matters. One case resulted in calls to Belleville and Columbia included in basic phone service to Millstadt.

Haas has a master's degree in engineering from Washington University in St. Louis. He held professional engineering and real estate broker licenses in Illinois and Missouri.

After retiring from Boeing-St. Louis, Haas programmed flight planning systems for Scott AFB. His last industrial activity was serving on a four person senior design and launch approval team for NASA Shuttle.

He presently heads Concordia Water Co-op. He has obtained the only Illinois grant to aid in construction of the water system (worth up to Monday, March 23, 2015

Dining in the Dark

Food safety tips during a power outage

C torm-induced power outages can take you by surprise. If you've lost power and have a refrigerator full of food, make sure time and temperatures are on your side.

If your home's power is interrupted for two hours or less, losing perishable foods shouldn't be a concern. When an outage is prolonged, it's time to decide when to save and when to toss food away.

A digital quick-response thermometer can be one of the most useful tools you can wield in your battle to preserve food. The gadget checks the internal temperature of food, ensuring items are cold enough to eat

Use these food safety tips to help you minimize food loss and reduce the risk of foodborne illness:

Refrigerated Food


- Keep refrigerator doors closed as much as possible. An unopened refrigerator keeps food cold for about four hours.
- If food (especially meat, poultry, fish, eggs, and leftovers) has been exposed to temperatures above 40 degrees Fahrenheit for two or more hours, or has an unusual odor, texture, or color, get rid of it. Remember the American Red Cross food safety rule: "When in doubt, throw it out."

- Never taste food to determine its safety or rely on appearance or odor.
- Use perishable foods first, then frozen food.
- To keep perishable food cold, place them in a refrigerator or cooler and cover with ice.

Frozen Food

- A full freezer stays colder longer. Freeze containers of water to help keep food cold in the freezer. If your water supply runs out, melting ice can supply drinking
- If you keep the door closed, a full freezer keeps the temperature for approximately 48 hours (24 hours if it is half full).
- If food in the freezer is colder than 40 degrees Fahrenheit, is partially thawed, and has ice crystals on it, you can safely re-
- Always discard frozen or perishable food items that have come into contact with raw meat juices.
