## **CEO'S REPORT**by Mike Casper

This time last year I was preparing to move back to the area that I call home. Having traveled and lived throughout the country, it's great to be back to one of, if not, the most beautiful regions of the United States with the friendliest and most caring people.

One of my favorite parts of the job is reacquainting myself with so many people I haven't seen in years and talking with our members about the cooperative. I had the chance to do that again in September when we met with the co-op's Member Advisory Council (MAC) at Elkay, an Americanowned and operated company located in Savanna. The meeting was designed for MAC members to learn more about this local business, hear updates and share ideas. (See page 18c for information on how you can get involved.)

After the meeting, we received a message from one of the MAC members about the "member/owner" concept and how it may be unfamiliar to many of our members. He reminded us that many Jo-Carroll Energy members, especially those who have moved from larger cities, find it difficult to connect the co-op and member concept to the company that issues their utility bills.

Living on co-op lines is more than paying your bill once a month. It is more than the amount of kilowatts or therms you use, and it is even more than just knowing that there are people working every day to bring you safe, reliable and affordable service.

Living on co-op lines is an investment – an investment in our area and an investment in our members.

Founded as a way to bring electricity to areas that didn't interest investor-owned

utilities (like those that supply larger cities), electric co-ops have been a cornerstone of community and economic development in rural America for decades.

Unlike our IOU counterparts, we are not-for-profit. When we make more money than we need to supply energy safely and reliably, we return it to our members in the form of capital credits. After all co-op expenses are paid, any additional money we earn goes back into our communities instead of a shareholder's pocket.

Because we are owned by you – the members – we have a vested interest in making sure our community is prosperous. We support community service projects that make for a better quality of life for our members. It's why we undertake projects like Sand Prairie fiber that will better connect our members to each other and the world.

As your cooperative, our purpose extends beyond keeping the lights on, the gas flowing and the internet connected. Together we're working to make a difference.

I hope you view Jo-Carroll Energy as a local business that takes pride in helping bring prosperity to our communities. One that puts members first.

## **Resume of minutes**

August 23, 2017

he board met on Wednesday, August 23, 2017, at the Jo-Carroll Energy headquarters. The following is a summary of the meeting activities. The Agenda, as amended, and the Consent Agenda were approved.

Chairman's Report - Chairman Senn discussed the solar industry as a whole and the financial circumstances of the State of Illinois, noting that these are "challenging times." Senn reiterated the importance of keeping our Members informed. Senn also noted that Rock Energy recently presented to the AIEC board regarding its operations and future plans.

Dairyland Report - Director Mattingley discussed the Dairyland Report. Mattingley informed the board that Dairyland had a successful Strategic Planning Session.

#### AIEC (Association of Illinois Electric

Cooperatives) Report - Chairman Senn discussed donating to the NRECA (National Rural Electric Cooperative Association) International Foundation for an upcoming international project. President and CEO Mike Casper discussed Jo-Carroll Energy's safety culture and the importance of safety training. Senn reported that Jo-Carroll Energy received an award from the AIEC for our President's-level participation in the ACRE (Action Committee for Rural Electrification) program.

APGA Report - Director Carroll provided an update on regulatory matters being followed by the American Public Gas Association (APGA), as well as his attendance at the APGA Annual Meeting. Carroll reported on the Whiteside and Carroll County Fairs he recently attended on behalf of Jo-Carroll Energy, noting that he spoke with members about Fiber to the Home and First Call systems.

PPI Report - Director Hallendorff reported on Prairie Power Inc. (PPI's) most recent generation figures and provided operational highlights from Prairie State Units 1 and 2.

#### Monthly Committee Review

a. Policy 110 – Approval of Consultants – A motion was made, seconded and carried unanimously to approve Policy 110 as is.

#### CEO's Report

President and CEO Mike Casper provided a Fiber update and a reminder that a Member Advisory Council meeting and tour of Elkay's facility is scheduled for September 19.

- a. Financial Operating Report Casper reported on the Cooperative's operating margins for the yearto-date. The current equity of the cooperative is approximately 24.98%, compared to 23.65% at the end of 2016. By general consent, the board moved to file the financial operating report with the auditor.
- b. Tech Update Casper presented on solar energy, focusing on the various types of technologies and design plans for improving panel output.
- c. Senior Vice President and Assistant General Manager Report - Kyle Buros, Senior Vice President and Assistant General Manager, discussed

- Jo-Carroll Energy's strategic initiatives and their development, noting each employee will have input in the process.
- d. External Relations Update Chris Allendorf, Vice President of External Relations & General Counsel, provided the board with an overview of matters concerning the State of Illinois, noting that overrides of the Governor's veto of appropriations and spending bills were enacted. Allendorf noted that attention in the General Assembly will now turn to Senate Bill 1, which is a comprehensive reform for primary education funding from the state. Allendorf also discussed a new comprehensive energy bill that is in Congress, along with many appropriations and spending bills that need to be passed before the end of the year. Allendorf updated the board on the Tri-County Economic Development Association's (TCEDA's) upcoming events and projects and the hiring of a full-time staff member to assist TCEDA's Executive Director Lisa McCarthy.

#### **Board Issues**

- a. Discounted Estate Capital Credit Retirements - Discounted Estate Retirements Approval - A motion was made, seconded, and carried unanimously to approve the discounted estate retirements, as presented.
- b. Rate Policy 803 A motion was made, seconded and carried unanimously to approve Rate Policy 803
- c. NRECA International Foundation A motion was made, seconded and carried to approve a donation amount to the NRECA International Foundation. A second motion was made, seconded and carried to amend the donation amount.
- d. Renew Line of Credit with Illinois Bank and Trust
- A motion was made, seconded and carried unanimously to renew the line of credit with Illinois Bank and Trust.
- e. CFC (Cooperative Finance Corporation) Voting Delegate and Alternate Voting Delegate - Director Holesinger was selected to serve as the CFC voting delegate and Director Stanger as the alternate voting delegate.
- f. Select Voting Delegate and Alternate Voting Delegate for the PPI (Prairie Power Inc.) Special Meeting of Members - No action needed.

Executive Session - A motion was made, seconded and carried unanimously to go into executive session at

Out of Executive Session - A motion was made, seconded and carried unanimously to come out of Executive Session at 11:57 a.m.

Consideration of Matters discussed in Executive Session - None

Other Business - None.

Chairman Senn adjourned the meeting at 11:58 a.m.

## Petitions available for 2018 director nominations

Nomination petitions for the 2018 Jo-Carroll Energy Board of Directors are now available. Running for the board of directors and voting in the elections is a benefit of being a co-op member. Directors are democratically elected by the membership.

Five director posts will be up for election in the 2018 elections. Districts up for election include: District 8, currently represented by Russell Holesinger of Fulton; District 7, now represented by David Senn of Mount Carroll; District 5, now represented by Pat Smith of Galena; and District 10, now represented by Ronald Hallendorff and Robert Kuhns, both of Geneseo; and District 4, now represented by Dan Tindell of Galena. IPH 1103S

With this election, the number of representatives from District 10 will be reduced to one. Following the merger with Farmers Mutual Electric Company, District 10 was initially represented by three

directors, and reduced to two in 2015 following a transition and integration period. In District 4, the election will be to fill an unexpired term that ends in 2019. Tindell was appointed in May to fill the vacancy until the next election.

Any Jo-Carroll Energy member residing in a district that is up for election, including the incumbent director, may petition for nomination in that district. Members interested in seeking election to the board may pick up a nomination petition at one of Jo-Carroll Energy's offices or download a petition from the cooperative's website at www.jocarroll.com.

Petitions must be signed by at least 25 Jo-Carroll Energy members residing in the district for which the director is to be elected. Petitions must be filed at Jo-Carroll Energy's headquarters no earlier than Dec. 27, 2017 and no later than March 23, 2018.

In order to qualify to have their names placed on the ballot, all

nominees must participate in an orientation process provided by the attorney for the cooperative, assuring that all nominees fully understand the expectations and responsibilities of directors. These include but are not limited to: time demands, educational expectations and fiduciary duties.

All eligible candidates will be announced and listed on the cooperative's website and in Hi-Lines.

The 2018 Annual Meeting of Members is set for Wednesday, May 23 beginning at 6 p.m. at the Crossroads Community Church in Galena (the former Galena Convention Center).

## **Jo-Carroll Energy** sends crews to help with power restoration following Irma

To-Carroll Energy crews assisted with hurricane recovery and restoration at two Georgia electric cooperatives in September.

Linemen Steve Ludwig, Brad Travis, Jeremy Whitmer and Brandon Cummings were among the 123 Illinois linemen from 21 co-ops dispatched to assist with restoration efforts in Georgia and North Carolina.

In advance of Hurricane Irma, the Georgia Electric Membership Cooperative reached out to the Association of Illinois Electric Cooperatives (AIEC) for storm recovery help. The AIEC activated its Emergency Work Plan to assist.

The hurricane produced tropical-force winds, torrential downpours and extensive damage to Georgia's electric infrastructure.

Before the hurricane made landfall, the crew from Jo-Carroll Energy was sent to Carroll EMC in Carrollton, Ga. After helping to restore power to all of those members, the crew was released to assist others at Snapping Shoals EMC in Covington, Ga.

The Jo-Carroll Energy crews worked mostly with downed limbs and trees on lines and some broken poles, and not as much flooding or highwind damage as those working in other parts of Georgia and Florida.

Cooperative workers from 25 states converged in the hurricane's impact zone to assist in restoration efforts. Peak outage estimates indicated there were more than 760,000 co-op outages in Florida, 535,000 in Georgia and 100,000 in South Carolina, according to AIEC. The linemen were working an average of 17 hours a day, under difficult circumstances, to rebuild the systems.






## Powering Up After an Outage

When the power goes out, we expect it to be restored within a few hours. But when a major storm or natural disaster causes widespread damage, extended outages may result. Our line crews work long, hard hours to restore service safely to the greatest number of consumers in the shortest time possible. Here's what's going on if you find yourself in the dark:



#### 1. High-Voltage Transmission Lines:

Transmission towers and cables that supply power to transmission substations (and thousands of members) rarely fail. But when damaged, these facilities must be repaired before other parts of the system can operate.



2. Distribution Substation:
A substation can serve hundreds or thousands of consumers. When a major outage occurs, line crews inspect substations to determine if problems stem from transmission lines feeding into the substation, the substation itself or if problems exist further down the

# 3. Main Distribution Lines: If the problem cannot be isolated at a distribution substation, distribution lines are checked. These lines carry power to large groups of consumers in communities or housing developments.

#### 4. Tap Lines:

If local outages persist, supply lines (also known as tap lines) are inspected. These lines deliver power to transformers, either mounted on poles or placed on pads for underground service, outside businesses, schools and homes.

#### 5. Individual Homes:

If your home remains without power, the service line between a transformer and your residence may need to be repaired. Always call to report an outage to help line crews isolate local issues.

## **Budget billing accounts** recalculate in November

Tembers with budget billing for their electric accounts will have their budget amounts recalculated in November.

Because your budget amount is based on an average of the previous 12 months' use and outstanding credits or debits accrued, this November true-up recalculation may result in an increase or decrease, depending on changes in your use patterns.

Be sure to look at your November statement to see if your budget amount has changed. If a change results from the recalculation, a message will appear on your statement in blue indicating the new

budget amount. If you do not see a message on your statement, your budget billing amount remained the same.

If you have more than one billing account on budget, it is possible that one or both amounts may change. You begin paying the new budget amount in December. Invoice billed members, please remember that no messages will print on your bill statement whether or not the budget bill amount changes. If you would like to know your new budget bill amount, please call our offices between 8 a.m. and 5 p.m., Monday-Friday or email us at info@jocarroll.com.

Budget billing can help you manage your energy costs by allowing you to allocate the same amount each month. Monthly utility bills can vary significantly throughout the year due to variations in your usage through heating and cooling seasons. With Jo-Carroll Energy's budget billing plan, you eliminate the month-to-month fluctuations caused by changing weather and use patterns. It is imperative that members on budget billing still watch their monthly use and outstanding balances to ensure a large increase does not occur during a recalculation month.

## Levelized billing

Jo-Carroll Energy also offers a levelized billing program. Under this plan, each monthly bill is the rolling average of your electric use for the most recent 12 months, thus eliminating true-up months.

This means you will not pay the exact same amount every month, but it will be close to the same. The amount you owe some months will be more than the average, other months it will be less. Over the course of the year, you will have paid what you actually owe.

Levelized billing does not reduce your bill; rather it helps you manage your utility payments.

### **Neighbor to Neighbor Care Funds offer help**

Tf you need assistance paying your Lenergy bill this winter, help may be available through Jo-Carroll Energy's Neighbor to Neighbor Care Funds.

# Jo-Carroll Energy, statewide scholarships available

Jo-Carroll Energy will award up to \$25,000 to students from its service territory through its scholarship program. In addition, Illinois electric cooperatives in 2018 will award nine academic scholarships to high school seniors from across Illinois through a memorial scholarship fund.

The Jo-Carroll Energy Scholarship Program includes:

- Six Jo-Carroll Energy Scholarships in the amount of \$1,000 to current high school seniors whose parents or guardians are members of Jo-Carroll Energy. Two scholarships will be awarded in both Jo Daviess and Carroll counties and one each in Whiteside and Henry counties.
- Four \$1,000 scholarships (one awarded in each county of the cooperative's service territory) for students who will attend two-year, technical or trade schools.
- Two lineworker scholarships in the amount of \$2,000 each.
- Four \$1,500 scholarships (one awarded in each county of the cooperative's service territory) for adult or "non-traditional" students. These scholarships will go to cooperative members who are returning to school or will attend a post-secondary or accredited training program.
- Ten "Director's Scholarships" of \$500 each to be awarded to a student from each of the cooperative's 10 director districts. Current high school seniors, whose parents are members of Jo-Carroll Energy, are eligible for these scholarships. Applicants and at least one of their parents must attend the Annual Meeting of Members on May 23 where selections will be made by drawings.

All Jo-Carroll Energy scholarships are funded by unclaimed capital credits.

## IEC scholarships

Illinois electric cooperatives will award nine academic scholarships designed to financially assist deserving students in the "electric cooperative family." In addition, a tenth scholarship – to assist with costs in attending an electric lineworker school – will also be offered.

A total of 10 scholarships of \$2,000 each will be awarded through the Thomas H. Moore Illinois




Electric Cooperatives (IEC) Memorial Scholarship Program.

- Five scholarships will be awarded to high school seniors who are the sons or daughters of an Illinois electric cooperative member receiving service from the cooperative.
- The Earl W. Struck Memorial Scholarship will be awarded to a student who is the son or daughter of an Illinois electric cooperative employee or director.
- Three scholarships are reserved for students enrolling full-time at a two-year Illinois community college who are the sons or daughters of Illinois electric cooperative members, employees or directors.
- The "LaVern and Nola McEntire Lineworker's Scholarship" of \$2,000 will help pay for costs to attend the lineworker's school conducted by the Association of Illinois Electric Cooperatives in conjunction with Lincoln Land Community College, Springfield, Ill. Sons and daughters of co-op members, relatives of co-op employees or directors, and individuals who have served or are serving in the armed forces or National Guard are all eligible for the lineworker's scholarship.
