cooperatives "have benefited 156,-919 rural people in my state through central stations of electric service," he declared.

And he concluded:

The example of electric cooperatives with REA support providing widespread electric service at lowest possible costs in Illinois and elsewhere "has caused the commercial power industry to become more active in serving the needs of the nation."

### Gray, Shipley Sponsor Co-op Aid Legislation

Two Illinois congressmen have I introduced into the House of Representatives similar bills that would specifically exempt electric cooperatives from Federal Power Commission jurisdiction.

They are Representatives Kenneth J. Gray of West Frankfort and George E. Shipley of Olney. Other bills of a like nature also have been introduced in both the House and Senate.

Sponsors of such legislation have said that FPC regulation of nonprofit cooperatives not only is completely uncalled for but also is unnecessary as a protection for the investors and consumers. In the case of the electric cooperatives, the original investor is the United States whose interests are well protected by Rural Electric Administration regulations.

Also in the case of the cooperatives, supporters of this legislation point out, the consumers are actually owners of the cooperatives and these owner-consumers control the cooperative's operations including its rates and service conditions.

Consumer-owners would have no motive to overcharge themselves, supporters emphasize, and if the rates they set produced more than the cost of the service, the consumers ultimately recover these margins in the form of capital credit pay-

REA Administrator Norman M. Clapp in Washington testimony recently pointed out that Congress intended through the Federal Power Act to regulate only those companies which operated for a profit.

"The cooperatives should not be required to carry the burdens of superfluous commission regulation in addition to the substantial handicaps they face in carrying on the important job of rural electrification," he testified.

### Spot Checks **Show Meters** Being Misread

We have made spot checks with reference to meter readings and have found that some of our members are not reading their meters correctly, but are reading them under the exact amount, therefore lowering the monthly bill.

We have sent bills to numerous members where the meter reading was incorrect. As our check shows that meters are misread we are making a check of our entire system, reading all of our meters. This is rather costly.

We have also found a jumper on a meter. The member removed the meter and placed a jumper across the terminals. In accordance with the policies of the cooperative, members who tamper with the watt hour meters will be disconnected, and they must appear before the board of directors before reconnection can be made.

DR. RIDINGER swung quickly back to the subject of free time.

"Today one man with machinery and technological equipment and education produces five times as much as a man did in 1850 on a similar job—and in half the time," he said.

"This factor helps explain our prosperity, our great wealth of goods and why we have become a nation of consumers since there is so much to consume. And it begins to show why there is no need to work 10, 12 or 16 hours a day.

"Early in 1900 we were working 60 hours a week—farmers, office and industrial workers. Now this has shrunk by law to 40 hours a week and for many it is 35. Steel workers have been granted, at least those with five years' work records, a 12-week vacation every five years. They have a month's vacation every year.

"Also we're observing more holidays. For almost everyone the total is from seven to 13 holidays.

"Specialists who study these facts have come to realize that today we Americans have ten billion hours more free time than we had as recently as 1940 and it is predicted that by 1980—only 15 years away—we will have not ten billion hours more but a hundred billion hours more.

"The average working American, not an executive, has 121 free days per year—one in every three. No wonder the need for recreational facilities is skyrocketing!"



### Co-ops, Utilities Agree on Bill

The Illinois electric cooperatives through their state association introduced a bill in the House for territorial protection. The utilities introduced a bill in the Senate which would have brought the cooperatives under the Illinois Commerce Commission.

Gov. Otto Kerner called together representatives of both groups of power suppliers—utilities and cooperatives — and asked that they negotiate legislation satisfactory to both sides that would set up machinery through which electric needs of all Illinois citizens could be met in an orderly fashion.

Cross, director, legal and public affairs department, AIEC; Orville Foreman, general counsel for Western Illinois Power Cooperative, Inc.; and Charles C. Cole, chairman of the AIEC member and public relations committee.

We do not believe that this bill will solve all our problems, but it is surely a step in the right direction and it is a great improvement over our past experiences.



### Lake of Egypt Is Attracting Keen Interest

What's happening at one of Illinois' largest and newest manmade lakes?

President R. S. Holt, Steeleville, president of Southern Illinois Power Cooperative of Marion has a one-word answer: "Plenty."

Lake of Egypt is a sparkling 2,300-acre lake built by the power cooperative to provide cooling water for the 99-megawatt steam generating plant eight miles south of Marion.

THE PLANT is to be dedicated at 1:30 p.m. Sunday, Aug. 29, with Governor Otto Kerner delivering the dedicatory address.

The lake is essential to operation of the plant that will provide power for some 24,000 homes, churches, schools and businesses in the 22 southernmost Illinois counties.

But it is doing more than that. It is providing unexcelled recreational facilities for visitors from several states.

Southern Illinois Power Cooperative, with the enthusiastic support of its 12-member board of directors and L. Thomas Clevenger, its manager, is encouraging recreational use of the lake facilities.

Its clear blue water is highly suitable for fishing, skiing and other sports.

And more than 500 lake front building lots for year-round and seasonal homes already have been sold by private developers to private owners. At least 65 cottages and eight permanent homes have been built and the development program is just getting well under way.

THE BEAUTIFUL lake is located in Williamson and Johnson counties. It has 93 miles of shoreline.

"Cooperative and other area leaders have high hopes for the orderly development of recreational facilities made possible through creation of Lake Egypt," Ora M. Snider, information director and lake development manager for the power cooperative, said in a recent interview.

During the past months we have received letters from members of this cooperative requesting that the board of directors change the date of the annual meeting. These members said that they have routes in St. Louis on a Saturday afternoon and have never been able to attend an annual meeting of this cooperative because, ever since the cooperative was organized, the annual meetings have been held on a Saturday afternoon starting at 1:00 p.m. and adjourning about 4:00 or 4:30 p.m.

The board of directors has discussed this subject at several of its board meetings. The directors feel that all members should be given the opportunity to attend an annual meeting. At the July 20 board of directors meeting a resolution was adopted changing the annual meeting from a Saturday afternoon to an evening meeting during week days—that is, between Monday and Friday. #### State's Public Utilities Tax Rate Increased

We have received notice from the Department of Revenue of the state of Illinois that the Public Utilities Revenue Act increased the rate of tax from three to four percent effective Aug. 1.

This will change your rate schedule inasmuch as the three per cent tax we are now paying is included in your rate schedule.

The cooperative will not increase your rate to reflect the four per cent level for the remaining months of 1965. However, your meter reading books which will be mailed to you on Jan. 1, 1966, will have a different rate sheet enclosed which will include the four per cent Public Utilities Tax.

Therefore, your minimum of \$3.35 will be changed to \$3.38. The one per cent increase will be added to all other rate figures.

time of the meeting will be decided by the board of directors, and the members will be notified.

This change is on a trial basis, and if the attendance is good no doubt will be continued into the future.

At the board of directors meeting on July 20, the board passed a resolution recommending to the members that the bylaws be changed with reference to the number of proxies each member can vote. The bylaws now specify five proxies can be voted by each member. The board recommends that this be changed to two proxies voted by each member.

The change of bylaws, of course, will require a vote of the members at the annual meeting, and this subject will appear in the notice of this year's meeting.


Thomas H. Moore, general manager of the state association, was chairman of the morning session. Managers of service companies, cooperative managers and power use personnel were on the program.







# New Offices Occupied by State Group

Nearly 300 persons visited new headquarters of the Association of Illinois Electric Cooperatives six miles south of Springfield during a recent open house.

The one-story limestone building contains 4,556 square feet of office and meeting room space on the first floor plus an equal amount in the basement. The later houses chiefly the printing and mailing departments which include the most modern of offset printing facilities and darkroom.

LYLE E. DUNHAM, director, the state associations member service department, described the new headquarters in this way in an article published by Contractors' Electrical Equipment magazine:

"The installation is not spectacular. It is not designed to dazzle. Instead it is intended to be intensely practical, economical and efficient, reliable and satisfactory over a long period of years."

The structure includes the latest ideas in electric heating installed by E. P. Allison Company of Chicago and manufactured by Radiant Electric Heat Company of Centerville, Iowa. Mr. Dunham worked with Radiant Electric in designing the system.

"We regard this installation as highly practical for office buildings of all kinds, plus hotels, motels, senior citizens' homes and similar structures," a company spokesman said.

"This will stand the test of time and the wisdom of the electric heating plan will become increasingly apparent as the trouble-free years pass."

RAYMOND W. RUSTEBERG, Valmeyer, president of the state organization, said of the new building:

"We believe it will prove of considerable interest to builders and others concerned with planning and construction of similar structures.

Our estimates indicate heating costs will be less than \$600 annually."

Mr. Rusteburg said cost of the building and three-acre site was around \$140,000.

Members of the building commit-

tee are Walter Johnston, chairman; Owen Chaney, Paul Deisher, L. C. Groat, Loyd Pickard and W. L. Walker.

Ralph N. Morrisett, Springfield, was the architect.

### **New Office Work Progresses**

Questions asked cooperative associates very frequently are, "When will you move into your new headquarters?" and, "How large an office building and garage are you building?"

No doubt the board of directors will authorize an open house day after the building is all completed and the office furniture, etc., has been moved in. All the members and the public will then have a chance to inspect our new head-quarters.

As to when we expect to move, that is the sixty-four dollar question although we must say that the contractor is making splendid progress. Our guess is sometime in November. The manager's guess is about the last week in November.

LET US FILL you in on the progress. The roof is all completed, the portico is just completed and the roofers should have been finished with that roof sometime during the week of Aug. 23.

The contractor expected to do the grading around the property sometime during the same week. As soon as grading is completed the firm which will put down the asphalt road and parking lot will start its work. The equipment is now on the premises.

ALL THE PARTITION work in the office is completed as is all partition work in the garage. The four large double doors for truck entrances are up, the electrician is making good progress, the heating plant which is an electric boiler is installed, the cooling system which is a Chrysler Temp unit is being installed by the heating and plumbing people, the plasterer has all the metal lathing up and no doubt will finish plastering about the first week in September, the concrete block partitions are all painted, the people who are installing the drop ceiling are working on that at the present time and all the windows and doors are in the office portion. The big job is hanging lighting fixtures and installing the covering on the concrete floor.

THE VAULT, which is located in the center of the office building, is completed. It is definitely fire-proof with a large fireproof door.

As we stated before, the contractor is making good progress. He is on time. We cannot complain as he has kept his crafts on the job.

The building is located on a 17-acre tract which belongs to your co-operative. However, a portion on the north and on the south side will not be used by the cooperative at the present time, and one of the neighboring farmers will plow this portion. It is understood that he will put alfalfa in both portions.

The center portion around the building and the warehouse will be graded and a portion blacktopped for parking. The circle drive coming in from State Route 3 also will be blacktopped.

AT OUR PRESENT headquarters we do not have a large vault in which to store documents and papers which are valuable to the cooperative. At the new building we have a large vault, and all of this material will be placed in the fire-proof vault.

We also have a night depository in which the members can drop their monthly bills if they so desire. These envelopes will drop into a small fireproof safe which is located inside of the building.

The entire building is modern and fireproof and has sufficient space for expansion. The architects, Weisenstein, Rogers & Hausmann, have done a splendid job in the designing, and the contractor, Buckley Construction Co., is doing a good job of construction. We know that everyone concerned will be pleased after the building is completed and we occupy it.

# Across the manager's desk

As stated in the August issue of Rural Electric News the board of directors has changed your annual meeting from a Saturday afternoon to an evening. This was done so



that some of the members who could never attend an annual meeting due to the time that it was being held will have the opportunity to be present.

Don't forget that we are having local talent for entertainment. In a future is-

On Aug. 25 we mailed capital credits in the amount of \$28,975.52 to members who received electric service from this cooperative during the year 1949. This amount represents the difference between the revenue for that particular year and the expenditures for the year 1949. This difference is being returned to the members who received electric service during that period so that they are receiving their electric service at cost price. What other organization besides REA co-ops can make this statement? "Electricity at cost price."

Interruptions to electric service have been few during the year 1965. However, it is impossible to eliminate all interruptions because we have no way of stopping lightning from hitting our distribution lines, breaking insulators, damaging poles, etc. Our other big enemy on which we have not experienced outages lately is ice storms.

### Co-op Sending Bumper Stickers To Its Members

Each month your cooperative has an ad in one of the newspapers serving our area. Our state organization—the Association of Illinois Electric Cooperatives — also places ads monthly in the daily newspapers, and our national organization—the National Rural Electric Cooperative Association—places ads in magazines.

Why does an electric cooperative advertise? Our answer is to educate and inform its membership and to counteract false impressions about cooperatives and the REA loan program.

SPEAKING OF advertising, each member of this cooperative will receive sometime during the month of September a bumper sticker. This sticker will state that this person is a member of the Monroe County Electric Cooperative and is receiving electricity at cost.


We would appreciate each member placing this sticker on the bumper of his or her automobile. We believe that you should be proud to be a member of an organization which is giving you electric service at cost price.


