High school sophomores or juniors could go on the trip of a lifetime!

What do 1.500 high school students. our nation's capital and electric cooperatives have in common? The Electric Cooperative Youth Tour, of course!

Youth Tour was established with one thought in mind – to inspire our next generation of leaders. Since 1964, more than 50,000 young Americans have taken advantage of this special opportunity offered by their electric cooperative.

It all starts here locally with the Illinois Cooperative Youth Day in April. Corn Belt Energy will sponsor sophomore or junior students from high schools in our service area on an all-expense paid trip to Springfield, Illinois, on Wednesday, April 3, 2019. During the day your students and their counterparts from other Illinois high schools will meet their elected senators and representatives at the Capitol and learn first-hand about the workings of state government.

Then, two "Youth to Washington" representatives will be selected from the contingent that tours Springfield on April 3. The two selected representatives will also receive a weeklong, all-expense paid trip to Washington, D.C. on June 14-21, 2019, when hundreds of electric co-ops across the country send



participants to Washington, D.C., for a chance to learn about the cooperative business model and a full week of sightseeing.

On the tour, students will learn about electric cooperatives, American history and U.S. government. They participate in National Youth Day, visit with their representatives and senators, and explore the sights around the nation's capital. Youth Tour is so much more

than a sightseeing trip. Students have repeatedly shared that this experience has helped them grow into successful professionals. It has also benefited our local communities. Youth Tour participants return home with a deeper understanding and skillset of what it takes to be leader, and as a result, they put these skills to use right here in our community.

In February, Corn Belt Energy will begin the application review process



2019 Nominating Committee meeting scheduled

As an alternative, any active cooperative member may also be nominated for election by petition. Any fifty active members of the Cooperative, by their petition, may propose the name of any qualified member as an additional nominee.

The nominated person must have active service in the Board district of the vacancy, and no other Directors can live in the same township.

Petitions to nominate Directors must be filed at Corn Belt Energy's office no later than Monday, April 22, 2019. The election to fill the Director seats will occur at the Annual Meeting, scheduled for Friday, June 21, 2019, at Central Catholic High School in Bloomington.
