

Process for nomination and election of co-op directors

Shelby Electric Cooperative's 81st Annual Meeting of Members will be held on Friday, June 7, 2019 and will include the election of two directors.

Directors are elected from the cooperative's membership, and any qualified Class A member may seek election to serve as a director.

The cooperative is divided into seven Director Districts, and one director is elected from each Director District. The directors' three-year terms of office are staggered. In 2019, directors will be elected from District 3 and District 6. Although directors are elected from particular Director Districts, all active Class A members may vote in every election.

The qualifications in the cooperative's bylaws to serve as a director are:

- Must be an active Class A member who is a natural person (not a corporation, etc.) and not a person acting in a representative capacity for a Class A member (not a Class A member's guardian, etc.)
- Must be a bona fide resident in the Director District from which he or

she is to be elected

- Must be at least 18 years old
- Must not have completed six or more three-year terms as a director
- Must not be employed by or financially interested in:
 - Any business or enterprise engaged in the sale of any form of energy to the cooperative (other than any form of energy that the cooperative is required by law to purchase) or to any of the cooperative's subsidiaries, members, or consumers
 - Any business or enterprise engaged in the delivery of any form of energy to the cooperative or any of the cooperative's subsidiaries, members, or consumers
 - Any other business or enterprise which is engaged in by the cooperative or its subsidiaries
 - Any business or enterprise primarily engaged in selling electrical appliances, fixtures or supplies to the cooperative or to any of the cooperative's subsidiaries, members, or consumers
- Must not be the incumbent or a

candidate for an elective public office in connection with, which a salary is paid, other than township offices or school offices

- Must, if seeking re-election for a fourth full term, be certified by the National Rural Electric Cooperative Association (NRECA) to have successfully completed a course of training for rural electric cooperative directors.

Nominating petitions (available at the cooperative office) must be signed by 15 or more active Class A members. The petition and a Statement of Qualifications demonstrating that the potential nominee meets the qualifications must be filed at the cooperative office not less than 60 days prior to the annual meeting, i.e., April 8, 2019 at 4 p.m.

A cooperative director is expected to:

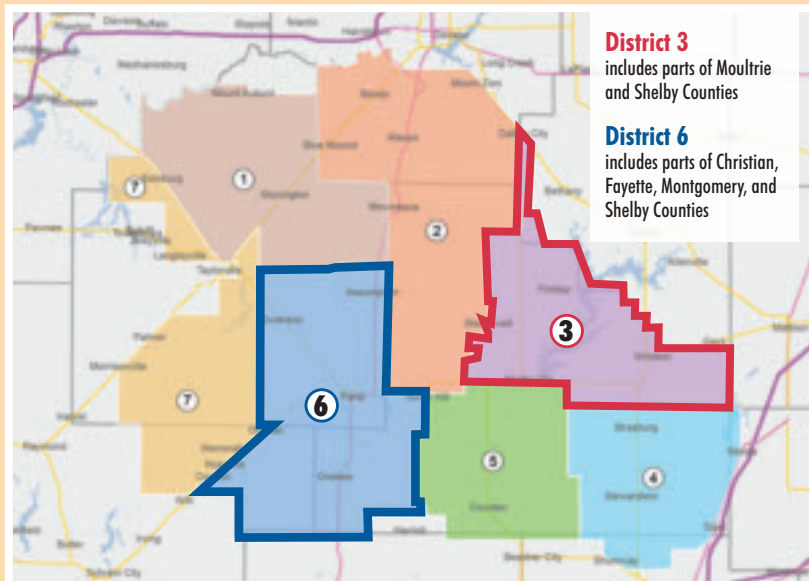
- Attend all monthly board meetings, which generally last from three to five hours
- Attend all special board meetings, committee meetings, and annual meeting of members
- Attend all board meetings of other organizations for which he or she is a director representing Shelby Electric Cooperative
- Complete the NRECA Credentialed Cooperative Director training during the first three-year term of office.

The cooperative's bylaws provide that directors shall be elected by ballot at the annual meeting of members, but the board of directors may determine that an election be conducted exclusively through written ballots submitted by mail or through online internet voting. In recent years, the elections have been conducted by mail.

If the nominating process results in no contested elections, the board of directors may direct the 2019 election to be conducted by ballot at the annual meeting (saving the cooperative approximately \$10,000 in election costs).

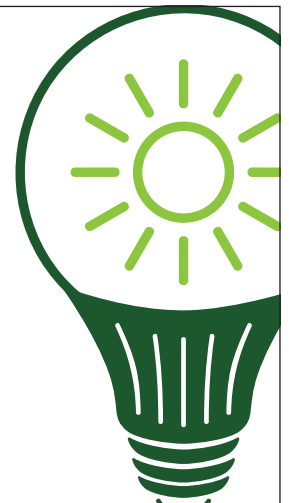

Getting Real with Marla and spring

Daylight Saving Time begins Sunday, March 10, providing an extra hour of daylight to enjoy in the evenings. Technically, the first day of spring is Wednesday, March 20; however, most of us will spring outside the first day the weather cooperates. In the eagerness to get outside, safety should not be overlooked.

March is National Ladder Safety Month. This recognition is aptly timed as a reminder to be vigilant when cleaning gutters or working on other projects requiring a ladder. Safe Electricity recommends keeping ladders and their operators at least 10 feet away from overhead power lines and electrical equipment. Always check for overhead wires before moving ladders or any tall equipment.

Outdoor projects often involve damp surroundings – either the use of water or wet ground conditions. For outdoor projects requiring the use of electrical tools, remember to plug into ground-fault circuit interrupter (GFCI) outlets. These fast-acting circuit breakers are designed to shut off electric power in the event of a ground-fault within as little as 1/40th of a second. If extension cords are needed, make sure they are rated for outdoor use and invest in a portable GFCI. These specialized extension cords are designed for added protection against shocks.

If your spring plans involve landscaping, always remember to **call 811** before you dig! The strategic placement of trees and bushes can be a great benefit to the comfort

and energy efficiency of your home. Deciduous trees should be planted on the south and west sides of your home. They will provide shade during the heat of summer, yet allow the sun's warmth to add heat your home during winter. Evergreens should be planted on the north side of the home to block chilling winter winds. Plant all trees at least 25 feet away from power lines. The Arbor Day Foundation has a helpful website at Arborday.org for more great information. As the Chinese proverb says, "The best time to plant a tree is 20 years ago. The second-best time is now."

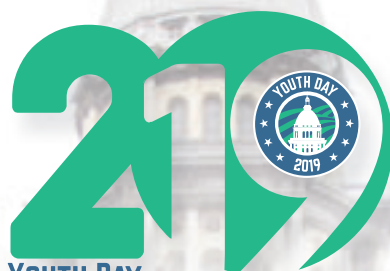

Ways to pay



Pay online – View and pay your bill online with SmartHub web, 24/7, with a checking account or credit/debit card. Visit shelbyelectric.coop and click on the “SmartHub” icon.



SmartHub app – View and pay your bill using this app with your smart phone or smart tablet. The app is available at your favorite app store.



Pay-by-phone – Pay your bill securely by phone 24/7. Call toll free 1-855-385-9981 and follow the automated prompts to pay by check, credit, or debit card.



Automatic draft – credit/debit/checking/savings – Choose an automatic payment deduction from the account of your choice. This is set up as a recurring payment draft on the due date shown on your bill. Sign up by using SmartHub or our automated pay-by-phone line.



Pay by mail – Mail your check along with the stub conveniently located at the bottom of your bill to Shelby Electric Cooperative in the envelope provided with your statement. Please allow 3 to 5 business days for delivery.



Pay in person – Stop by the office in Shelbyville during business hours to pay your bill in person. An after-hours drop box is also available.

How to read your propane gauge

Shelby Energy Company, the cooperative’s LP gas subsidiary, recommends that you learn how to read your tank gauge and develop a habit of checking it on a regular basis.

Look at the gauge attached to the tank with numbers from 5 to 95. Numbers indicate the percentage of gas remaining in the tank. If your tank gauge reads 25 percent or less, call Shelby Energy for a refill at 217-774-2311.
