



Get Ready Set Vote

Director election voting is set for May 20 – June 11. Members will have a choice to vote electronically or by mail. Details will be available on our website, www.cmec.coop, and included in your ballot packet. Survey Ballot Systems, SBS, will mail, tabulate and report election results electronically ensuring integrity and transparency. Carefully follow the instructions when casting your vote.

Our cooperative is divided into seven districts. This year board districts 1 and 7 terms expire. District 1 candidates are Rebecca Moran and Bill Voyles. District 7 is uncontested for Jeffery Hudson; therefore, no ballot voting is required for this district.

on page 20A and 20B. You will need to vote for one candidate in District 1. There are no proposed bylaw amendments for 2019.

Paper ballots will be mailed to all members. Members who wish to vote electronically will be able to vote by accessing the official login page as printed on each ballot. There will also be a direct link to SBS from our web page.

Each membership has one vote and each ballot will have a unique election credential. Reminder emails may be sent out to those members who have an email on file with us. Elections play an important role giving members the power to select leaders and influence the direction of our cooperative. SBS will provide support by phone, email or chat, and their contact information will be listed on the ballot material. If you contact them after business hours, they will contact you the next business day.

ELECTRICAL HAZARDS Power Lines - Always look up and out for power lines. Keep you and your equipment at least 10 feet away from power lines.

5 OUTDOOR

Outdoor outlets – These should be powered by a 2. ground fault circuit interrupter (GFCI), which turns itself off if it senses a current leak or a short circuit.



Pools – Use battery-powered electronics around the pool. Have an electrician inspect your pool, spa or hot tub before the beginning of each swim season to avoid electrical hazards.

Extension Cords - Use extension cords that are rated for outdoor use. Using an indoor cord, which cannot withstand the weather conditions, could result in a shock or fire hazard.



Electric Garden Tools - Never use electric garden tools in wet or damp conditions. Check for cracked or frayed cords before use and replace if damaged.

President & CEO Report – February 2019

CONNECT

- 419 Current Customers
- CMEC Connect experienced a major outage this past month. While this was a long process, CMEC Connect team did a great job working together and getting everyone back on. About 45 people were affected.
- Irby was here Jan. 21-25, 2019 for ring upgrades and small tower repairs.

Marketing/Member Services

- CMEC staff member Sam Adair attended the CBA Marketing Meeting. This is the CBA's 20th year.
- CMEC participated in the EIU Science Festival. This was our first year participating in this event. We showcased our GIS and IT department at this show.
- CMEC participated in the LLC career fair. This event attracts around 750 area grade school students.

Key Accounts

CMEC staff member Sam Adair met with a few large power accounts this month.

Safety

- CMEC Safety Committee met on Feb. 8 for our monthly meeting.
- CMEC employees and staff met with the AIEC on Feb. 15. All employees were given first aid and bloodborne pathogens training as well as AED training.
- CMEC Safety Committee continues to move toward finishing the safety manual for CMEC and hopes to be completed by the end of February.
- Sam Adair and Bob Schafer spoke on the WTIM radio show about electrical safety. This is a directed effort from the Safety Committee to better educate members on safety around power lines.
- 2,247 Facebook followers.

Accounting/Finance

Continuing work on year end processes and audit preparation. Reviewing member policies that affect the member services/billing area.

LED Lighting

■ To date, (2,207) LED lights installed replacing (443) mercury vapor and (1,673) sodium vapor lights.

Engineering

- Manual meter reads decreased from 53 to 45 for February.
- Engineering received requests for 140 JULIE locates and called in 43. Of the 140 notifications, CMEC personnel performed nine primary and 11 secondary locates.
- 17 Report-On-Calls were received and assigned for member/new member requests.
- Field engineers are working on the following projects: U3BA mile (moving a line out of ROW that is extremely rough to traverse), L3A1 mile (relocating line from a field to the road for access since the poles in the field need replaced), W4-2 mile (replacing a one mile stretch of underground with OH conductor).
- Field engineers generated 33 work orders for the month of February, of which 20 were O&M pole replacements.
- Field engineers began training with the GIS Dept to perform distribution system updates that can be directly input into the GIS map. The updates are nearly complete.
- We began a thorough review of member policies.

Operations

In February, crews performed the following work: (3) new services,
(1) service upgrade, (1) retirement,
(4) system improvement, (63) pole replacements due to age (2), O&M (59), weather (1), relocation (1).

Fleet

Received a demo digger truck from Altec to be used at no charge until the new one arrives.

IT/SCADA

- Continuing work on software updates on office computers that PPI has suggested to help eliminate known vulnerabilities.
- Continuing work on creating new SCADA user interfaces.
- Working on SCADA pilot project network setup.
- Working with Trilliant and PPI on the NEMS server transfer. After the transfer all CMEC office, GIS, and

AMI servers will be redundant, fully backed up, and on the PPI cloud.

- The Barracuda Email filtering system is now setup and running.
- Working on office PC upgrades.
- Began coordinating with the city of Sullivan on their new AMI project. The radio frequencies for the city are near the existing ones that Trilliant uses to transmit data.
- David Welsh and Jim Wallace met with Southwestern Electric Cooperative in Greenville to discuss their experience with NovaTech, the company that we intend to go with for the SCADA build.

GIS

In February, Shaun Vester continued to train the field engineers on how to input data into the GIS. Shaun also continued work on developing our new staking software. Lastly, Jim Wallace and Shaun were interviewed at NRECA about our GIS system.
