



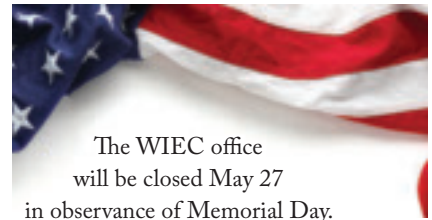
David Peer joins WIEC

**5 OUTDOOR
ELECTRICAL HAZARDS**



1. Power Lines – Always look up and out for power lines. Keep you and your equipment at least 10 feet away from power lines.

2. Outdoor outlets – These should be powered by a ground fault circuit interrupter (GFCI), which turns itself off if it senses a current leak or a short circuit.



3. Pools – Use battery-powered electronics around the pool. Have an electrician inspect your pool, spa or hot tub before the beginning of each swim season to avoid electrical hazards.



4. Extension Cords – Use extension cords that are rated for outdoor use. Using an indoor cord, which cannot withstand the weather conditions, could result in a shock or fire hazard.



5. Electric Garden Tools – Never use electric garden tools in wet or damp conditions. Check for cracked or frayed cords before use and replace if damaged.

Electric Cooperative Lobby Day

Ninety Illinois electric cooperative directors, managers and staff visited the Illinois State Capitol on Wednesday, March 20 to fly the co-op flag and build important relationships with their local legislators. Representing Western Illinois Electrical Coop. at Electric Cooperative Lobby Day were Manager Todd Grotts and William Newton, director. They spoke with Representative Randy Frese and Representative Norine Hammond whose districts include their co-op territory regarding issues of importance to electric cooperative members. They (6616-5) discussed various pieces of legislation currently being debated in Springfield, sharing how those proposals could impact cooperatives and their members. This included the various energy proposals that have

been filed, Senate Bill 1304/House Bill 1633 which would expand criminal penalties for damage to critical

infrastructure facilities and Senate Bill 1304/House Bill 2839 on administrative decision review.

Security lights

**A small price to pay
for home safety and
security**

As you drive around the countryside at night, security lights dot the horizon. Each security light is added safety and protection to the farm or home it illuminates. A well-lit yard or residence provides:

- Safety – to avoid injury when outside in the yard after dark
- Security – to help deter prowlers and varmints, discourage vandals and welcome you home to a lighted yard
- Productivity – a little extra “day-light” can be very valuable when it gets dark so early in the winter months

WIEC is offering LED lights to our members, either for rent or for purchase. Although the LED lights cost more, they do last longer, use much less electricity and are more durable than their predecessors. They do not contain a gas or an element of any kind. Instead, the entire LED is made up of a semiconductor; which is solid in nature and makes LEDs more durable. LED achieves full illumination immediately. They have an estimated lifespan of almost 50,000 hours, which works out to about 11 years (working 12 hours a day). **(6532-78)** All this will reduce the repair and maintenance costs WIEC incur.

The replacement LED lights will have a bright white light instead of the amber color of the previous high-pressure sodium lights. The pricing for the LED security lights is below.

40W LED Rental Costs:

\$5/month—Member pays for electricity; WIEC maintains lights

\$10/month – WIEC pays for electricity and maintenance

\$289 plus tax – Purchase the light with free installation

Either way you choose, a security light can be very useful as it lights your way around your home or farm.
