We've improved your usage management tools!

Are you looking to view your usage and weather trends by month or even by day? Go to Clinton County Electric's website, www.cceci.com, log into SmartHub, click start now under the View and Manage My Usage box and select a tool.

The Usage Explorer tool provides a detailed look at your past and present usage all in one place. The Average Usage tool shows your typical or average usage for the selected time period. Finally, the Usage Comparison tool lets you compare two bills of usage history side by side.

Please keep in mind, some of the information can only be viewed from the time the Automated

Metering System (AMI) was installed. Clinton County Electric started installing AMI back in August 2018 and finished the project in December 2018.

Always assume a downed power line is deadly

Overhead power lines carry thousands of volts of electricity. If a line is down, always assume it is energized and dangerous, even if the power is out in your area. Touching or getting near a live power line injures and kills.

Never approach an accident scene where a line is down or damaged. If you run toward the accident to help, you too could become a victim by entering the energized area.

Power lines can come down or sag close to the ground for a few reasons: severe weather or damage due to a car accident, for instance. And a downed line isn't always visible. After severe weather, lines can lurk underneath water or debris.

Stay clear of all types of utility lines. Even if you think lines might be

designated for telephone or cable service, they may have contact with damaged and energized power lines nearby. **Safe Electricity** and **Clinton County Electric Cooperative** offer these additional safety reminders:

- Call 9-1-1 to report fallen or damaged power lines.
- Power lines do not have to be arcing or sparking or making a humming noise to be live.
- Do not attempt to move a downed line or anything it is touching with another object such as a stick or pole. Even materials that don't normally conduct electricity can do so if they are slightly wet.
- Do not step in water or walk in debris near a downed power line.
- Stay at least 10 feet away from the downed power line.

- Do not attempt to drive over a downed power line.
- If a power line falls on your vehicle while driving, do not attempt to drive away or get out. Call for help and **STAY INSIDE THE VEHICLE** until utility crews say it is safe to get out. If there is a fire or you smell gasoline, hop out without touching the vehicle at the same time and **DO NOT WALK**, but hop away to safety.
- Line properties can change: Any power line that is dead could become energized at any moment due to power restoration or back feed from backup generators.

Always consider all lines, regardless of the type, energized at deadly voltages. For more information about electrical safety, visit SafeElectricity.org.

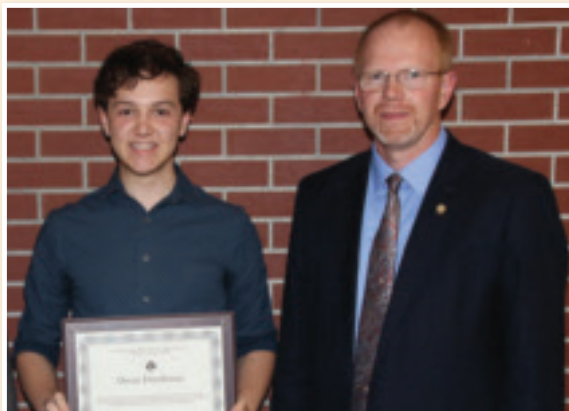
\$2,000 Thomas H. Moore Scholarship awarded

Owen Henderson, a 2019 graduate of Wesclin High School, has been selected as a recipient of the Thomas H. Moore Illinois Electric Cooperatives (IEC) Scholarship. Owen is the son of Hank and Laurie Henderson of Trenton, Clinton County Electric Cooperative members, and will be attending the University of Illinois Urbana-Champaign in the fall to study journalism. Henderson was selected from among 316 applicants.

The Thomas H. Moore IEC Memorial Scholarship Fund was established in 1994 to provide financial assistance to deserving students. Applicants must be high school seniors who plan to enroll full-time at an accredited two- or four-year college, university or vocational/technical school in Illinois. Scholarships are based on grade point average, college entrance test scores, work and

volunteer experience and participation in school and community activities.

Each year, 12 \$2,000 scholarships are awarded to Illinois students who are sons or daughters of cooperative members, directors and/or employees. Six scholarships are given to students enrolling at a four-year institution; four are reserved for those enrolling in a two-year Illinois community college; one (the Earl W. Struck Memorial Scholarship) is awarded to the son or daughter of an Illinois electric cooperative employee or director; and the LaVern and Nola McEntire Lineworker's Scholarship is presented to a student to attend the lineworker's school conducted by

Considering Solar? Call us first!

As interest in “green” energy and ways to save money on utility bills continue to grow, some cooperative members may be considering the installation of a solar array.

Since these types of systems have the capability of returning electricity back to the electric grid, there are some major safety considerations to sort through before a system is installed.

Before deciding to buy a solar array, examine the economics to determine if such a system will lower your monthly electricity costs. If you do decide to install a solar array, contact our office as early as possible in the process.

A CCEC representative will provide information on our interconnection process and policies, as well as answer any questions you may have. That way, you and your installer will have the information needed as you progress with your system.
