Insulating Your Attic Is Like a Stocking Cap for Your Home

As you add a fuzzy hat, scarf and gloves to your wardrobe to stay warm this winter, remember to prepare vour home for cold temperatures as well. Proper home insulation is an important step to save money on your energy bill and make you comfortable in your home as temperatures dip below freezing.

If your home feels drafty and could use more insulation, always start at the top since most heat loss is through the roof. Start with the attic or ceiling and work your way down through the walls and then to the basement or crawl space. If you start adding insulation at the lowest level (basement or crawl) and work your way up, upper floors could feel cool or drafty in the winter months since extra insulation below will cause the cool air to rise.

While addressing your home's insulation is one of the more expensive outlays you can make to save on your utility bill, it's the biggest bang for your energy buck, paying for itself in the long run.

Safe Electricity offers other ways to help reduce energy costs this winter:

 Caulk windows and door frames that leak air, and replace or update door seals if they are old or ineffective.

- Bundle up and turn down your thermostat. For every degree turned down, you can save up to 3 percent on your energy bill.
- If you do use a portable space heater, use it judiciously as well as safely. Using one for long lengths of time can cause your energy bill to spike since it draws so much power to run. If you use it continuously, it can add \$100 or more to your monthly energy bill. Space heaters touted as energy efficient aren't necessarily so; they may just cycle off more
- If you can, turn down your water heater a few degrees - 120 degrees or less is recommended. especially with small children to prevent accidental scalds.

President and CEO

- Amy Borntrager and Carla Bradbury met with Sarah Bush Lincoln Health Center to present a donation to the cancer center.
- Amy Borntrager attended NRUCFC's Independent Borrowers Executive Summit
- Coles-Moultrie Electric has a meeting scheduled with Prairie Power, Inc in January to discuss our net-generation policies. We will bring those board polices back to the board with any changes.
- Amy Borntrager and Sam Adair attended a dinner to honor the Cooperative Balloon Associates 20th Anniversary in Normal, IL.
- Amy Borntrager met with Lake Land Community Foundation to meet Jackie Joines successor and discuss scholarship donations for 2020.
- Amy Borntrager, Anita Hoene and Sandra Fisher attended the Our Town Community Update Breakfast in Charleston where there was a presentation from the United States Census Bureau regarding the 2020 Census.
- Coles-Moultrie Electric Cooperative Day coordinated through Coles-Together, Sam Adair, Anita Hoene. Jim Wallace, David Welsh, Shaun Vester and Amy Borntrager gave departmental presentations to 180 Mattoon High School students. Lake Land College partnered with CMEC for this event to help educate these students about jobs, careers and training available here in our community. - IRBY chose CMEC's Connect to be the location for one of its beta test sites for some new aged equipment. We installed the equipment at no cost to CMEC for testing. If the equipment works out the way it is intended CMEC will have the option to buy this to continue to serve its members in the South Shores area in Sullivan.

Operations and Engineering

- Jim Wallace met with Cooperative Response Center (CRC) to discuss the performance of CRC and the services they provide. This will be a quarterly call that is intended to keep communication lines open to discuss ongoing issues with the afterhours dispatch service they currently conduct for CMEC.
- Jim Wallace and David Welsh attended the Cooperative Technical Conference in Noblesville, IN. This is a joint effort by the Illinois and Indiana Statewide Associations to address and discuss IT and Engineering issues facing electric cooperatives today.
- Accounting and engineering met to improve the method of coding for work performed in order to track progress of the 4 Year Construction Work Plan. It will provide a more streamlined process to track annual progress as well as a total for the full 4 -year process.
- Operations, Engineering, Accounting, IT, HR and the CEO met with representatives of Toth & Associates, our engineering consulting firm to lay out the foundation for the 4 Year Construction Work Plan (2020-2023). This plan will provide the roadmap for improvements to the distribution system over the next four years as well as provide budget guidance for

- preparation of the annual operating budget.
- A document detailing the process for rubber gloving has been presented to IBEW Local 702 for review. Upon approval of the document, the cooperative plans to proceed with pursuing a Letter of Agreement with Local 702 to integrate rubber gloving with other work practices in use today in the maintenance and construction of the distribution system.
- A temporary service was connected in the Coles Centre Business Park to supply service to the office trailer on site at the Hilton Garden Inn construction site.
- The infrastructure extension in Coles Centre has been installed to the HSHS Medical facility. Engineering is now coordinating with the general contractor to install the permanent service.
- Engineering has been contacted about temporary service to the Blue Cross

- Blue Shield construction site, also in Coles Centre.
- Substation testing for the Fall took place during the last week of October. The tests went well. Substations tested were Union Center, South Mattoon. and East Charleston.
- Operations will be coordinating with PPI in the near future to replace the 69 kV switches that feed Fairgrange and Fast Charleston Substations. This should be the last of the switches to be replaced.

Accounting and Finance

- · Sandra Fisher and Aimee Boswell are preparing for the retirement of capital credits for the years 1980-1982. There were 3,967 checks mailed totaling \$1,107,499.
- · Accounting has begun collecting estimates for income and expenditures to create the 2020 CMEC Operating Budget. We will plan to present this to the Board of Directors in the

- December meeting which will be held in January.
- We continue to address the accounting processes and procedures for the CONNECT business.
- Sandra Fisher and Aimee Boswell attended a Sales and Use Tax workshop in Urbana, IL.

Human Resources

- We have currently posted for the CFO position on Facebook, Indeed and Cooperative.com.
- We met with all employees regarding the updated vacation policy, which now includes our practices in the policy.
