



Harvest Safety

Prepare Ahead

- Know the location of guy wires while not energized, if hit or damaged these wires could bring down power lines.
- Look up and around for electric lines and ensure equipment will stay a minimum of 10 feet away - inspect farm equipment heights now for clearance.
- If you see a sagging or low power line, contact us.

During Harvest

• Use a spotter when operating large machinery near lines, set extensions to lowest setting before moving, and use care when extending augers or raising truck beds.

- If the machinery you are operating makes contact with a power line, stay on the equipment. Immediately call 9-1-1, warn others to stay away and wait for the utility crew to cut the
- If you need to exit the vehicle after contact is made jump off with your feet together and without touching the ground and machinery at the same time. Then, still keeping your feet together, hop to safety as you leave the area.

Pineapple Surprise



1 box white angel food cake mix 1 can crushed pineapple in juice, undrained

Heat oven to 350 F. In a large bowl beat dry angel food cake mix and crushed pineapple on low speed 30 seconds; beat on medium speed 1 minute. Pour into ungreased 10-inch tube pan. Bake 40-45 minutes or until deep golden brown. Cool completely upside down as directed on cake mix box, about 2 hours. Run a knife around the edges and turn cooled cake out onto serving plate. Cut into slices using a serrated knife. Store covered in refrigerator.

Tiger Bars

2 cups flour 1 tablespoon baking powder 1 teaspoon salt

1/2 cup shortening

1 cup sugar 1/2 cup packed brown sugar

1 teaspoon vanilla

2 eggs

1 cup banana slices (approx. 2 bananas) Chocolate syrup



Heat oven to 350 F. Sift together flour, baking powder and salt. In a separate bowl cream shortening, sugar and brown sugar. Blend in vanilla. Beat in eggs. Blend in 1 cup of flour mixture and beat 1 minute at medium speed. Add bananas and mix on high until smooth. Stir in rest of flour mixture and beat 2 minutes. Spread in 11x16 jelly roll pan. Drip chocolate syrup diagonally over cake then use a knife to move through cake the opposite direction to get a marbled look. Bake 35-40 minutes. Cool 1 hour.
