Close or lower window coverings during the heat of the day

## Don't fall victim to utility scams

Every day, millions of Americans are targeted by scammers through phone calls, emails, text messages, online or in person. Scammers' tactics can change daily, which is why it's important for consumers to stay on top of the latest scam reports from local and national news outlets, as well as your local utility companies. In many cases, co-op members are targeted through a phone scam where the scammers demanded immediate payment and threatened to shut off power if the money was not received. Remember, Clinton County Electric Cooperative (CCEC) will never call you and demand immediate payment without notice.

We want you to be aware of two trending scam tactics. One is the overpayment trick, where a scammer contacts you and claims that you have overpaid your utility bill. The scammer will say they need your personal banking information to deposit the credit back to your checking account. Don't fall for this scam! If you make an overpayment on your energy bill, CCEC will automatically apply the credit to your account, which will carry over to your next billing cycle. Another trending scam is smishing (short for SMS phishing). Many

consumers know to watch out for suspicious emails, but we tend to trust text messages sent to our smartphones. Always question suspicious texts, especially from someone claiming to represent a utility. These are just a couple examples of trending scams, so it's important to watch for any red flags.

Here are a few reminders on how to take control of the situation when you've been targeted by a scammer:

- Take your time. Utility scammers try to create a sense of urgency so that you'll act fast and hand over personal information, especially over the phone. Take a moment to think about the situation before acting.
- Be suspicious. Scammers typically request immediate payments through prepaid debit cards or thirdparty apps. Unusual requests like this should raise red flags. Remember, if the request seems strange and out of the ordinary, you're likely being targeted by a scammer.
- Confirm before you act. If you're contacted by someone claiming to represent CCEC or another utility but you're unsure, just hang up the

phone and call the utility directly. You can reach us at 1-800-526-7282 to verify the situation.

Our increasingly connected world provides scammers with more opportunities to connect with unsuspecting consumers. Be vigilant, and please report any utility scams to CCEC so we can let others in our community know. Together, we can help prevent our friends and neighbors from being victimized.

During summer months, run large appliances that emit heat (like clothes dryers and dishwashers) during the evening when it's cooler. This will minimize indoor heat during the day when outdoor temperatures are highest.



# Considering Solar? Call us first!

As interest in "green" energy and ways to save money on utility bills continue to grow, some cooperative members may be considering the installation of a solar array.

Since these types of systems have the capability of returning electricity back to the electric grid, there are some major safety considerations to sort through before a system is installed.

Before deciding to buy a solar array, examine the economics to determine if such a system will lower your monthly electricity costs. If you do decide to install a solar array, contact our office as early as possible in the process.

A CCEC representative will provide information on our interconnection process and policies, as well as answer any questions you may have. That way, you and your installer will have the information needed as you progress with your system.
