They competed against teams from across Illinois in events using skills that focus on agility, speed and accuracy. While these skills are part of the judging criteria, above all, participants are judged on safe work practices.



The rodeo highlights the skills linemen use to work safely and efficiently. Line personnel competed in five team and individual events: a 40-foot climb, hurt man rescue, H-structure obstacle course, transformer banking and a head-to-head climbing challenge. Scores for each event are based on completion time, proper execution of the task and safety. Deductions were made to a team or individual's overall performance score due to mistakes such as slipping when climbing poles, dropping tools or executing inappropriate procedures or methods. Dravton Davis, pictured left, received second place in the H-structure obstacle course.

Line Foreman Bill Hart, pictured on right, was awarded the AIEC Individual Leadership Award. Nominated by his peers,

# Fourteen scholarships available for co-op family members

### **Board updates RECC's renewable energy policy**



The maximum size of eligible renewable systems that can be connected under RECC's Net-Metering Policy will remain at 10 kW DC. The total capacity of all wind, solar and other renewable source that can be connected to our system has increased from 3 to 5 percent of RECC's annual peak demand (1,280 kW). Our Net-Metering and Interconnection Policies are available on recc.coop.
