#### Questions from the annual meeting

Thank you to everyone who attended our 2022 Annual Meeting of Members, watched the livestream or listened on the radio. It was great to be able to visit with many of you who attended the June 2 event in Fulton.

We received some great questions from those in attendance and in advance of the meeting. The majority of the questions could be placed in four categories (incentives, fiber, energy prices and renewables).

Below are general responses to your questions. For individuals who submitted specific questions, we will provide you responses directly via email or mail.

#### Any rebates for upgrading appliances?

Jo-Carroll Energy offers incentives for ENERGY STAR rated appliances. A full list of incentives, available through Jo-Carroll Energy, can be found on our website. I strongly suggest that you contact John Scott, Jo-Carroll Energy's Energy Detective, to discuss other ways you may be able to reduce consumption through energy conservation and energy efficiency measures.

#### How soon before we receive fiber?

I would first like to thank you for your patience. For those of you in awarded grant areas, within 4 years. Our goal is to provide fiber to everyone who wants it within 7 years. This timeline is

possible as long as certain grants qualify and we are successfully awarded those grants.

Currently, the largest grant opportunities are releasing final rules and other details as we speak. We are engaged, watching closely, and prepared to apply for any feasible opportunities.

Timing will depend on grant schedules and you submitting interest via our website at connectsp.com where you can also follow our progress in your area.

## I'm hearing on the news that energy prices are going up. How is that going to affect my bill?

Our goal is to curb rate increases at or below inflation. Just like you, we are facing increasing inflationary pressure on our materials and energy costs. We are committed to containing costs as much as possible while maintaining your safety and providing the reliability that you expect.

To maintain fair and equitable rates between rate classes, we use a thirdparty consultant to assess the cost of service (COS) for the Jo-Carroll electric service territory. Fixed and demand charges cover expenses such as power

April 27, 2022

The regular board meeting of Jo-Carroll Energy, Inc. (NFP) was held on Wednesday, April 27, 2022.

A Safety Moment was provided by Director Russ Holesinger on how to live in the moment by slowing down, look at your surroundings and don't be in a rush.

Approval of Agenda – A motion was made, seconded, and carried unanimously to approve the agenda.

Consent Agenda – A motion was made, seconded, and carried unanimously to approve the consent agenda.

#### **Board Issues and Action Items**

2021 Margin Allocations – A motion was made, seconded, and carried unanimously to approve the 2021 Margin Allocations.

Policy 815 Online Backup – A motion was made, seconded, and carried unanimously to approve Policy 815 Online Backup.

Select Dairyland Power Cooperative (DPC) Annual Meeting Attendees (note that all director attendees will be considered as voting delegates) - Attendees were selected to attend the DPC Annual Meeting.

Certification of Director and Alternate Director to Serve on the DPC Board of Directors - A motion was made, seconded, and carried unanimously to nominate Director Joe Mattingley as the Director and Director Dan Tindell as the Alternate Director to serve on the DPC board of directors.

Certification of Candidates for Director/ Alternate Director to Serve on the Prairie Power, Inc. (PPI) Board of Directors - A motion was made, seconded, and carried unanimously to nominate Mike Casper and Bob Kuhns as Directors, and Marcy Stanger as the Alternate Director to serve on the PPI board of Directors.

#### Designation of Voting Delegate and Alternate Delegate for PPI Annual Meeting

- A motion was made, seconded, and carried unanimously to designate Bob Kuhns as the Voting Delegate and Marcy Stanger to serve as the Alternate voting delegate for the PPI Annual Meeting.

Certification of Voting Delegate/Alternate for CFC 2022 Annual Meeting (June 20) - A motion was made, seconded, and carried unanimously to designate Marcy Stanger to serve as the voting delegate and Dan Tindell to serve as the alternate voting delegate for the Cooperative Finance Corporation (CFC) Annual Meeting.

Designation of Voting Delegate/Alternate for Cooperative Response Center, Inc. (CRC) 2022 Board of Directors Election (held in conjunction with CFC Annual Meeting) - A motion was made, seconded, and carried unanimously to designate Dan Tindell to serve as the voting delegate and Marcy Stanger to serve as the alternate voting delegate for the CRC 2022 Board of Directors Election.

Select Association of Illinois Electric Cooperatives (AIEC) Annual Meeting Attendees (July 28-30) - Attendees were selected for the AIEC Annual Meeting.

Certification of Delegate/Alternate Delegate to serve on the AIEC Board of Directors - A motion was made, seconded, and carried unanimously to nominate Director Senn as the Director and Pat Smith as the Alternate Director to serve on the AIEC board of directors.

Select Attendees for National Rural Electric Cooperative Association (NRECA) BLC Course 971/Coop Governance – Attendees were selected to attend the NRECA BLC Course 971/Coop Governance.

#### **CEO/Financial Operating Report**

**CEO Report** – President and CEO Casper reported that he recently participated on a NRECA CEO panel and provided highlights from the discussion. Casper also reported that the financial team is developing a natural gas procurement dashboard.

Financial Operating Report -Chuck Woods, Chief Financial Officer provided a summary of the financial operating report for March. Revenue for March is approximately \$18 million vs. a budgeted amount of approximately \$17.6 million. Total operations and maintenance expenses were approximately \$662,669 under budget. Margins are approximately \$2.4 million vs. a budgeted amount of approximately \$972,167. By general consent, the board moved to file the financial operating report with the auditor.

#### **Operations and Regulatory/ Legislative Update**

Operations Update - Chief Operating Officer, Kyle Buros, commented on the progress of broadband/fiber expansion. Buros also provided an update on material lead times.

#### Grant and Employee Update -

V.P. of Human Resources, Merri Sevey, provided information on the Co-Bank Matching Grant Program that Jo-Carroll Energy partners with. In addition, Sevey introduced Alex Peebles, Manager of Safety and Loss Control to the board, noting that he is doing an excellent job keeping the employees up to date with training and managing day to day safety policies and procedures.

Strategic Plan - V.P. of Member Services, Jennifer Meyer, provided an update on the 2022 Strategic Plan, which included its current progress and metrics.

External Affairs/Legislative Update - Terry Kurt, Outside General Counsel, shared that he will be working from Jo-Carroll's Elizabeth office on Wednesday's. He also announced that he has been elected as President of the Jo Daviess County Bar Association.

Governance Topics and Board Policy Review - None.

#### Reports/Updates

#### Association of Illinois Electric Cooperatives (AIEC) Report -

Director Senn commented on the Climate and Equitable Jobs Act (CEJA) trailer bill, which included six components as Amendment 4. Casper added that none of the six components will directly impact Jo-Carroll members or other Illinois electric cooperative members.

American Public Gas Association (APGA) Report - Director Carroll discussed the various topics within the natural gas (NG) industry including factors affecting NG prices. Carroll noted that the APGA recently met with the United States Department of Transportation to discuss enhanced cyber security efforts. Casper added that internally, Jo-Carroll has performed tabletop exercises to prepare for possible cyber security threats.

#### **Dairyland Power Cooperative**

(DPC) - Director Mattingley provided highlights from the April DPC board meeting and noted that they approved elimination of the flat rate wholesale power option, which will not impact Jo-Carroll members. Mattingley also noted that DPC will be bringing an in-house attorney to the cooperative.

#### Prairie Power Incorporated (PPI)

Report - Director Kuhns provided a summary of the PPI Special Board Meeting and generation report.

lines, transformers, trucks, labor and other expenses the cooperative incurs ensuring energy is available when you need it, no matter how much energy is used.

We continue to encourage you to reach out to us if you are concerned about being able to pay your energy bills.

#### Are alternative means of consumer energy (i.e. solar and wind) still eligible for credit?

Renewable Energy Federal Tax Credits are available for geothermal heat pump systems, solar energy systems, and small wind turbines. The renewable energy tax credit is 26 percent through the end of the year (12/31/2022) and then lowers to 22 percent through 12/31/2023.

More information about federal tax credits for renewable energy can be found at energystar.gov or by contacting your tax advisor.

We are also working closely with you and solar contractors with the interconnection of solar.



## **Local agencies receive Sharing Success grants**

o-Carroll Energy recently awarded grants total-Jing \$20,000 to four recipients through the CoBank Sharing Success program.

The cooperative has participated in the CoBank program for several years and received more than 40 applications in 2022.

The Sharing Success program reflects two key principles that guide all co-ops, "Cooperation Among Cooperatives" and "Concern for Community." Last year, the bank increased the annual matching fund and raised the maximum match.

CoBank is a cooperative bank that assists rural America with financial services to agribusiness and rural electricity, water and communication providers in all 50 states. CoBank matches contributions by its cooperative members to the charitable organizations, schools and government organizations that serve a public purpose and are consistent with the program's purpose and guidelines.

Selected to receive Sharing Success grants in the JCE service territory were the following agencies and organizations. The amount noted is the total of the JCE grant plus the CoBank match.

Inspire Continuing Care, Geneseo: \$10,000



Inspire Continued Care provides a daytime community program that allows post-high school young adults with complete special needs to be involved in their local community, answering an unmet need in Geneseo and Henry County.

"ICC is the only local continuing education option for post-high school young adults with multiple diagnosed disabilities and complex social needs," stated Jennifer Johnson in the grant application. "Families have to make difficult decisions about how to ensure their dependent young adults remain socially and emotionally engaged in their communities, rather than confined to their homes ... ICC exists to provide affordable, quality care for these 'uniquely qualified' young adults, facilitating learning opportunities through community-centered programming."

"ICC believes in the right of young adults with unique and complex needs to continue being life-long learners and contributing adult members of their community through experiencing a wide variety of activities that introduce and reinforce essential life skills."

ICC is a private, nonprofit organization that does not receive any state or federal funding. The program opened its doors in August 2021. The goal is to increase participation to include all young adults in need of ICC's services, regardless of their ability to pay.

ICC participants become contributing members in the community as they visit the local grocery store, bank, post office and engage in community service activities such as delivering a newspaper route, pet walking service, delivering coffee or soft drinks on "Thirsty Thursday" to schoolteachers and staff, hosting a donation site for the food pantry and delivering collected items weekly.

The matching grant funds will be used to provide supervised daytime community opportunities for uniquely qualified young adults in Geneseo and the surrounding Henry County area.

Camp Benson, Mount Carroll: \$5,000



Located on 113 acres outside of Mount Carroll, YMCA Camp Benson's 113-acre campus has been home to countless friendships, life lessons and summertime memories for generations of campers earning the camp a reputation as one of the premier overnight summer camps in Illinois.

"For more than 90 summers, YMCA Camp Benson has provided engaging, positive and life changing overnight summer camp programs for boys and girls ages 6-17. Wewton This has been accomplished through innovative, valuebased programming supervised by experienced and caring staff members in a wonderful natural setting," stated camp director Gwyn Bemis in the grant application. "Summer camp is what we do, and summer camp is who we are."

Sharing Success grant funds will be utilized to purchase programming materials for campers including helmets and harnesses for rope activities, as well as supplies and equipment for arts and crafts, sports and games and water activities.

#### Whiteside County Soil and Water District **Education Fund, Morrison: \$3,000**



An offshoot of the Whiteside County Soil and Water District, the education fund has a goal to provide both youth and adult conservation/environmental education.

In order to obtain the goal, plans are to develop a conservation education center in the western part of Whiteside County, just south of Fulton. The 501(c)3 has acquired a long-term lease on approximately 30 acres of farm ground that has been planted and seeded to native trees.

The grant will be used to administer education programs on the land; a building will eventually be constructed where education activities will be held. Prior to the pandemic, several dozen adult

and youth education seminars were held annually on a variety of conservation topics for 400-500 participants. The grant will help implement the program again.

#### American Legion, Galena: \$2,000



The American Legion is a not-for-profit organization for U.S. war veterans. The legion provides lifechanging assistance and guidance for veterans, military personnel, their families and communities every day. Help is in the form of personal assistance, grants donated good and volunteerism.

The Sharing Success grant will be used for transportation to and from medical appointments and procedures for veterans in need.

You can set your temperature with your voice and receive notifications on your energy usage. As you'd probably expect, it syncs brilliantly with Alexa, though it does not work with Apple's HomeKit or Google Assistant. While it lacks the broad array of features of both the Nest and Ecobee smart thermostats, you may find that the Amazon Smart Thermostat fits your family's needs for the price.

You can be confident that any of the smart thermostats outlined above will help break the summer heat in your home and ease the pain in your wallet!
