If your home is heated through warm-air registers, baseboard heaters or radiators. remember to clean them regularly to boost efficiency.

Keeping Pets and Energy Bills Comfortable

don't know about you, but I consider my four-legged companion part of the family. I know others feel this way, too. That's why during the winter months, we make sure our whole family, including our fourlegged members, is cozy—without taking a big "bite" out of our budget.

This month, I'd like to share a few simple ways you can make your home more comfortable this winter, which can ultimately help you save on energy bills.

At the onset of the cold weather season, we replace the HVAC filter for better air quality and to help the unit operate more efficiently. You can also keep your home cozier by caulking and weatherstripping windows and doors. If your home is particularly chilly, you can tape or affix heavy, clear plastic to the inside of your window frames to create an additional barrier against the cold. Ensure that the plastic is tightly sealed to the frame to help reduce infiltration.

We know winter can be "ruff," so

we set our thermostat at 68 degrees, a "purr-fect" temperature for people and pets. This is especially important for smaller, short hair and senior dogs-not just for warmth, but for their general health. Puppies, kittens and older pets with arthritis or other ailments may have a harder time controlling their body heat and need the additional warmth when it's chilly out.



Pets that sleep close to the floor can be subject to cold drafts that enter your home through windows and exterior doors. If your pet's bed is near a window or door that feels drafty, tightly roll up a towel and place it near the bottom of the door or window to eliminate the draft. Cutting down on cold drafts helps everyone feel more comfortable during colder months.

If possible, elevate your pet's bed so it's not placed directly on a cold floor. An old chair or sofa cushion works well. If you don't use a dog bed, take some old blankets and create a donut shape on the cushion so the dog can snuggle and "nest" within the blanket. You can do the same for cats but on a smaller scale. Blankets enable pets to nestle into them, even when they aren't tired, and provide a comfortable place for dogs and cats to curl up.

During the day, open your blinds and curtains to allow sunlight to warm your home. Close window coverings at night for an added layer of insulation.

Empower children to stay safe outdoors

ccording to the National Institutes of Health, electricity causes approximately 1,000 deaths and 30,000 injuries in the United States each year, 20% of which occur in children. Empower your family with electrical safety knowledge that can potentially save their lives. Always remember that electricity is everywhere, even when playing outdoors, away from screens and other plug-in devices.

Electrical substations may spark a child's imagination with high towers and sprawling gates, but make sure your children know never to enter one for any reason. An adult should call the electrical utility for help if a lost pet or toy enters one.

Always assume that power lines are energized and dangerous. Inform children to stay away from downed or low-hanging power lines and ask them to tell an adult if they see one. The utility company will send a professional to assist.

Children should never play with, climb on or open padmount transformers or outdoor electrical "green" boxes. They contain electrical equipment for underground service to homes and businesses and may be dangerous. If children see a box that is open or damaged, they should stay away from it and tell an adult to contact the utility.

While it may look like fun, never play on a flooded street or in a waterfilled ditch. The water may hide fallen power lines or damaged electrical equipment, which could cause serious injury or death.

Do not plan outdoor activities if a thunderstorm is expected. Wait at least 30 minutes after the last observed clap of thunder or lightning 5323-001 bolt to play outside.

If enjoying the outdoors near water, such as a lake or pool, never use electronics with damp hands or while standing in water.

Kites and other flying devices, such as toy airplanes or drones, should only be used in large, open areas far away from power lines and electrical equipment.
