## **CEO class visits WIEC**

On Feb 19, the Hancock County Creating Entrepreneurial Opportunities (CEO) class visited WIEC. Manager Tommie Long gave the students a brief introduction about WIEC, how we are different than the investor owned utilities and discussed the seven cooperative principles. He also gave a tour of WIEC's office and grounds. There were good questions from the students about our electrical system and how we operate.

Although this is the first year for the CEO program in Hancock County, this program began in Effingham County, Illinois as a way to show students that they don't have to leave the rural area and head to the big cities for jobs. This program plants the seeds of entrepreneurship so these young people have the skills and background necessary to create employment opportunities in their own backyard. The students can explore the possibilities and understand the risks involved. The (6716-40) students are introduced to many businesses, such as WIEC, in Hancock County and talk with area business leaders, many who are CEOs of their own companies.

We are proud of these students and eagerly wait to see what their future holds.

# WIEC's 2015 Allocation of Margins

One of the major differences between a cooperative and an investor-owned utility is that any monies left over after expenses are paid back to the members in the form of capital credits. Each year, WIEC sends notification to our members explaining what their share of the previous year's margins would be. This

year, members will be receiving their Allocation Notice in the mail around the first part of May. This will tell members the dollar amount of the capital credits they have earned for 2015.

Remember, capital credits are held by the cooperative and will be returned to the member when Western Illinois Electrical Coop's board of directors decides that the cooperative is strong enough financially to do so. This is for our members' information only and does not need any action on their part. (561-48) Please do not pay the allocation amount or subtract this amount from the bill. If there are any questions, please call our office.
