Your role in Co-op Nation

There is a reason we say member, not customer

Spoon River is connected to a network of cooperatives. You might be thinking, "Really? How does that work?" Spoon River is a member of the Association of Illinois Electric Cooperatives, www.aiec.coop. We do this to keep in close contact with our 'sister' utilities and to stay up to date on how to best serve you. They are there to assist with local training, legislative issues affecting us in Springfield and when we have a severe outage, we can call on them to assist in getting your electricity back on as soon as possible. This is one of the ways we live up to our seven cooperative principles, which includes "cooperation among cooperatives."

Spoon River is also a member of Prairie Power, Inc., www.ppi.coop. This is the organization that produces the power that we buy at the wholesale level and enables us to provide safe, reliable and efficient power to you at the lowest possible cost. Prairie Power is also a cooperative, and we hold a seat on the organization's Board of Directors to represent your interests.

But wait--there's more! Spoon River is also a member of the National Rural Electric Cooperative Association (NRECA) www.nreca.coop that unites electric cooperatives in the 47 states we serve. NRECA provides important benefits such as representing our interests with federal lawmakers and the Administration (the executive branch of our government). NRECA also provides health and retirement benefits to our employees, as well as training for board members and employees.

NRECA is a member of both the National Cooperative Business Association www.ncba.coop and the International Cooperative Alliance (ICA) www.ica.

coop, which is made up of a wide range of cooperative businesses including those in agriculture, banking (credit unions), health care, housing, purchasing and many others in more than 80 countries. Many of these businesses represent some of the best known global brands in the world.

In 2013, the ICA released the "Blueprint for a Cooperative Decade" designed to promote the cooperative business model as the best way to meet both the economic and social needs of individuals and communities.

The report (which is available for free at www.ica.coop) describes the five key areas that all co-ops emphasize:

- Participation (member engagement)
- Sustainability (how we help our communities prosper)
- Identity (making sure people understand and showcase the cooperative business model)
- Legal Framework (making sure laws and regulations help, not harm our ability to operate for your benefit)
- Capital (ensure we have the money we need to finance our operations)

Member owners like you at Spoon River have a role to play in all of these areas, but it is Participation (member engagement) that is critically important. We strive to have members actively participate in our governance through voting or running for our board of directors.

Back in the early days of Spoon River, we never could have existed without the active participation of all of our members. While technology and reliability have improved, we still need you to be involved. In many ways, it is more important than ever that you feel

77th Annual Meeting of Members

Spoon River Electric Cooperative held its 77th Annual meeting of Members at Canton High School. Members were updated on the organization's financial condition, its system reliability, the results of the director election and pending regulations that could impact future power cost and supply. President/CEO Bill Dodds said there's been no real growth at the co-op, but that it ended 2013 with net margins of \$1,016,412. The cost of power represents more than 54 percent of the co-op's total expenses.

Several years ago, in an effort to trim expenses and improve reliability Spoon River Electric teamed up with McDonough Power Cooperative in Macomb to share the cost of right-of-way clearing. Since then, members in most areas are now experiencing far fewer outages and blinks. Dodds made reference to the Breeds area, saying that he is aware of the unacceptable occurrence of blinks and outages there, and efforts are being made to rectify the situation. Menard Electric Cooperative in Petersburg recently joined with Spoon River and McDonough Power on cost-sharing of right-of-way clearing. Since the program began, the three co-ops have cleared 5,200 miles of line. Dodds said this is an example of co-ops working together.

Dodds also told members there is

great concern among electric co-op leaders regarding future power cost and supply. He said, "Illinois' not-for-profit electric cooperatives support an 'all-of-the-above' energy strategy, one that incorporates natural gas, nuclear, renewable energy, and coal to generate power." This strategy was initially endorsed by President Obama in his January 2012 State of the Union Address, but the U.S. Environmental

Protection Agency (EPA) issued proposed regulations for both new and existing power plants that set tough limits on carbon dioxide emitted from the plants. The regulations mean utilities will be under great pressure to reduce, or eliminate coal altogether as a fuel source. Coal represents 39 percent of the electricity generated in the United States, and if it is eliminated, there is not currently a way to replace it.
