## Southern Illinois Electric Cooperative's 74th annual meeting

Nearly 600 members of Southern Illinois Electric Cooperative (SIEC) attended the co-op's 74th annual meeting. Members learned that 2013 is a financially smooth year, thus far. An announcement was made regarding the upcoming retirement of capital credits toward the end of 2013. The most important message of the evening was that of no anticipated electric rate increase through 2014. Members also heard reports on local and national issues, including many benefits of being a member of a cooperative. Co-op officials spoke about power marketers who may still be contacting members, and shared news of regulatory concerns facing the cooperative. The meeting was held Thursday, August 8 at Shawnee Community College in Ullin.

Board President Carole Kelley of Buncombe reported that safe, reliable electric service remains SIEC's core business and mission. Kelley reminded members that several advancements have been made toward providing reliable power.

"Reliability means each time you flip the switch, you have power," said Kelley. "One specific area of attention within the past several years is our right-of-way maintenance program. While we have removed several trees, we still focus on our responsibility to protect the environment."

Kelley also discussed the co-op's qualified management staff and employees. In 2013, the board of directors engaged in a first time, national executive search for a general manager, to ensure members the best candidate would be hired to guide the co-op in a strong, positive direction. She later introduced the members to SIEC's new General Manager and Executive Vice President Chris Bennett. **Mark Wilson Jones**

Member service was emphasized during Kelley's speech as well. She

explained that throughout the co-op's 75 year history, true member service to its members has evolved. She stressed membership value is what sets a co-op apart from an investor-owned utility.

In conclusion, Kelley announced SIEC's latest member service, the Touchstone Energy Co-op Connections Card program. It is a free, card-based member program designed to deliver discounts at local

and national participating businesses. She asked the members to look for the delivery of the card with their December issue of the Illinois Country Living co-op magazine.

Chris Bennett then gave his first annual meeting speech, addressing three main points to the members – aggregation, capital credits and electric rates. He continued by discussing the letters and calls that members have received from power marketers regarding aggregation.

Bennett explained, “Most experts agree, the low priced deals being made today by Alternative Retail Electric Suppliers (ARES) are temporary and will not last. Electric cooperatives have made long-term plans for reliable electricity sources and stable electric rates. Our future power agreements and solid infrastructure are protecting you from market uncertainty and potential spikes in your energy costs for years to come.”

Bennett compared current ARES “deals” to that of an adjustable rate home mortgage. “The adjustable rate might provide some short-term savings, but when interest rates increase, it could become an unaffordable deal,” said Bennett.

In his closing, he echoed Kelley’s sentiments of membership value. Bennett announced the planned distribution of over \$500,000.00 in capital credits toward the end of 2013 for 1985 to members. He also explained there would be no electric rate increase in 2013 and no expected rate increase in 2014.

“As your new general manager, I plan to make certain our focus is on service and we do not waste your hard-earned money,” stressed Bennett.

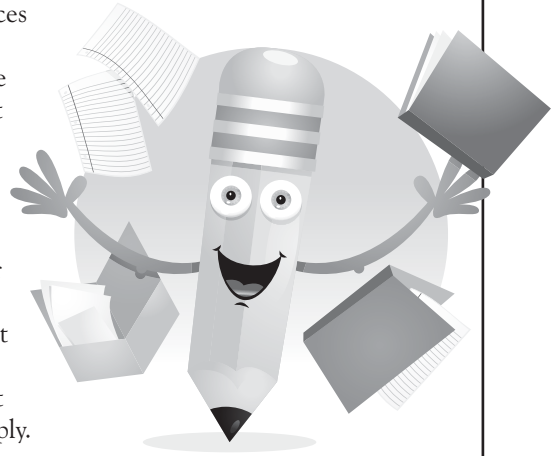
## Apply for your 2013-2014 Touchstone Energy Classroom Empowerment Grants

##### "What is the FACILITY CHARGE on my electric bill statement?"

This is probably one of the most popular questions we receive. If you remember the old rate books (before automated meter reading), this same charge was called the "Minimum Monthly Charge". The facility charge at the top of your line items on your bill statement is for maintaining infrastructure and providing availability of services, and does not include energy consumption charges. It is **not** an additional or new charge. It is not a charge to read your meter. It is just more visible due to our automated bill statements.

# Help our dispatchers provide you better service during power outages!

**S**IEC dispatchers monitor your outage calls 24-hours per day through our automated outage reporting system. There are some simple things you can do to help our dispatchers provide you with better service.

- Make sure your primary telephone number is up-to-date in our records. The primary number we have on file is listed on your monthly bill. This is the number our outage system will key to when you report an outage. If this number is incorrect or if you have recently changed your primary number, please call us to have your records updated. If

you call to report an outage using a different telephone, the system will ask if you know the primary number on your account. You may still enter this number to report your outage.

- Have your 8-digit account number available before calling in your outage. The 8-digit account number is listed on your monthly bill. Some account numbers have leading zeroes, which are important. If the system does not recognize your telephone number or if you have more than one account, you will be prompted to enter your 8-digit account number.

- Do not leave a message unless the system does not recognize your telephone or account information, or unless you know the specific cause of your outage. Not having to listen to messages helps our dispatchers more efficiently get crews out to restore your service.

*Again, SIEC dispatchers monitor your outages calls 24-hours per day through our automated system. This system helps to efficiently group outages by location, and helps our dispatchers serve you better. Each member can help by following the above recommendations.*
