Electronics Recycling, Document Shredding Attract 1,200 to Member Appreciation Day

total of 6.7 tons of electronics had been dropped off for recycling and 2.5 tons of paper had been shredded in less than three hours during the coop's Member Appreciation Day on Sept. 15.

We decided to add these two services to this year's event as a way to provide extra value to our members. Because it was something new, we had no idea what to expect. Both of the companies we worked with warned us that first-time events usually weren't too successful. Well, it didn't take long to realize that our event was go-

ing to be an exception to that rule. A record crowd of more than 1,200 visited our Janesville warehouse on that beautiful Saturday morning.

Fifteen minutes before the event started, vehicles started lining up in our circle driveway, where both the shredding truck was parked and empty pallets were lined up awaiting used electronics. The stream of traffic continued throughout the morning.

We had workers assigned to help members carry their bags and boxes of documents to the shredding truck and unload heavy electronics from vehicles. Every time I took a short break from my duties inside the warehouse and looked outside, I would see another huge TV being hauled from a vehicle. Thank goodness we had some strong guys assisting.

At the end of the event, there were 33 pallets filled with various types of electronics. The final report we received from Universal Recycling Technologies contained astonishing figures. A total of 6.7 tons of electronics had been collected. The bulk of that—4.5 tons—were TVs of various shapes and sizes. The rest were computer towers and monitors, printers, scanners, fax machines,

calculators, phones, radios, stereos, DVD and CD players, VCRs, and other miscellaneous gadgets.

By participating in our recycling event, members helped keep these used electronics out of our community landfills. The items may not be valuable to us anymore because they're broken or obsolete, but the products contain valuable resources. The metals, plastics, and glass used in electronics require energy to mine and manufacture. By recycling electronics and reusing the materials, we are conserving our natural resources as well as reducing the energy demands from mining and manufacturing. For example, the Environmental Protection Agency



estimates that reusing the components of 1 million laptops rather than mining new resources saves enough energy to provide electricity for 3,657 homes for a year.

The document shredding service provided at the event not only helped with recycling, but it also gave members the security of knowing that their personal information would not fall into the wrong hands. The Federal Trade Commission estimates that as many as 9 million Americans become identity theft victims each year. Research shows that most identity thieves obtain information through traditional paper-based sources rather than electronic channels.

Members who brought their documents to the event

don't have to worry about becoming the next victim. As documents were brought to the Shred-it truck, a company employee fed the paper into an industrial-sized shred-der and the information was immediately destroyed. The shredded paper then is bundled and recycled into other paper products.

The EPA estimates that by recycling 1 ton of paper, we save 17 trees, 7,000 gallons of water, 463 gallons of oil, 3 cubic yards of landfill space, and enough energy to heat an average home for six months. All that, and we protected our identities.

Because electronics recycling and document shredding proved to be so popular, we plan to offer both services again next year.

But Member Appreciation Day was about more than just old electronics and documents. The annual event gives the employees and directors an opportunity to express their gratitude to our great members and allows us all to have some fun together. The kids enjoy jumping in the bounce house and shaking CFL Charlie's hand, while people of all ages like watching the amazing jugglers and riding high up in the sky in a bucket truck.

And we can't forget the pancakes. The chefs from Chris Cakes did another great job of preparing the meal and entertaining the crowd as they flipped pancakes right onto members' plates. Their system for dispensing the batter onto the long grills allows them to make thousands of pancakes in short order.

On behalf of all the employees and directors, I want to thank the people who attended Member Appreciation Day. I personally always appreciate the opportunity to walk from table to table and visit with our members.

I especially enjoyed chatting with Don Russell and



his wife, Mary, who live off Highway 51 north of Janesville and have been on our lines since the beginning. Don dug deep into his closet to find an old Rock County Electric Cooperative cap with the Willie Wiredhand mascot on it. Our crews tell me the Russells would always bring them something to eat when-



ever they had a service call at their place.

Energy Assistance Available for Low-Income Households

For many Illinois households, energy costs place a severe and continuing stress on the family's budget. In some cases, families will be forced to make painful decisions about which bills to pay and which necessities to cut.

The federally funded Low Income Home Energy Assistance Program (LIHEAP) helps eligible low-income households pay for winter energy services. Fortunately, Rock Energy Cooperative works with LIHEAP, which benefits about 300,000 Illinois households each year.

LIHEAP Details

LIHEAP heat and electric assistance is a one-time benefit payment per heating season that is intended to help pay a portion of a household's heat and electric costs. The benefit amount depends on household size, income, and energy costs.

In most cases, the benefit is applied as a credit directly to the household's Rock Energy account. You do not need to duplicate your efforts by applying for assistance with both your local agency and Rock Energy. We will send you a letter about one month after receiving your application that will include details on your assistance status and dollar amounts.

You are eligible for heating assistance if your household's combined income is at or below the levels shown on this chart:

Weatherization Services

When you apply for energy assistance, the local agency also will see if you qualify for the Weatherization Assistance Program, which helps fund energy efficiency home improvement projects. If you are eligible for weatherization services, an energy auditor will look at your home to see what can be done to make it more energy efficient. Weatherization services differ with each home, depending on how it was built and its condition.
