What is a kWh?

A kilowatt-hour (kWh) is the standard unit of measure for electricity use and is equal to 1,000 watt-hours. For example, a 100-watt light bulb running for one hour uses one tenth of a kWh. If electricity costs 10 cents per kWh, it costs one cent per hour to operate that bulb. Remote Reconnect or Disconnect

CMEC utilizes available technology that allows us to disconnect and/or reconnect your electric service without an employee being physically dispatched to your meter location. This allows for more flexibility in the time management of co-op employees, which in turn benefits our members. Be aware that a meter site may be disconnected or reconnected, and power may be restored at any time without an employee or member at the meter site.

RESPECT SUBSTATIONS

REPORT SUSPICIOUS ACTIVITY

Only authorized utility workers should approach a substation, touch the fence or enter the gate.

Paying attention to activity in or near substations and other utility equipment helps keep everyone safe.

Authorized workers should:

- Wear proper personal protective gear and display an ID badge.
- Use work vehicles that have utility branded logos/information.

Suspicious activity includes individuals in street clothes who are:

- Near or inside a substation fence.
- Tampering with equipment, such as power poles, meters and padmount transformers.

If you notice anything unusual at a substation, please report it to the electric utility. Examples include:

- An open or unlocked gate.
- A damaged fence.
- Obvious damage inside the fence.

Call 9-1-1 and then the electric utility if you see:

- Smoke or fire.
- Non-utility workers inside the substation fence.
- Non-utility workers on a pole or tampering with a meter.

Start Safety Education Early

DO'S & DON'TS AROUND ELECTRICITY



Start discussions about electrical equipment and safety when children are young!

Here are some great safety lessons to teach:

DO



- Stay inside after a storm in case there are downed power lines.
- Place a cell phone on a bedside table, not on bedding or under a pillow.
- Find another tree to climb if an overhead power line is nearby.
- Fly kites, drones or other RC toys in an open area away from overhead power lines.

DO NOT



- Do not go near a downed power line.
- Do not use or set plugged-in items near water, including a sink, pool or bathtub.
- Do not go near or enter a substation to retrieve a toy or pet. **Dannie Diener**
- Do not try to free an object that is stuck in a power line.
