His early days at the co-op saw him learning the ropes as an apprentice meter serviceman. Later, Chad would become an apprentice lineman and work his way up to the line crew foreman.

CEO is now accepting applicants for the fall 2024 class. Students who will be entering their senior year may apply.

The CEO programs take high school seniors out of their schools and meet in business settings throughout the year. Around 40 business, agricultural, and professional leaders make presentations to the groups and the classes visit a similar number of businesses throughout the year.

In the first half of the school year, the students develop a class business, which helps fund their individual businesses in the second half of the year. Students in the program are also paired with a mentor from their business community.


