

## Wholesale power cost pressures increase

Over the past few years, we have experienced the cost of materials and supplies increasing at double-digit rates, and with that sustained pressure now subsiding to a cost level which we consider our new normal, we are relieved. However, it seems just

as one tide ebbs, another flows. Looking ahead to 2025, our wholesale power supplier is forecasting a 6-8% cost increase over 2024 actuals, based on year-to-date data.

Multiple factors of power supply changes go into this increase, but it is primarily being driven by transmission service providers — those entities which deliver power to the substations serving our members. Over the last seven years that cost has increased incrementally at a 1-2% rate each year, but jumped 3% in 2024 and is forecast to jump another 3.5% to encompass 25% of our power supplier's total operating expense in 2025.

For the past several years, wholesale power costs have represented 60-62% of our total annual costs to provide service to our members. Due to publication deadlines for this magazine, the exact

increase for 2025 is still being determined. Your board of directors is considering several options for tackling the increased pressure of wholesale power costs. I will have more information for you in the following months.

In the meantime, let me reassure you that as always, all decisions are made with you, our members, as our top priority. As an electric co-op, we do not seek to earn profits for investors; we were built by the communities we serve, and our mission remains to provide safe and reliable service at a reasonable cost.

### 3 Ways to Increase Winter Energy Efficiency

- \* Keep cold air out with caulk and weatherstripping.
- \* Check attic insulation for damage and settling; add more if needed.
- \* Service your furnace/heating system and replace filters as needed.

### 2 Winter Safety Tips

- \* Never touch a fallen line. Assume all downed wires are live, and beware of lines covered by snow.
- \* Never use a generator or gas/charcoal grill indoors or in a partially enclosed area due to carbon monoxide.






